The Joint Committee conducted its hearing on September 3, 2025. The company was requested to send its representative on the scheduled hearing, and also invited were representatives from the Public Employment and Service Office (PESO), Bacoor

As stated, the objective of the MOA is to establish a strategic partnership between the City Government of Bacoor and MOVE IT Philippines, to promote inclusive economic development, and enhance urban mobility through the deployment of motorcycle taxi services.

It appears that the Public Employment and Service Office (PESO), Bacoor City, is the principal endorser of the MOA which is primarily focused on the employment and/or hiring of Bacooños, and secondarily, the business operation of the company within the jurisdiction of Bacoor City.

In the letter dated August 6, 2025 of the Office of the City Mayor, Bacoor City addressed to Hon. Catherine Sarino, then Acting Vice Mayor/Presiding Officer of Sangguniang Panlungsod, Bacoor City, an approved Resolution is being sought authorizing the City Mayor, Hon. Strike B. Revilla to enter into and sign the Memorandum of Agreement with WE-LOAD TRANSCARGO CORPORATION (MOVE IT Philippines).

Traffic Management Department (BTMD), Livelihood Office and Office of the City Legal Services, as resource persons. During the hearing, the resource persons were requested to comment on the subject matter:

MOVE IT Philippines

- Continues coordination with PESO in providing livelihood and employment opportunity to Bacoreños.

Bacoor Traffic Management Department

- The MOVE IT motorcycle taxis are partially operating within the jurisdiction of Bacoor City.
- The operation of MOVE IT motorcycle taxis has no terminal and does not cause any traffic obstructions or violations.

Public Employment and Service Office

- The partnership with MOVE IT started since the pandemic period.
- Generated 300 jobs during the pandemic period.
- The present program of MOVE IT aims to upgrade the capability of tricycle drivers with the use of its application.
- Verified and coordinated with the BMTD relative to road use of additional transportation (tricycle).

Livelihood Office

- It will increase employment, as the source of livelihood.
- Upgrading of transportation technology through the MOVE IT application.

Office of the City Legal Services

- The MOA was already reviewed and approved by the head of the department.
- The MOA was endorsed by the PESO
- No further comment or objection on the approval of the resolution authorizing the City Mayor enter into and sign the MOA with MOVE IT Philippines.
- If ever there will be future problems in the operation of MOVE IT within Bacoor City, the city government could immediately tap the management of MOVE IT for the early resolution of such future problem.

Hon. Rogelio M. Nolasco: "So, We-Load Transcarg Corporation (Move It Philippines) pwede pong mailahad nyo regarding po sa inyong magiging memorandum of agreement?"

Ms. Pearl Simbulan: "Simple lang po yung si Move It basically, si Move It pupunta po kami dito upang manghikayat, makipag coordinate po sa PESO ninyo para makapagbigay ng Livelihood sa citizens po ninyo. Nagpunta po kami rito at kung sino po yung willing na makipag partner sa Move It ay pupunta po sa PESO at ireregister po sa amin ng PESO para mabigyan po ng opportunities ang mga riders na naandito po sa area na ito, malaking tulong din po talaga ang PESO natin at yung coordination na galing sa kanila para po yung mga walang trabaho sa lugar ay mabigyan po ng pagkakataong masubukan po."





Hon. Rogelio M. Nolasco: "Actually, malaking bagay nga yan, ano ang masasabi ng ating PESO?"

Dr. Abraham De Castro: "Salamat po your honor, Magandang hapon po, with regards po dito ang Public Employment office po would like to inform this breaching, prior with our partnership with Move It, we have partner with Mr. Anton Nacion during pandemic pa po, we have partners with Panda. Na Nakapagbigay na po tayo ng 300 jobs noong panahon ng pandemia at na award dan po tayo ng Department of Labor of Employment because of that. Ngayon po ang Move It naman po, ang kagandahan po sa Move It mayroon po silang programa para tulungan po yung ating mga tricycle drivers and Motor cycle owners na mag upgrade. Kunwari po hindi po professional yung kanilang license, tutulungan po sila ng Move It para i upgrade, kung kailangang i upgrade yung kanilang motorsiklo mayroon po silang loans available, free services po with trainings as well, ngayon ang kagandahan po dito hindi po ako nagpadalos dalos, to have this agreement, ako po ay nakipag coordinate sa BTMD to ensure po yung atin pong mga road rules at wala naman pong problema if ever na mag dagdag po tayo ng ganitong mode of transportation Sir. Salamat po Sir."

Hon. Rogelio M. Nolasco: "Thank you. We acknowledge din po ang presence ng ating Livelihood Department. Sa atin pong Livelihood Department, ano po ang masasabi nyo dito sa memorandum of agreement between We Load?"

Ms. Carmelita Gawaran: "Siguro it's a good opportunity na magkaroon tayo ng ganitong klasng MOA with the Mayor and Transcargo Corporation. Kasi at the same time magkakaroon po tayo ng increase ng employment syempre kinakailangan natin rito, and para magkaroon na rin ang ating kababayan sa panibagong technology ng transportation."

Hon. Rogelio M. Nolasco: "So, how about sa ating BTMD ano ang opinion nyo regarding dito?"

Mr. Rommel Bunag: "Sa ngayon po, ang observation namin, actually nag ooperate na po ang Move It not only here in Cavite even outside Cavite nag ooperate na. May nakikita na po kami na talagang tumatakbo dito sa atin. At sa tingin ko po para magkaroon ng kumpitensya sa market na hindi lang isa o dalawa ang nakakapag bigay serbisyo dito sa atin."

Hon. Rogelio M. Nolasco: "Thank you. Ito po bang Move It mayroong opisina dito sa Bacoor?"

Mr. Wayne Bradfield Jacinto: "Sa ngayon po wala pa po kaming opisina, but we intend to have once na maayos na pong lahat."





Hon. Rogelio M. Nolasco: "Sana nga po. Sa Legal natin ano po ang masasabi nyo na revise nyo na yung MOA?"

Atty. Salve Salvacion: "Yes po pati po yung mga restriction, as far as the MOA is concern, ito naman po ay bago nakarating sa Sangguniang Panlungsod ay ito naman po ay naaprobahan na ng aming City Legal Office. So, base on the endorsement from the PESO and ni review of at ni revise na po ng City Legal Office. Hon. Rogelio M. Nolasco: "Thank you. Any opinion ang suggestion from the council?"

Hon. Manolo Galvez: "Mr. Chair, magbigay lang ako ng suggestion, baka naman po pwedeng matulungan ng Move It yung ating mga tricycle natin sa Move It problema lang baka bawal sila sa national road? pero sa mga subdivision pwede ba sila huwag lang sa national road? Hon. Reynaldo Palabrica: "Mr. Chair, ngayon ko lang kasi nariniig yung Move It pasensya na kayo ha, kasi ngayon ko lang narinig yan. Mr. Jacinto, can you please enlighten the whole committee the full operation of Move It Company. Kasi naka lagay dito Transcargo ano ba ito cargo transport o pang pasahero ba ito? Can you please enlighten us?"





Mr. Wayne Bradfield Jacinto: "Sige po Mr. Chair, ang Move It po ay tinatawag nating motorcycle taxi kung saan nagsasakay poi to ng pasahero from point A to point B sa Bacoor, para pong Angkas or Joy Ride po. So, si Move It po ay recent lang po mga 3 years ago mga 300 units yung sinasabi po ni Konsihal about doon sa mga tricycle, alam nyo po may iba pang paraan pa yan at pwede nating tignan at pag aralan draft naman po kasi, may mga grab trike apps naman pero sinisimulan pa sa Zamboanga, at sa Pampanga."

Hon. Reynaldo Palabrica: "So ang business nyo ay passenger? so, hindi cargo or transport?"

Mr. Wayne Bradfield Jacinto: "Yes po, hindi po cargo."

Hon. Horacio Brillantes: "Mr. Chair, Same din yan ng Angkas, Tama?"

Mr. Wayne Bradfield Jacinto: "Opo."

Hon. Horacio Brillantes: "So, pag sinabing Angkas hindi pwede Tricycle? Application din po siya? Pero nag eexist na po ito? Ngayon I ta tie up natin sa City Government para makatulong tayo dito sa mga residente ng Bacoor. Extra Job tama po ba?"

Mr. Wayne Bradfield Jacinto: "Opo."

Hon. Horacio Brillantes: "Paano po yung mangyayari kunwari priority natin ang residente ng Bacoor?"

Mr. Wayne Bradfield Jacinto: "Opo."

Hon. Horacio Brillantes: "Yun lang kasi ang doon sa ano ang exclusivity na kailangan dito ay Motor hindi pwede ang tricycle at saka sidecar para malinaw sa lahat. Pero kung bibigyan ng chance ang ganoon pwede po ba? Mga 3 wheels ina acknowledge ko lang po yung sinabi ni Konsi Noly Galvez baka may chance?"

Mr. Wayne Bradfield Jacinto: "May programa po ang grab trike pero nag eexist siya sa from grab at nag ba viral po kami sa Pampanga. Dito po yung tricycle driver's naman na gusto ng humabol sa technology binibigyan din namin ng pagkakataon na gumamit sila ng apps days at publication para makakuha ng pasahero at maiwasan din po natin yung mga downtime na tinatawag."

Hon. Horacio Brillantes: "Kung may ganon kasi sa atin dito, parang limited lang yung sasakyan na pupuwede within that area lang baka naman maapektuhan yung mga Toda at saka gardenia?"





Mr. Wayne Bradfield Jacinto: "Ano po hindi naman po ginagamitan din kasi ng geofencing na kung saan lang sila pwede doon lang din po sila."

Hon. Horacio Brillantes: "Within the applicable area doon lang applicable yung kanilang apps?"

Mr. Wayne Bradfield Jacinto: "Opo."

Hon. Horacio Brillantes: "Kunwari nasasakop lang sa isang subdivision instead na mag hintay si trike pwede nilang gamitin yang application na yan para point to point ang gagawin ng trike tama ba? Para malinaw lang."

Mr. Wayne Bradfield Jacinto: "Opo."

Hon. Reynaldo Palabrica: "Do you have any application or partnership with any existing Transport tulad ng grab or similar than that or independent yan?"

Hon. Reynaldo Palabrica: "Mayroon pa kayong partnership doon sa mga service provider katulad ng Grab, Joy ride mayroon kayong partnership sa mga similar companies na nag po provide ng ganoong services?"

Mr. Wayne Bradfield Jacinto: "Independent lang po kami."

Hon. Reynaldo Palabrica: "So papaanong makaka avail sa inyo? halimba kasi this is a job opportunity for our fellow Bacoorenos, papaano makaka avail sa inyo ng Anong tawag doon? Magiging member ninyo? Or magiging employee ninyo? Papaano yun?"

Mr. Wayne Bradfield Jacinto: "Yun pong apps na I po provide namin kapag may mga applicante po pwede naman pong mag file daretso through PESO/Move It."

Hon. Reynaldo Palabrica: "Membership ang tawg dyan?"

Mr. Wayne Bradfield Jacinto: "Membership po, hindi po sila empleyado but riders sila bali kung tawagin independent contractors or worker sila."

Hon. Reynaldo Palabrica: "Contractor ninyo?"

Mr. Wayne Bradfield Jacinto: "we have freedom po halimbawa po once na meron silang apps gusto nilang bumiyahe ngayon pangkain lang pwede pwede ring hindi. Kung gusto nilang kumita ng more than what they get ay





mag ta trabaho sila ng mas matagal. Kung kuntento na sila sa pambili lang ng ulam o gatas."

Hon. Reynaldo Palabrica: "Wala silang required na number of trips? Or service?"

Mr. Wayne Bradfield Jacinto: "Wala po."

Hon. Reynaldo Palabrica: "Magkano ang membership?"

Mr. Wayne Bradfield Jacinto: "Wala pong bayad."

Hon. Reynaldo Palabrica: "Walang bayad and yet you will provide all the necessary as stated in MOA? Yung mga accessories, training and free of charge?"

Mr. Wayne Bradfield Jacinto: "Opo."

Hon. Reynaldo Palabrica: "Kung nonpro ang drivers license tapos gustong mag avail sa inyo, nababanggit sa MOA ay i assist ninyo rin para maging professional ang drivers license?"

Mr. Wayne Bradfield Jacinto: "Opo mayroon po kaming programa na nonpro to pro ito po ay sinimulan na naming para matulungan yung mga habal habal na rider sa Metro Manila. So, marami pong habal habal doon ang problema nila professional Drivers License."

Hon. Reynaldo Palabrica: "Papano yun kasi itong pagiging public transport nato na trike papano yung franchise noon?"

Mr. Wayne Bradfield Jacinto: "Wala pong franchise sa ngayon kasi under po tayo ng Technical Working Group, prior studies siya pero nasa Congress po kasi yung pagsasa batas nito pero hindi pa po naisasabatas ito pinayagan po ang Technical working group ipatuloy na po natin ang pag ooperate ng booking or apps na ito."

Hon. Reynaldo Palabrica: "Kung sino ang may apps na similar ng function ninyo pwedeng mag operate?"

Mr. Wayne Bradfield Jacinto: "Doon lang po sa tatlong pinayagan nila."

Hon. Reynaldo Palabrica: "Ah so tatlo lang yan?" Halimbawa meron ditong businessman na makipag partner sa inyo na to access yung franchise, ibig sabihin maki ride doon sa authorization sa inyo papayag kayo?"





Mr. Wayne Bradfield Jacinto: "Sa ngayon po hindi pa inaallow."

Hon. Reynaldo Palabrica: "So, dapat Move It lang talaga?"

Mr. Wayne Bradfield Jacinto: "Yes po."

Hon. Miguel Bautista: "Mr. Chair, tanong ko lang sa ating resource person bukod sa Bacoor na nakipag MOA kayo saan pa kayo nakipag MOA? Cities of Province?"

Mr. Wayne Bradfield Jacinto: "Sa Outside of Luzon, Cities Cagayan De Oro po at Cebu. Dati nakipag partnership din kami with Metro Manila yun pa lang po."

Hon. Miguel Bautista: "Okey thank you."

Hon. Manolo Galvez: "Yun pong mga member ninyo, actually nangyari ito eh Crime. May nangyaring mga crimen so, mayroon naman kayong mga data base if it ever na na trace na Move It yug sangkot doon sa crimen, mayroon naman kayong access?"

Mr. Wayne Bradfield Jacinto: "Meron po at within this apps malalaman po natin kung saan pumupunta yung mga riders."

Hon. Manolo Galvez: "Meron tayo? So, yun lang po Mr. Chair."

Hon. Rogelio M. Nolasco: "Any othe opinion? Sa ating PESO at Livelihood meron pa ba kayong mga tanong?"

Dr. Abraham De Castro: "Your honor, ang hinabol lang po namin dito ay yung talagang benepisyo ng ating mga tao number 1 po ay to provide more options po sa mga mananakay. Salamat po."

Hon. Reynaldo Palabrica: "Kapag nag member sa inyo, magkano ang percentage sa inyo at sa fee na ibinabayad ng mga pasahero?"

Ms. Pearl Simbulan: "Depende po, mayroon po kasi tayong tinatawag na service fee sa pag gamit po nila ng application."

Hon. Reynaldo Palabrica: "How many percent? Percentage ba per trip?"





Ms. Pearl Simbulan: "Dynamic po kasi siya, may range halimbawa po 7%, 3%, 17%."

Hon. Reynaldo Palabrica: "17% of the fee?"

Ms. Pearl Simbulan: "Tinatawag nating service fee or platform fee na kung baga yung member."

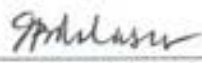

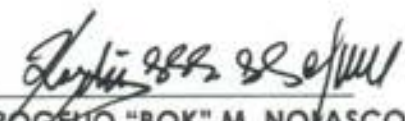

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement (MOA) is made and entered into by and between:

THE CITY GOVERNMENT OF BACOR, through the **Public Employment Service Office (PESO – Bacoar)**, with principal office at Bacoar Government Center, Bacoar, Cavite, represented herein by its Honorable City Mayor, **STRIKE B. REVILLA**, hereinafter referred to as **"BACOR CITY GOVERNMENT"**.

and

WE-LOAD TRANSCARGO CORPORATION (MOVE IT Philippines), duly organized, created, and existing under Philippine Laws, with Securities and Exchange Commission Registration Number CS201504989, with principal address at 23 Cabrera Road, Brgy. Dolores, Kaytikling, Taytay, Rizal, Philippines, represented herein by its General Manager, **WAYNE BRADFIELD JACINTO**, hereinafter referred to as **"MOVE IT"**;

WITNESSETH:

WHEREAS, **MOVE IT** is a Transport Network Company duly accredited by the LTFRB, aiming to empower Filipinos by providing sustainable livelihood opportunities through its motorcycle taxi platform;

WHEREAS, **BACOR CITY GOVERNMENT** is committed to providing employment and livelihood opportunities for its constituents through job referrals, placement, and career guidance services;

WHEREAS, both parties recognize the value of collaboration to provide accessible livelihood opportunities for residents of Bacoar, Cavite;

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

MOVE IT shall:

- Coordinate with PESO Bacoar for the scheduling and logistics of the grand onboarding event(s);
- Provide necessary materials, equipment, and manpower for the conduct of the event (e.g., application kits, digital onboarding tools, and orientation facilitators);
- Provide free gear such as, but not limited to, helmets, jerseys, and vests;
- Offer assistance for Non-Professional to Professional license conversion;
- Provide NBI clearance assistance through CIBI, specifically for applicants who do not have an NBI clearance on the day of onboarding;
- Supply promotional artworks to support communication and visibility of the partnership and mass onboarding event;
- Screen and process applicants who meet the qualifications (e.g., motorcycle ownership, professional license, and other valid requirements);
- Extend support and aftercare to newly onboarded riders, including orientation, platform access, and incentive programs;
- Submit a report to PESO Bacoar on the number of applicants and successful hires.

PESO Bacoar shall:

- Assist in promoting the mass onboarding event through its job referral network, barangay channels, and official social media platforms;
- Provide venue support for the conduct of events that can accommodate between 300 and 1,000 participants, with access to electricity and adequate lighting;
- Allocate an area within the venue for skills assessment, with a minimum size of 500 square meters;

- Endorse qualified jobseekers who meet Move It's basic rider qualifications;
- Coordinate with MOVE IT on event documentation and post-event reporting;
- Ensure compliance with all applicable local government guidelines and safety protocols during the activity.

TERMS OF AGREEMENT:

- This MOA does not constitute an employer-employee relationship between MOVE IT and PESO Bacoor.
- This MOA shall take effect upon signing by both parties and shall remain in force for a period of one (1) year, unless earlier terminated by either party with thirty (30) days written notice.
- Measures of Success: The parties agree to monitor the engagement levels and success of the sign-up campaign.
- Amendments: The parties may amend or modify this MOA upon mutual consent through an addendum signed by all parties.
- Confidentiality Clause: All information, records, and documents received by either Party by reason of this MOA are confidential and shall remain confidential even after the termination of the Agreement.

EFFECTIVITY: This Memorandum of Agreement shall take effect immediately upon signing thereof by the Parties and shall remain valid and binding unless pre-terminated by either party for violation of any of the terms and conditions of this MOA, upon serving a written notice of termination to the other party at least three (3) days prior to the intended date of termination.
