Subject: *A resolution authorizing the City Mayor, Hon. Strike B. Revilla, to sign a Memorandum of Agreement with the Provincial Government of Cavite (PGC), represented by Hon. Francisco Gabriel D. Remulla on behalf of the City Government of Bacoor for the grant of financial assistance to the City Government of Bacoor amounting to One Million Pesos (Php1,000,000/00).*

The above-mentioned proposed resolution underwent its first reading on August 11, 2025 during the 7th Regular Session of the 6th Sangguniang Panlungsod. The said proposed resolution was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

The Committee on Rules and Privileges, Laws and Ordinances conducted a Committee Meeting on August 26, 2025, 9 a.m. at the Session Hall of the Sangguniang Panlungsod. After due consultation and deliberation hereby reports the findings, information gathered and recommendation for the above-subject matter. Attached hereto are the attendance sheet and photos taken during the said meeting.

FINDINGS:

A letter dated August 04, 2025 from the Office of the City Mayor was received by the Sangguniang Panlungsod, requesting for a City Resolution authorizing the City Mayor, Hon. Strike B. Revilla to sign a Memorandum of





Agreement in behalf of the City Government of Bacoor with the Provincial Government of Cavite regarding the request for Financial Assistance amounting to One Million Pesos (Php1,000,000.00) for the City of Bacoor's 354th Founding Anniversary (Bakood Festival 2025).

Pursuant to the Local Government Code of 1991, every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as the powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.

To formally grant the request for financial assistance of the City Government of Bacoor, a Memorandum of Agreement (MOA) shall be entered into by and between the City Government of Bacoor and the Provincial Government of Cavite (PGC).

RECOMMENDATION:


After a thorough review of all the circumstances and statements from the committee members, and the provisions of the proposed resolution, the Committee respectfully recommends that the Sangguniang Panlungsod approve the above-subject matter on 2nd reading during its next regular session.
