Subject: REQUEST FOR APPROVAL OF RESOLUTION FROM BARANGAY MOLINO I: RESOLUTION NO. 10 SERIES OF 2025 ENTITLED: "A RESOLUTION FORMALLY RENAMING THE 'FORMER MOLINO I MULTIPURPOSE BUILDING' TO 'STRIKE MULTI-PURPOSE CENTER.'" (PCR 091-2025, dated 11 August 2025)

The above-mentioned proposed resolution was referred to the Committee on Tourism, Culture, Arts, and External Linkages, chaired by Hon. Ricardo F. Ugalde, and to the Committee on Barangay Affairs as sub-committee during the 6th Regular Session of the 6th Sangguniang Panlungsod held on 11 August 2025.

The facility formerly known as "Molino I Multi-Purpose Building" has long served as a venue for community functions, barangay assemblies, and public service programs.

There is a need to formally rename the building to better reflect its role as a central hub for government services and community activities. The proposed new name, "Strike Multi-Purpose Center," is considered more distinctive, avoiding confusion with the extension building while enhancing recognition among residents and visitors.

#### FINDINGS:

During the Joint Committee Hearing held on 13 August 2025, the Committees found:

- 1. Barangay Molino I, through its Barangay Council, approved in its regular session Resolution No. 10, Series of 2025, formally renaming the former "Molino I Multipurpose Building" to "Strike Multipurpose Center."
- 2. The proposed renaming aims to provide the facility with a distinct identity, preventing confusion between the main and extension multipurpose buildings.
- 3. The representative from the Office of the City Legal Services confirmed that there is no legal impediment to adopting the name "Strike Multipurpose Center". The term "Strike" is interpreted as a call to action and is not solely a reference to the City Mayor.



The joint committee hearing was called to order by Chairperson of the Committee on Tourism, Culture, Arts, and External Linkages Hon. Ricardo F. Ugalde, who acknowledged the presence of the members of both committees and fellow City Councilors.

Attendees were then requested to introduce themselves, stating their name, designation, office, or the Barangay they represent.

The Chair read the title of the proposed resolution and opened the floor for discussion.

Punong Barangay Dominguez explained that the request to rename the former "Molino I Multipurpose Building" to "Strike Multipurpose Center" was made following a directive from the City Mayor. The Barangay Council subsequently approved the resolution in their regular session.

Atty. Valenciano stated there was no legal impediment to naming the facility "Strike Multipurpose Center," noting that the term "Strike" serves as a call to action and is not solely a reference to Mayor Strike, who remains in public service.

Hon. Palabrica suggested considering the name "Strike As One Multipurpose Center" to emphasize unity, recommending that this justification be reflected in the resolution's "Whereas" clause.

Atty. Valenciano and Ms. Francisco (Bacoor City Culture, History, Arts, and Tourism Office [BCCHATO]) agreed that "Strike As One" would also be acceptable but reiterated there was no legal issue with the current proposed name, "Strike Multipurpose Center."

Punong Barangay Dominguez clarified that the primary reason for the name change was to distinguish the main multipurpose building from its extension.

Hon. Galvez and Hon. Nolasco agreed that the name change would improve identification and wayfinding.

Hon. Nolasco then inquired which name should be finalized - "Strike Multipurpose Center" or "Strike As One Multipurpose Center."

The Chair clarified that since Barangay Molino I's resolution explicitly used "Strike Multipurpose Center," the committee would respect and endorse this version without adding "As One."

Upon motion by Hon. Palabrica duly seconded, and the Council unanimously agreed to recommend favorable endorsement of Barangay Molino I's Resolution No. 10, Series of 2025 to the Sangguniang Panlungsod for consideration in the next regular session.

With no further matters to discuss, the hearing was ADJOURNED.


