Subject: ***A RESOLUTION APPOINTING MS. JOY BARCOMA, MS. EARTH PHILIPPINES 2025, AS THE GOODWILL AMBASSADOR OF THE CITY OF BACOOR, CAVITE, FOR ENVIRONMENTAL AWARENESS AND YOUTH DEVELOPMENT. (PCR 100-2025, dated 18 August 2025)***

The above-captioned legislative measure was submitted on First Reading before the City Council on 18 August 2025. The City Council unanimously voted to suspend the internal rules to immediately deliberate and act upon the proposed resolution.

The measure seeks to appoint Ms. Joy Mayanne Felix Barcoma, Ms. Earth Philippines 2025, as the Goodwill Ambassador of the City of Bacoor, with a primary focus on environmental awareness and youth development initiatives. Her appointment is expected to inspire the younger generation and strengthen the City's advocacy for sustainable development.

FINDINGS:

1. The appointment of Ms. Barcoma as Goodwill Ambassador will significantly promote the City Government's environmental programs and youth-oriented initiatives.
2. Ms. Barcoma, being Ms. Earth Philippines 2025, embodies the values of ecological stewardship and social responsibility, aligning with the City's objectives for sustainable development.
3. There are no legal or procedural impediments to her appointment, as the measure was duly endorsed and approved by the Sangguniang Panlungsod through suspension of its internal rules.

RECOMMENDATION:

In view of the foregoing, the Committee on Tourism, Culture, Arts, and External Linkages respectfully recommends the **APPROVAL** of Proposed City Resolution No. 100-2025, entitled:
