The Committee held a committee hearing on September 04, 2025, 1:50 pm. at the Sangguniang Panlungsod, 6th Floor Bacoor Legislative & Disaster Resilience Building, Bacoor Government Center, Bacoor City, Cavite. It was presided over by Chairperson of Committee on Public Works and Highways Hon. Levy M. Tela.

FINDINGS:

The resolution seeks to formally request the assistance of Congresswoman Lani M. Revilla for the upgrading/cementing of the road and installation of drainage systems along Fabian St. and Celestino St., New Niog Village, Purok 2, Niog, Bacoor City. The total estimated length of the project area is approximately 350 meters.

Unpaved and deteriorating roads, damaged canals, and inadequate drainage systems often lead to flooding in the area, posing serious inconvenience and danger to residents.

To ensure the timely implementation of this project, Barangay Niog is seeking the support and assistance of Honorable Congresswoman Lani Mercado-Revilla for funding and technical assistance.

RECOMMENDATION:

In view of the foregoing, the Committee acknowledges the validity and importance of the infrastructure need raised by constituents. The Committee respectfully recommends **ENDORISING** the request of Barangay Niog to the Office of Congresswoman Lani M. Revilla for appropriate action.
