The proposed Supplemental Investment Program (SIP) for Supplemental Budget No. 1 of Barangay **MOLINO 7** has been examined and reviewed by the City Budget Department and the same is consistent with the provisions of Republic Act No. 7160 and existing budget circulars/issuances.




