The proposed SK Supplemental Barangay Youth Investment Program (SBYIP) for SK Supplemental Budget No. 1 of Barangay **SALINAS 1** has been endorsed, examined and reviewed by the City Budget Department, and the same is consistent with the provisions of Republic Act No. 7160 and existing budget circulars/issuances.


RECOMMENDATION:


