Subject: A resolution authorizing the City Mayor, Hon. Strike B. Revilla, to a Memorandum of Agreement on behalf of the City Government of Bacoor, with the Department of Migrant Workers regarding the establishment of its office within the City of Bacoor.

(Date referred: September 29, 2025)

The above-mentioned proposed resolution underwent its first reading on September 29, 2025 during the 13th Regular Session of the 6th Sangguniang Panlungsod. The said proposed resolution was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

#### FINDINGS:

A letter from the Office of the City Mayor dated September 19, 2025 was received by the Sangguniang Panlungsod regarding the endorsement of letterrequest from the Regional IV-A Office of the Department of Migrant Workers for a Memorandum of Agreement in securing an office facility within the City of Bacoor.

The Department of Migrant Workers, created by Republic Act No. 11641, is the primary government agency tasked to facilitate the overseas employment and reintegration of Filipino workers, as well as the promotion of the empowerment and protection of overseas Filipino workers (OFWs) and their families through legal assistance and provision of continuous training and knowledge development, among others.
