Subject: **"AN ORDINANCE ADOPTING CITY ORDINANCE NO. 2014-007 PROHIBITING EXCESSIVE UNNECESSARY AND UNUSUALLY LOUD SOUNDS GENERATED BY THE VIDEOKE/KARAOKE SYSTEM OR OTHR SIMILAR EQUIPMENT OR DEVICES WITHIN RESIDENTIAL AREAS AND ALONG PUBLIC STREETS IN BACOOR TO STRICTLY IMPLEMENT THE SAID ORDINANCE IN BARANGAY SALINAS 2".**

(PCR-177-2025 dated September 29, 2025)

City Ordinance No. 2014-007 was enacted to maintain peace and order by regulating noise pollution caused by videoke, karaoke, and similar sound-generating devices, particularly during late hours in residential areas and along public streets. The ordinance aims to preserve the welfare, comfort, and well-being of the residents by curbing unnecessary and excessively loud sounds that disrupt rest and public tranquility.

Barangay Salinas II has submitted a resolution to the Sangguniang Panlungsod requesting the strict implementation of the said ordinance within its jurisdiction due to numerous complaints and disturbances caused by loud videoke and karaoke use, especially during nighttime and public gatherings.

FINDINGS:

The key points in implementing this resolution were:

1. Section 16 of the Local Government Code of 1991, states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.
2. The making and creation of excessive, unnecessary or unusually loud sounds from videoke/karaoke system, or other sound producing devices at unacceptable levels during unholy hours cause serious

3. discomfort and has created numerous complaints and public condemnation.
4. The Sangguniang barangay received multiple complaint specially during school season and some resident is work from home (WFH) and they focus because of disturb or annoys due to excessive loud sound.
5. Under section 2, all persons regardless of age or gender and any commercial establishment that produces any excessive, unnecessary, or unusually loud sounds whether or not generated by videoke/karaoke systems.

The Committee on Barangay Affairs firmly supports the passage of the ordinance, as it embodies the principles of good governance, community welfare, and responsible citizenship. Its implementation will significantly enhance the quality of life in Barangay Salinas 2 by reducing noise disturbances and promoting harmony among residents.

RECOMMENDATION:

After thorough review and deliberation, the members of Barangay Affairs hereby recommend the **APPROVAL** regarding the Barangay Ordinance prohibiting excessive loud sounds from videoke/karaoke and similar devices in Barangay Salinas 2.

WHEREAS, under Section 2. All persons regardless of age or gender and any commercial establishment that produces any excessive, unnecessary, or unusually loud sounds whether or not generated by videoke/karaoke systems

WHEREAS, Section 6. Operation and use of videoke/Karaoke system and other sound producing devices in PUBLIC STREETS OR ROAD sides shall be allowed only upon securing of a permit from the Barangay that has jurisdiction over the area and only until 10:00pm, Monday to Sunday.

WHEREAS, all applicants for a permit to operate or use videoke / karaoke system and other sound producing devices in public streets or road sides shall complete and fill up application form and describe the nature of activity submit or in the Barangay at least three (3) to five (5) working days prior to the date of the intended activity and some guidelines in issuance of Barangay permit.

WHEREAS, Under Section 10. ENFORCEMENT AND ABATEMENT The duty of the Barangay and the Bacoor City Police is to enforce the provisions of this ordinance.

Any person who violates the provisions of this ordinance shall receive a verbal order to cease or abate the loud sounds generated from videoke/karaoke system or other amplified audio device immediately or within a reasonable time period. Provided however, that if the violation is deemed to be excessive, the Barangay authorities need not issue a verbal reprimand to cease or abate the loud sound, but may in lieu thereof charge the offending person(s) with violation of this ordinance.

WHEREAS, Section 11. Penal Provision. Any person who violates this ordinance shall be meted a fine of One Thousand Pesos (1,000.00) or imprisonment of not more than six (6) months or both such fine and imprisonment at the discretion of the proper court.

NOW THEREFORE on motion of Hon. Medelino V. Basa duly seconded by Hon. Armando P. Kho the ordinance unanimously approved
