The joint committee hearing was held on October 21, 2025, at 9:46 AM at the Session Hall, 6th floor, Bacoor Legislative & Disaster Resilience Building, Bacoor Government Center, Bacoor Boulevard, Brgy. Salinas 2, City of Bacoor, Cavite. It was presided over by Chairman Hon. Randy C. Francisco, Committee on Barangay Affairs.

FINDINGS:

1. R.A 7160, otherwise known as the Local Government Code of the Philippines, section 129 provides the power to the Local Government Units to create their own sources of revenue and to levy taxes, fees.
2. Revenues from fees shall uplift the financial capability of the barangay to enhance public service operations.
3. Fees from the Barangay Clearance shall be used to defray expenses on supplies, materials, and operations to ensure ease in doing business within the territorial jurisdiction.

- The Barangay Affairs Committee suggested that this matter be discussed during the Liga ng mga Barangay meeting to address the proposed changes to the business clearance fee of Barangay Salinas 2, as all barangays should have uniform rates for business clearance fees.

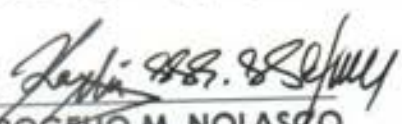

Discussion:

- Salinas 2 explained that the reason for the slight increase in fees was to accommodate small businesses that do not have the means to obtain a permit.
- Mr. Lawrence San Jose, OIC of the Business Permit and Licensing Department, stated that if Salinas 2 identifies sari-sari stores with a capital below ₱50,000, they should recommend them to the BPLD. Salinas 2 will issue a barangay endorsement; after that, the Building Permit Office will conduct an inspection.
- Business regulation through the clearance system also helps promote safety, order, and compliance within the community.

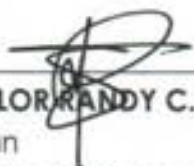

"AN ORDINANCE IMPOSING FEE FOR THE ISSUANCE OF BARANGAY CLEARANCE ON BUSINESS"

WHEREAS, R.A 7160 otherwise known as Local Government Code of the Philippine section 129 provides the power to the Local Government Units to create its own sources of revenue and to levy taxes, fees and charges;

WHEREAS, Revenues from fees and charges shall uplift the financial capability of the Barangay to enhance public service operations;

WHEREAS, Fees from the Barangay Clearance shall be used to defray expenses on supplies, materials and operations to ensure ease in doing business within the territorial jurisdiction;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BARANGAY in a regular session assembled upon the motion of Honorable Kagawad Armando P. Kho and unanimously approved by all the council members present that:

Section 1. TITLE: "BARANGAY CLEARANCE FEE ON BUSINESS"

Section 2. Declaration of Policy: It is hereby declare the policy of the Barangay to impose reasonable fees to promote ease in doing business within its territorial jurisdiction.

Section 3. Objective: To promote progressive business climate in the locality

Section 4. Schedule of Fees:

- a. One Thousand Pesos (P1,000.00) – for business with an annual gross sale of One Hundred Thousand Pesos (P1,000.00) / or initial capital for new business of Fifty Thousand Pesos (P50,000.00) and below.

- b. Five hundred Pesos (P500.00) – for business with an annual gross income/ or initial capital of more than One Hundred Thousand Pesos (P1,000.00) for new business.

Section 5. Special Provision. The Sangguniang Barangay authorizes the Business Permit and Licensing Office (BPLO) and other business concerned agencies of the City of Bacoor, to issue Barangay Clearance in the Business One Stop Shop (BOSS) section of the Bacoor City Business Permit and Licensing Office. Fees collected by the City Treasurer shall be remitted to the official bank account of the Barangay.

Section 6. Separability Clause. If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue in full force and effect.

Section 7. Repealing Clause. All laws, decrees or rules inconsistent with the provisions of this acts are hereby repealed or modified accordingly.

Section 8. Effectivity Clause. This Ordinance shall take effect fifteen (15) days upon approval of the City Council after public hearing called upon for this cause and after its publication in newspaper of general publication.
