(date referred September 29, 2025).

On September 19, 2025, the Office of Sangguniang Barangay of Barangay Poblacion approved the Barangay Ordinance No. 07-2025 entitled: "AN ORDINANCE REGULATING THE USE OF VIDEOKE / KARAOKE IN BARANGAY POBLACION, CITY OF BACOR, CAVITE".

The said Barangay Ordinance was forwarded to the Office of Sangguniang Panlungsod requesting for a Resolution for the approval of the Barangay Ordinance No. 07-2025.

FINDINGS:

The resolution seeks to approve the Barangay Ordinance No. 07-2025 for Barangay Poblacion. The said Barangay Ordinance's purpose to promote peace and order by regulating the use of videoke and karaoke units and preventing excessive noise, particularly during nighttime hours, to preserve the welfare and tranquility of residents.

Approval of the said Barangay Poblacion Ordinance No. 07-2025 will be beneficial to Barangay Poblacion residence. This ordinance will strengthen the peace and order in the area of the said barangay.

With reference to the existing City Ordinance No. 2014 – 007 Series of 2014, entitled "AN ORDINANCE PROHIBITING EXCESSIVE UNNECESSARY AND UNUSUALLY LOUD SOUNDS GENERATED BY VIDEOKE / KARAKOKE SYSTEMS OR SIMILAR EQUIPMENT OR DEVICES WITHIN RESIDENCIAL AREAS AND ALONG PUBLIC STREETS IN BACOR CITY", the said Barangay Ordinance is in accordance with above mentioned City Ordinance.

Upon review and careful study of the City Ordinance No. 2014 – 007 Series of 2004 and the Barangay Poblacion Ordinance No. 07 – 2025 Series of 2025, the committee finds no conflict between the above-mentioned ordinances.

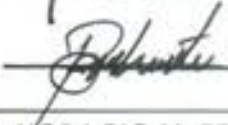

AN ORDINANCE REGULATING THE USE OF VIDEOKE/KARAOKE IN BARANGAY POBLACION, CITY OF BACOR, CAVITE

WHEREAS, excessive noise from videoke/karaoke establishments can disturb the peace and quiet of the community;

WHEREAS, it is the duty of the barangay to promote and protect the well-being of its residents;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BARANGAY OF POBLACION that:

SECTION 1.

1. PROHIBITED ACTS - No person shall operate or permit the operation of videoke/karaoke equipment in any establishment or residence within the barangay beyond 10:00 PM.

SECTION 2. PENALTIES - Any person who violates this ordinance shall be subject to a fine of

1st offense Verbal reprimand

2nd offense 300.00 pesos or 10 hrs. community service

3rd offense 800.00 pesos or 20 hrs. community service

SECTION 3. EXEMPTIONS - This ordinance shall not apply to special events or occasions authorized by the Punong Barangay or other competent authorities.

SECTION 4. EFFECTIVITY This ordinance shall take effect September 19, 2025 and shall be published in accordance with law.

2. Consideration of the City Ordinance No. 2014-007 Series of 2014 entitled: "AN ORDINANCE PROHIBITING EXCESSIVE UNNECESSARY AND UNUSUALLY LOUD SOUNDS GENERATED BY VIDEOKE/KARAOKE SYSTEMS OR OTHER SIMILAR EQUIPMENT OR DEVICES WITHIN RESIDENTIAL AREAS AND ALONG PUBLIC STREETS IN BACOR CITY"

Hon. Galvez invited Hon. Francisco to present and read the contents of Barangay Ordinance No. 07-2025, which seeks to regulate the use of videoke and karaoke units within the jurisdiction of Barangay Poblacion.

After reading the proposed ordinance, Hon. Francisco elaborated on its key provisions and objectives—primarily to maintain peace and order by limiting excessive noise disturbances caused by videoke or karaoke use, especially during nighttime hours.

The committee members carefully reviewed the proposed barangay ordinance and compared it with the existing City Ordinance of Bacoor addressing similar regulations. Upon review, the committee found no legal conflict or overlapping provisions between the proposed barangay ordinance and the city's existing ordinances.

Following the discussion, Hon. Francisco moved for the approval of a Resolution endorsing the Barangay Poblacion Ordinance No. 07-2025 for confirmation by the Sangguniang Panlungsod.

The motion was duly seconded by one of the committee members.

With no objections raised, the motion was approved unanimously.

There being no further business, Hon. Galvez adjourned the meeting at 2:30 pm.

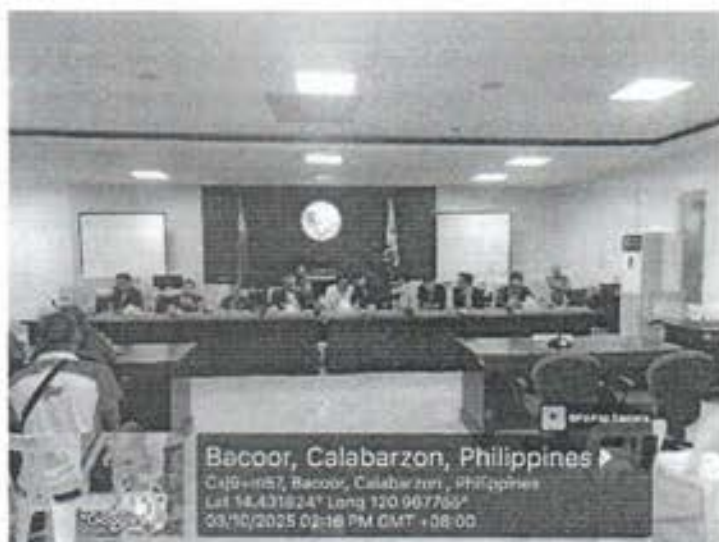
