On September 19, 2025, the Office of Sangguniang Barangay of Barangay Poblacion approved the Barangay Ordinance No. 08-2025 entitled: "AN ORDINANCE PROVIDING GUIDELINES FOR THE OPERATION OF BARANGAY TANOD IN BARANGAY POBLACION, CITY OF BACOR, CAVITE".

The said Barangay Ordinance was forwarded to the Office of Sangguniang Panlungsod requesting for a Resolution for the approval.

FINDINGS:

The resolution seeks to approve the Barangay Ordinance No. 08-2025 for Barangay Poblacion. The said Barangay Ordinance's objectives (i) to maintain peace and order within the barangay, (ii) to ensure public safety and security, and (iii) to provide assistance to residents in times of need. Hence, the Sangguniang Barangay formulated the duties and responsibilities and functions of their appointed barangay tanod unit. They further provide the operational guidelines of the said unit and the corresponding disciplinary action / sanctions for the unit member who failed to follow as a result of their neglect of duty.

Approval of the said Barangay Poblacion Ordinance No. 08-2025 will be beneficial to Barangay Poblacion residence. This ordinance will strengthen the peace and order in the area of the said barangay.

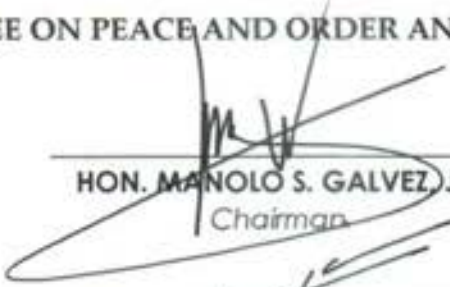

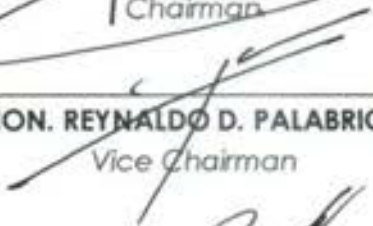

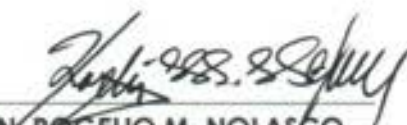

Ordinance No. 08- 2025

AN ORDER PROVIDING GUIDELINES FOR THE OPERATIONS OF BARANGAY TANOD IN BARANGAY POBLACION, CITY OF BACOR, CAVITE

By virtue of the powers vested in me as the Punong Barangay of Poblacion, I hereby issue this Executive Order to ensure the effective and efficient operation of the Barangay Tanod unit.

ARTICLE I: OBJECTIVES - To maintain peace and order within the barangay - To ensure public safety and security - To provide assistance to residents in times of need

ARTICLE II: FUNCTIONS AND RESPONSIBILITIES The Barangay Tanod unit shall perform the following functions:

1. Patrol and surveillance of the barangay
2. Respond to emergency calls and incidents
3. Assist in the enforcement of barangay ordinances and regulations
4. Provide support to other barangay units and agencies
5. Maintain records of incidents and activities

ARTICLE III: OPERATIONAL GUIDELINES

1. Deployment and Scheduling: Barangay Tanod personnel shall be deployed according to a schedule approved by the Punong Barangay.
2. Uniform and Equipment: Barangay Tanod personnel shall wear the prescribed uniform and use authorized equipment while on duty.
3. Reporting and Documentation: Barangay Tanod personnel shall submit reports and documents as required by the Punong Barangay or other authorities.

ARTICLE IV: DISCIPLINARY ACTION Disciplinary action shall be taken against Barangay Tanod personnel who fail to perform their duties or violate barangay rules and regulations.

ARTICLE V: EFFECTIVITY This Executive Order shall take effect immediately and shall be reviewed and updated as necessary.

The joint committee hearing proceeded as follow:

The hearing commenced with the introduction of the committee members and the invited resource person, Hon. Randy Francisco, Punong Barangay of Barangay Poblacion and Chairperson of Committee on Barangay Affairs

Hon. Galvez invited Hon. After reading the proposed ordinance, Hon. Francisco elaborated on its key provisions and objectives of the barangay ordinance. The committee members carefully reviewed the proposed barangay ordinance.

Upon review, the committee found no legal conflict or overlapping provisions between the proposed barangay ordinance and the city's existing ordinances.
