2025 SUPPLEMENTAL BARANGAY YOUTH INVESTMENT PROGRAM NO. 1

The proposed SK Supplemental Barangay Youth Investment Program (SBYIP) for SK Supplemental Budget No. 1 of Barangay **MAMBOG IV** has been endorsed, examined and reviewed by the City Budget Department, and the same is consistent with the provisions of Republic Act No. 7160 and existing budget circulars/issuances.

During the committee hearing, the resource person from the City Budget Department was invited to properly clarify and verify the following:

- The Sangguniang Kabataan of Barangay **MAMBOG IV** has an actual and available savings amounting to **TWO HUNDRED FIFTY THOUSAND PESOS (Php250,000.00)**.
- The subject of re-appropriation is within the same class expense and included in the 2025 Annual Barangay Youth Investment Plan (ABYIP) of Sangguniang Kabataan, as required under Republic Act 7160.
