1. The Avenida Wet and Dry Market which is owned and operated by a certain Riza Dona Villa was already been closed by the Business Permit and Licensing Department (BPLD) sometime in October 2023.

2. The prescription period for violation of City Ordinances committed by the Avenida Wet and Dry Market in 2023 in two (2) months only.
