Subject: A resolution authorizing the City Mayor, Hon. Strike B. Revilla, to sign the Deed of Donation on behalf of the City Government of Bacoor with the Barangay Santiago, City of General Trias, Cavite, pertaining to the donation of one (1) unit of Toyota Liteace.

The above-mentioned proposed resolution underwent its first reading on October 20, 2025 during the 16th Regular Session of the 6th Sangguniang Panlungsod. The said proposed resolution was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

FINDINGS:
