The above-mentioned proposed resolution underwent its first reading on October 20, 2025 during the 16th Regular Session of the 6th Sangguniang Panlungsod. The said proposed resolution was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

FINDINGS:

A letter from the Office of the City Mayor dated October 14, 2025 was received by the Sangguniang Panlungsod requesting for a City Resolution authorizing the City Mayor, Hon. Strike B. Revilla to sign a Deed of Donation and acceptance between the City Government of Bacoor and Barangay Santiago, General Trias, Cavite.

This Deed of Donation formalizes the donation of one (1) unit of Toyota Liteace by the City Government of Bacoor to Barangay Santiago, City of General Trias, Province of Cavite, for official use in the performance of public functions and delivery of basic services. The donation is intended to support barangay operations and enhance mobility and logistical capacity in the service of its constituents.

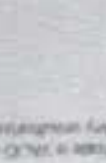

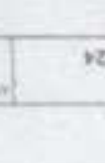
