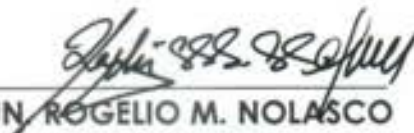

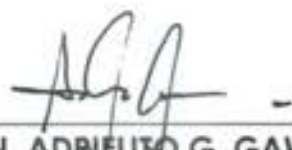

**AN ORDINANCE PROVIDING FOR THE GUIDELINES IN THE
ESTABLISHMENT OF BARANGAY COMMUNITY
GARDENS IN BARANGAY NIOG AND ALLOCATING FUNDS FOR ITS
OPERATION AND MAINTENANCE**

SECTION 1. TITLE - This Ordinance shall be known and cited as Barangay Community Garden Ordinance of Barangay Niog, City of Bacoor, Cavite

SECTION 2. DEFINITION OF TERMS. - For the purpose of this ordinance, the following terms and phrases shall apply:

Barangay Community Garden - The barangay community garden shall refer to a piece of land or several patches of land operated and cultivated by the barangay for the purpose of planting and growing vegetables and fruit-bearing trees.

Aeroponics - an integration of aquaculture (fish farming) with hydroponics. Creates symbiotic relationships between the plants and the fish. It uses the nutrient-rich waste from the fish tanks "fertigate" hydroponic production beds, and hydroponic bed cleans water for fish habitats.

Aquaponics - A bio-system that incorporates recirculated aquaculture (fish farming) with hydroponic vegetable and herbs production to create symbiotic relationships between the plants and the fish. The symbiosis is achieved using the nutrient-rich waste from fish tanks to "fertigate" hydroponic production beds.

Container Gardening - refers to a micro model farming where a family unit or household is producing fruit and vegetables in special containers for personal consumption.

Fruit-Bearing Tree-Planting - refers to the planting of fruit-bearing trees for food production purposes

Hydroponics - a method of growing food using mineral nutrient solutions in water without soil (soilless-based)

Organic Agriculture - it includes all agricultural systems that promote the ecologically sound, socially acceptable, economically viable and technically feasible production of food and fibers.

Square Foot Gardening - a simple method of creating a small, orderly, and highly productive Kitchen gardens.

Vertical Gardening - refers to a special kind of urban gardening suitable for small spaces, particularly for decorating the walls and roofs in various styles.

SECTION 3. SCOPE AND COVERAGE

This ordinance shall be enforced within Barangay Niog, City of Bacoor, Cavite

SECTION 4. ESTABLISHMENT & MAINTENANCE OF BARANGAY COMMUNITY GARDEN

4.1 The barangay community garden shall be established in available sites to be determined by the barangay through the designated focal person. The area of which is at least a minimum of two hundred square meters of land area of its equivalent in several patches of land;

4.2 Barangay community gardens may also be established in vacant lots owned by private individuals subject to any form legal arrangement;

4.3 The operation and maintenance cost of privately operated and maintained community gardens shall be borne by the private individuals;

4.4 Alternative gardening such as container gardening, vertical gardening, square foot gardening, hydroponics, aquaponics, and aeroponics shall also be encouraged;

4.5 All households, public and private establishments in the barangay are strongly encouraged to set up their vegetable garden and/or plant fruit-bearing trees in available open spaces;

4.6 The barangay shall establish a composting mechanism through collection of kitchen wastes of its residents and convert such into fertilizer which can be used in the community gardening;

4.7 Households and business establishments shall also be encouraged to establish their respective composting mechanism;

4.8 Partnership with volunteer groups in the promotion of community gardening, and in the maintenance and operation of barangay community gardens shall be encouraged;

4.9 Any income derived from the sale of produce from the barangay-owned community gardens shall be recorded properly and shall be utilized in its operation and maintenance. 4.10 Organic agricultural practices such as but not limited to the use of organic fertilizer and biopesticides are highly encouraged.

4.10 Designation of a Focal Person on Barangay Community Garden

The Chairperson on Environmental and Agriculture concerns shall automatically be designated as the focal person on the establishment and maintenance of barangay community garden, through an executive order. The Barangay Nutrition Scholar, and other barangay officials and staff shall also be designated in the same executive order, to assist in the operations and maintenance of the community garden.

SECTION 5. FUNCTIONS OF THE FOCAL PERSON

The Focal Person shall perform the following tasks:

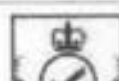
5.1 Lead and manage the establishment and maintenance of the barangay community garden;

5.2 Identify the area/s where the barangay community garden shall be established;

5.3 Coordinate with the City/Municipal Agricultural Offices for any available agricultural training, seminars, and capacity building, as well as seeding materials, and other agricultural equipment and facilities, that would help them in the operations of the barangay community garden;

5.4 Facilitate the following strategies: recording of the overall operations of the community garden such as the types of seedlings planted, number of seedlings, per plant planted, and the number of vegetables and fruits harvested, promotion of barangay community gardening and agri-business to the community, enactment of an ordinance regarding the setting-up and operations of barangay community gardens and allocation of funds to sustain its operations, and the establishment of volunteer groups to help in the establishment and maintenance as well as in the advocacy campaign

5.5 Cause the submission of necessary reports to the office of the C/MLGDO and CMAO

SECTION 6. INCENTIVES AND AWARDS

The barangay, through the Barangay Nutrition Committee (BNC) shall grant incentives through the conduct of annual contests, awards and financial or material support to families, establishments, and puraks engaged in community gardening during the Nutrition Month Celebration or other related celebration. The Committee shall be responsible in the formulation of guidelines as regards to these incentives and awards system.

SECTION 7. INFORMATION AND AWARENESS RAISING CAMPAIGN

The designated focal person shall cause the conduct of various information education campaigns to promote and raise awareness of all barangay residents about this ordinance.

SECTION 8. APPROPRIATION

The annual funding requirement necessary in the operation and maintenance of the barangay-operated community gardens shall be included in the barangay annual investment program, and in applicable nutritional programs, projects, and activities.

SECTION 9. MONITORING AND REPORTING

The periodic monitoring of accomplishment regarding the implementation of this ordinance shall be assumed by the designated focal person and the necessary reports shall be prepared and submitted to the DIG Field Office and the Local Agriculture Office.

SECTION 10. Repealing Clause. - All provisions of local ordinances, orders, and resolutions inconsistent herewith are hereby repealed and/or modified accordingly,

Section 11. Separability Clause - If any part of this Ordinance is declared not valid, unconstitutional or unlawful, such declaration shall not affect or impair the remaining provisions, sections or parts thereof, which shall remain or continue to be in full force and effect.

Section 12. Effectivity. - This Ordinance shall take effect after ten (10) days from the date of posting in the bulletin board at the entrance of the Barangay Hall.

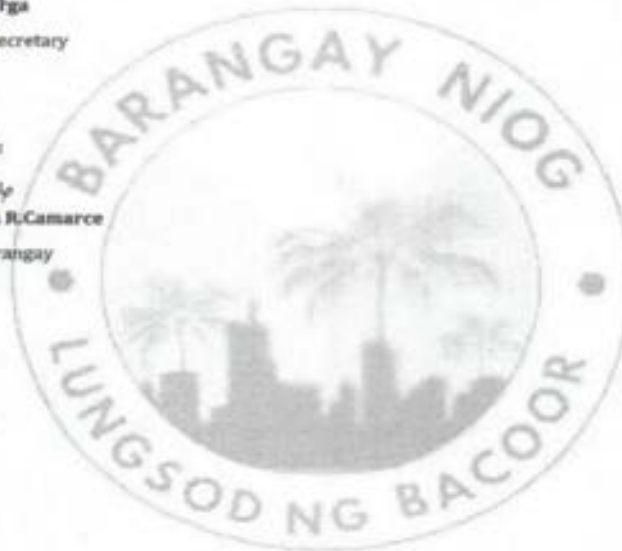
