

Subject: ORDINANCE NO. 08-2025, SERIES OF 2025, ENTITLED: "AN ORDINANCE ADOPTING CITY ORDINANCE NO. 7-S-2002 THE REVISED POLICIES OF THE LOCAL GOVERNMENT ON CURFEW FOR MINORS AND STRICTLY IMPLEMENT THE SAID ORDINANCE IN BARANGAY SALINAS 2. (PCR-214-2025 dated October 20, 2025)

The joint committee hearing was held on October 29, 2025, at 4:00 PM at the Session Hall, 6th floor, Bacoor Legislative & Disaster Resilience Building, Bacoor Government Center, Bacoor Boulevard. Bgry. Salinas 2, City of Bacoor, Cavite. It was presided over by Chairman Hon. Randy C. Francisco, Committee on Barangay Affairs.

#### FINDINGS:

- 1. Section 91 of city ordinance No. 171-2021 (the "child protection and Development Code of the city of Bacoor") provides that "the period from ten o'clock in the evening (10:00 pm) to four o'clock in the morning (4:00 am) is hereby declared as "curfew hours" for minors all over the city of Bacoor, minors apprehended for violating this provision shall be required to pay a fine.
- 2. Minors found violating this curfew will be returned to their parents or guardians. The city Government, including Local Government Unit (LGU) barangay officials, emphasizes that these measures are intended to protect youth.
- 3. The purpose of the Sangguniang Barangay is to maintaining public safety and safeguarding the well-being of its younger population and to avoid rampant criminality.





#### Discussion:

- The ordinance is expected to significantly reduce nighttime disturbances and promote a safer, more orderly community environment, particularly benefiting minors and their families.
- The implementation of a barangay-level curfew is necessary to enhance public safety and protect vulnerable minors from potential dangers at night, including exposure to crimes, accidents, and other unlawful activities.
- It aims to strengthen community discipline, promote peace and order, and prevent juvenile delinquency by restricting minors from loitering or staying in public places during curfew hours without a valid reason.

After deliberations, the Committee on Barangay Affairs unanimously agreed to recommend the Approval of the barangay ordinance adopting city ordinance No. 7-S-2002, the revised policies of the local government on curfew for minors, and to strictly implement the said ordinance in Barangay Salinas 2

There being no other matters to discuss, the meeting was adjourned at 4:15 PM.


