#### JOINT COMMITTEE HEARING REPORT

Subject: LETTER OF COMPLAINT OF MS. JUANISE RAINEL I. IGNACIO, AUDITOR OF SANGGUNIANG KABATAAN FEDERATION OF BACOOR CITY, CAVITE AGAINST MR. WILLER ALAMO, SK CHAIRPERSON OF BARANGAY BAYANAN, FOR ALLEGED DISHONESTY AND FOR ALLEGED VIOLATION OF THE RULES OF AN INTER-CLUSTER BASKETBALL TOURNAMENT. (PCR 236-2025 dated 27 October 2025).

This report pertains to the complaint of Ms. Juanise I. Ignacio, Auditor of Sangguniang Kabataan (SK) Federation of Bacoor City, against Mr. Willer S. Alamo, SK Chairperson of Barangay Bayanan, Bacoor City for the alleged dishonesty and violation of the rules of an inter-cluster basketball tournament.

The said complaint was referred to this Committee by the Presiding Officer, Hon. Rowena B. Mendiola, during the 17th Regular Session of the 6th Sangguniang Panlungsod on October 27, 2025.

Acting on the referral, the Committee conducted a committee hearing on October 30, 2025 at the Session Hall of the Sangguniang Panlungsod relative to the above-stated subject matter. The hearing was presided over by Hon. Miguel N. Bautista, Chairperson of the Committee on Ethics, Appointments and Government Reorganization.

Present were the Honorable Members of the Committee, representative from the Office of the City Legal Services, the complainant Ms. Juanise Rainel Ignacio, and the respondent, Mr. Willer Alamo along with other witness and concerned parties. Attached as an integral part of this report is the Attendance Sheet of the said hearing.

#### FINDINGS:

The following key facts were established:

- A verified complaint was filed by Ms. Juanise Rainel Ignacio, Auditor of SK Federation of Bacoor City against Mr. Willer Alamo, SK Chairperson of Barangay Bayanan, Bacoor City for alleged falsification and dishonesty;
- Both the complainant and respondent were administered the oath before giving their testimonies;

- Ms. Ignacio filed the said complaint to make sure that the tournament is clean and fair and that the persons who are responsible be accountable and liable in accordance with the rule of justice and fairness;
- According to the complainant, she is in-charge to check the team gallery and player documents, as well as to handle any submitted protests related to the tournament:
- Upon checking the documents submitted, Ms. Ignacio found out that there are
  players who submitted fake or tampered documents, e.g., Voter's Certificate
  and Identification Card. These actions were done under the responsibility of Mr.
  Alamo and clearly demonstrate dishonesty and violate the rules of the
  tournament. Mr. Alamo admitted the act eventually:
- The evidence gathered during the preliminary investigation provides sufficient grounds to believe that the alleged complaints are serious and that the continued stay of the respondent in Office may prejudice the case by allowing influence on the safety and integrity of the records and other evidences presented.

#### RECOMMENDATION:

After a thorough review of the complaint and evidence presented, the Committee has determined that the evidence of guilt is strong which is a ground for suspension.

In view thereof, the Committee recommends for the **DISCIPLINARY SUSPENSION** of Mr. Willer Alamo, SK Chairperson of Barangay Bayanan, Bacoor City, Cavite for a period of thirty (30) days effective immediately.

Attached is the copy of supporting documents from COMELEC and Barangay Management Information System (BMIS).



Subject: LETTER OF COMPLAINT OF MS. JUANISE RAINEL I. IGNACIO, AUDITOR OF SANGGUNIANG KABATAAN FEDERATION OF BACOOR CITY, CAVITE AGAINST MR. WILLER ALAMO, SK CHAIRPERSON OF BARANGAY BAYANAN, FOR ALLEGED DISHONESTY AND FOR ALLEGED VIOLATION OF THE RULES OF AN INTER-CLUSTER BASKETBALL TOURNAMENT. (PCR 236-2025 dated 27 October 2025).

A committee hearing was held on October 30, 2025 at the Sangguniang Panlungsod Session Hall regarding the aforementioned subject matter with the following attendees. (See attached attendance sheet)

The hearing was presided over by Committee Chair Hon, Miguel Bautista. He also led the prayer, gave his opening remarks and acknowledged the presence of all the committee members and resource persons as well.

Before presenting her complaint, Ms. Juanise Rainel I. Ignacio, Auditor of the SK Federation of Bacoor City was first placed under oath. According to her, SK Chairperson of Barangay Bayanan, Willer Alamo submitted their team gallery on October 20, 2025. She stated that she had verified the names and addresses of the players to ensure that the information matched the two identification cards submitted by each of them. According to her, all players are required to submit a copy of their Voter's certificate and Identification Card. Upon checking their documents, she confirmed that there were no issues since the information in the documents was consistent and matched accordingly.

Afterwards, the coach of Cluster One raised a concern, which was subsequently brought to the attention of SK Federation. It was discovered that the individual being complained in the person of Mr. Sanggalang, is a registered voter of Dulong Bayan; however, the document submitted by Mr. Alamo indicated that he was from Mambog. They also found out about Mr. Joaquin Octavo after seeing his faceboock account ran for SK Kagawad in San Antonio Noveleta, where they saw his campaign materials and a post showing his hand being raised, indicating his victory as SK Kagawad. The group then brought all these concerns to the SK Federation to seek guidance on what actions could be taken regarding Mr. Alamo.

Councilor Palabrica stated that there appeared to be an act of dishonesty and that the documents had been tampered with. The complainant concurred with this statement. The respondent was then asked whether he had received the counteraffidavit and if he was willing to respond on the same day. Mr. Alamo affirmed his

willingness to give a statement, after which he was placed under oath prior to providing his testimonies.

According to the statement of SK Chairperson Alamo, he and five (5) other SK Chairpersons from Barangay Bayanan and Mambog 1 to Mambog 4 had a discussion. He stated that they agreed to look for players for their team. One of the SK Chairperson suggested a group called "Brotherhood". They then approached this club to ask if they could represent their respective teams.

They submitted a list of names, which they checked to verify whether all of them were residents and registered voters of Mambog. At first, they said that only two (2) were non-voters of Mambog, so they agreed to proceed where infact there were actually eight (8) non-voters.

SK Alamo then told the SK Chairpersons of Mambog to "find a way" to address the issue, which led to his attempt to commit dishonesty. This was later discovered by the SK Federation Auditor.

Mr. Alamo admitted to the act. Councilor Palabrica asked him what specific falsifications he had made, and he responded that he had placed the pictures of actual voters on certain Comelec documents. However, he clarified that no one from the Office of Comelec Bacoor was involved.

He further explained that the names and addresses were replaced because he obtained voter information from Noveleta, which he then submitted. Unknowingly, one of those listed was also an SK Chairperson from Noveleta. He added that he has a friend who has a skill in editing and making alterations.

SK Alamo admitted to the act of falsification he had committed. Because of his admission, Atty. Salve asked him about his reason or intention for doing such acts. Atty. Salve also expressed surprise upon learning that the document he tampered is not just an ordinary piece of paper, but a voter's certification. And what he did doesn't only fall under administrative offense but also under criminal offense.

SK Chairperson Alamo was asked if he was ready to go to jail for the fraudulent acts he committed. And after that Councilor Palabrica requested for a recess.

There being no other matters to be discussed, the hearing was adjourned at exactly12:00 pm.


