Subject: BARANGAY MAMBOG 3 – A RESOLUTION AUTHORIZING THE UTILIZATION OF FIVE HUNDRED THOUSAND PESOS (PHP500,00.00) FROM THE UNUTILIZED AMOUNT OF ONE MILLION TWO HUNDRED NINETY-TWO THOUSAND ONE HUNDRED SEVEN PESOS AND 83/100 (PHP 1,292,107.83) FROM THE 70% CALAMITY FUND OF BARANGAY MAMBOG 3 FOR THE PROCUREMENT OF RICE AS PART OF DISASTER PREPAREDNESS AND MITIGATION PROGRAMS. – PCR 251-2025 dated November 3, 2025

Referred to this Committee on the 18th Regular Session of 6th Sangguniang Panlungsod is the above-subject-matter for appropriate action and recommendation.

The Local Disaster Risk Reduction and Management Fund (LDRRMF) can be used for disaster prevention, mitigation, preparedness, response, rehabilitation, and recovery. For its purpose, the use of the fund includes the following:

- Purchasing early warning systems
- Acquiring preparedness equipment
- Buying life-saving rescue equipment, supplies, and medicines
- Training
- Paying premiums for calamity insurance
- Post-disaster activities

During the hearing of the previously approved barangay request of the same nature, the Committee noted the following facts, processes and procedures that were properly explained and established by the City Accountant Office and City Budget Office:

- The unutilized calamity fund is part of the saving, and as a trust fund in the current year. The trust fund can be re-programmed to related projects.
- The request of the Barangay to utilize the amount of **FIVE HUNDRED THOUSAND PESOS (PHP500,000.00)** to be taken from the unutilized 70% Calamity Fund.
- The unutilized risk reduction and management fund within the period of five years, as a trust fund, can be utilized by the barangay as per the advice of Auditor of the Commission On Audit, Bacoor City and to be certified the Head of Bacoor Disaster Risk Reduction and Management Office,
- The submission of a supplemental budget to be processed by the City Budget Office is no longer required considering that it is a trust fund. The subject matter falls under the processing of the City Accounting Office.
- The request of the Barangay to utilize the unexpended fund is a continuing process as long as there is savings based on the record of the City Accounting Office and until the balances of which are expended and the programs are properly documented.
- The Barangay have already submitted the BDRRME certification for the purpose.

RECOMMENDATION:

In view of the foregoing, and considering that the existing law allows the utilization of unexpended 70% Calamity Fund from the Local Risk Reduction and Management Fund, the Honorable Members of the Committee hereby recommend **TO APPROVE** the Barangay Resolution No. 10, Series of 2025 of Barangay **MAMBOG 3** Bacoor City, pertaining to the utilization of **FIVE HUNDRED THOUSAND PESOS (PHP500,00.00)** to be taken from the unutilized 70% Calamity Fund of the barangay amounting to **ONE MILLION TWO HUNDRED NINETY-TWO THOUSAND ONE HUNDRED SEVEN PESOS AND 83/100 (PHP 1,292,107.83)**, subject to the existing accounting and auditing rules and regulations.






