Subject: (PCR 257-2025) A RESOLUTION SUPPORTING AND AUTHORIZING THE IMPLEMENTATION OF REVETMENT PROJECTS FOR ALL RIVERS AND DRAINAGE SYSTEMS WITHIN THE CITY OF BACOOR. (Date referred November 17, 2025).

The committee hearing was executed on November 18, 2025, 11:08 am at the Session Hall, 6th floor, Bacoor Legislative & Disaster Resilience Building, Bacoor Government Center, Bacoor Boulevard. Brgy. Bayanan, City of Bacoor, Cavite. It was presided over by Chairman, Hon. Levy M. Tela, Committee on Public Works and Highways.

FINDINGS:

A revetment project is a civil works initiative that involves the construction of a protective facing along a riverbank, shoreline, or wall, typically utilizing materials such as stone, concrete, or steel sheet piles. The primary objective of such projects is to prevent erosion, stabilize embankments, and dissipate the energy of flowing water. These works are commonly undertaken as part of flood control and river management programs to safeguard adjacent communities, infrastructure, and public property from the adverse impacts of flooding and soil erosion.

Furthermore, the Bacoor City Government continues to strengthen its flood management measures and mitigate the detrimental effects of soil erosion and waterway degradation.

The list of projects necessary to complete the revetment works along identified rivers in the City of Bacoor, as well as national road sections without existing drainage facilities, submit herewith the endorsed list of proposed infrastructure projects.



Engr. Reimart: good morning mr chair unfortunately wala po kaming presentation pero meron po kaming listahan ng mga proyekto for the proposed funding ito po isa-isahin ko Construction/Upgrading/Rehabilitation of drainage along Bacoor-Dasmarinas National Rd. -K0020 + 43 -K0020 + 376, K0022 + 239-K0023 + 415, K0023 + 991 - K0024 + 143, K0024 + 553 - K0027 + 000, Bacoor City Cavite, amounting to 100 million. Next po is construction/Upgrading/Rehabilitation of drainage along Gen. Evangelista Rd., Bacoor City, Cavite amounting to 215 million, and pangatlo po yung construction Upgrading Rehabilitation of drainage along Marcos Alvarez Rd., Chainage 0-1396, Bacoor City, Cavite amounting to 75 million and pang apat po construction upgrading rehabilitation of drainage along Daang Hari Road, Bacoor City, Cavite amounting 245 million. for the flood management program, the construction of slope protection and other improvements along Maliksi River, Bacoor City, Cavite 70 million. Construction of slope protection and other improvements along Bacoor River, Bacoor City, Cavite amounting to 320 million and last po construction of slope protection and other improvements along Zapote River, Bacoor City, Cavite amounting to 840 million for the total of 1,865,000,000 pesos. Hon. Tela: These are some of the proposed projects that we have here in Bacoor, right,

Engr. Reimart: Yes, Mr. Chair. To give you an information, Mr. Chair, ito pong amount na to is for the completion na po ng lahat pong revetment projects for the flood management program. Ito na lang po yung remaining for funding natin para po may sarado natin yung mga riverbanks, dere-derecho na po yung ating mga slope protection going to coastal. Then, yun po naman sa preservation. Ito po yung mga drainage system within the national roads na located dito sa Bacoor City, Cavite. Kailangan po natin na improvement nun para po mas malimitahan na yung pagbaha dito sa Bacoor City.

Hon. Palabrica: These are the list endorsed by the city government on DPWH for funding, tama?

Engr. Reimart: Yes po, Mr. Chair.

Hon, Palabrica: Kumusta naman? Mapupondohan ba?

Engr. Reimart: Based po kasi sa direktiba nga po ng aming secretary, based din po kay Pangulong Bongbong Marcos na onhold po muna yung mga flood control. So sa pamamagitan po nito, baka po sakali na ma-reconsider ng aming secretary na kailangan po talaga ng Bacoor City ang flood management program projects.

Hon. Palabrica: Mainit kasi masyado yang flood control na yan. If my recollection is correct, Mr. Chair, last week or two weeks ago, there was a DPWH here.

Engr. Reimart: Kami rin po yun, Mr. Chair.

Hon, Palabrica: Kayo din pala yun. You said that there is no funding yet.

Engr. Reimart: Yes, sir.

Hon. Palabrica: So, anong mangyayari dito hanggang endorsement lang ito.

Engr. Reimart: Pagtutulung-tulungan po natin, so that the Secretary can understand that Bacoor really needs this kind of project.

Hon, Palabrica: It's justifiable namanin the part of the LGU Bacoor because we are like a catch basin here. You can justify that in the engineering terms na ang baba ng tubig dito lahat sa Bacoor, karamihan, kalakihan ng tubig dito sa Bacoor. If we don't have it, just like the flood management program or projects, diba sabi nyo nung nakaraan na taon ito na hold muna. So isana taon muna kaming magtitiis. But anyway, what is the possibility of funding this? Because it's big, 1.8 billion.

Engr. Reymart: Our department has requirements that there should be a feasibility study of the reference of these for funds. We have conducted a feasibility study for the drainage system improvement and the revetment project.

Hon. Palabrica: So, is it already available?

Engr. Abbygail: Sir, right now, on-going po yung revision on consultant namin. But they have committed that within this week or next week, they will submit the draft for checking and comments from our department.

Hon. Palabrica: That's important because that will be our justification for this request of funds.

Enar, Reimart: That's what they call a master plan.

Hon, Palabrica: Yes, correct. That's okay, There should be a basis. Because there's no project that can be funded, even if it's a local government unit, if there's no plan. The plan always is a requirement for funding. So, Mr. Chair, I hope this will be good. Although this is the first step, maybe this will be funded so that our problem here in Bacoor will be solved. For the longest time, people of Bacoor have been suffering of the damage brought about by flooding. I hope this will help us. On our part, what should we do? Or is this enough? Is this enough?

Engr. Reimart: Yes, sir. I mean, that's what I'm asking for I'm asking for the coordination of the LGU.

Hon, Palabrica: So, a resolution being requested by the mayor to this honorable council is a big help to see the coordination.

Engr. Reimart: Yes, sir. That's the most important.

Hon. Palabrica: That is the essence of our gathering today.

Engr. Reimart: Yes, sir. Because, as a matter of record, we're hearing from the news that mostly the other projects are not known by the LGU. Ah. So, you know, they're surprised that there are those that have not been done or there are anomalies. So, this is the way of the department so that the LGU can understand what the project is really going to be like

Hon. Palabrica: Totoo naman yun, maaaring hindi rin naman totoo. But, on our part, to be realistic, based on the requirements of your department, this is a proof. The resolution is a proof of a coordination between DPWH and the LGU Baccor.

Hon. Tela: And also, I think it was also a proposal of our mayor to see that he will also direct the letter to the president so that we can really learn and at the same time, we can really learn about the reduction of flood control here. Because, this is true. Because, when we talked about flood control, you said it right. You said that it may not be a priority. But, at the same time, you helped. At the same time, you helped our mayor to make it better and to make it less of a burden for us. So, he will direct the letter, maybe, to the mayor, to the president so that we can see what we are doing.

And also, pagkakaalam ko ito rin ang proposal ng ating butihing mayor para makita po tayo mag rerekta din po siya ng sulat kay presidente, para matutukan at the same time matutukan ang tungkol sa pagbawas ng problema sa pagbaha dito. Totoo naman ito. Kapag pinag-uusapan ang flood control, tama ang sinabi ninyo maaaring hindi ito maging prayoridad. Hon. Palabrica: Although, there is no assurance that it will be funded. This is the very first step para papunta dun sa funding. Maybe, hopefully, mapondohan kahit ilan man lang dito. Kasi hindi naman siguro ito mapupuro itong 1.8 million sa isang bagsakan. Magiging parang facing. Maybe. Pero Maganda kung makapag simula na tayo. And, rest assured, your department's credibility sa aming paningin hindi nagbabago. Kung wasak kayo sa taong bayan, dito hopeful kami sa kakayanan and capability and of course, yung malasakit ng inyong department sa ating bayan. Thank you very much, Mr. Chair.

Hon. Tela: Thank you. Kaya po tayo nagkakaroon ng ganito para din po malaman din po kasi mag aapprove po ang konseho regarding this, yung request para malaman po yung mga project na dapat gawin nakikita ng buong konseho at kung sakasakali ma actionan kaagad.
