Members of the 6th Sangguniang Panlungsod met in order to call the 20th regular Session on November 17, 2025 at 12:00 nn. The session was presided over by Hon. Reynaldo Palabrica, President Pro-Tempore. The body referred the above subject matter to the City Council En Banc Committee on Public Works and Highways, Hon. Levy M. Tela the Committee Chairperson, serving as the lead.

FINDINGS:

On July 28, 2025 the City Development Council (CDC) issued CDC Resolution No. 05, Series of 2025 entitled "A Resolution Requesting the Cavite Provincial Development Council (PDC) to endorse the Flood Control and Various Infrastructure Projects of the City of Bacoor to the CALABARZON Regional Development Council (RDC) for Possible Funding Amounting to Twenty-Three Billion Two Hundred Ninety Million Two hundred Forty-Nine Thousand Three Hundred Eighty-four Pesos and ten Centavos (PhP 23,290,249,384.10)", which was subsequently endorsed to the PDC.


