FINDINGS:

- Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the City Government to enter into partnership with educational institutions for the purpose of providing assistance to qualified students.
- On November 13, 2025, the Sangguniang Panlungsod received a letter from the Office of the Mayor requesting authority to sign a Memorandum of Agreement with the University of Perpetual Help System Molino Campus regarding the on-the-job training (OJT) for their students. This proposed Memorandum of Agreement is incorporated and made an integral part of this Resolution as Annex A.
- The proposed Memorandum of Agreement stipulates that Parties will undertake to promote and develop academic cooperation through an exchange of administrative staff and students and through an extension of students learning opportunities.
- The City Government of Bacoor is showing its commitment to the pursuit of knowledge, furthering national development, and addressing the educational needs of its constituents.
- Affording students hands-on experience in various fields may improve the performance of students after their graduation.

WHEREAS, the UNIVERSITY is vested by law to provide academic requirement, training and development of students in the field of Accountancy.

WHEREAS, the COMPANY is vested by law to employ, deploy and accommodate student trainees in its facility given its specific requirements based on company need, minimum skill requirements etc.;

WHEREAS, the UNIVERSITY and the COMPANY recognize the complementary nature of their respective objectives and goals in the industry.

NOW, THEREFORE, for and in consideration of the foregoing premises, the UNIVERSITY and the COMPANY hereby mutually agree and stipulate that:

The UNIVERSITY shall:

1. Avail of the training program offered by the COMPANY for its students who will qualify for the internship program (given the company's requirements).
2. Make sure that students who will qualify in the internship program shall complete the required 400 hours' corporate exposure and training.
3. Require all students participating in the COMPANY's training program to strictly adhere to its rules and regulations.
4. Be responsible in providing adequate and qualified student trainees conforming to the requirements of the COMPANY.

The COMPANY shall:

1. Provide a training program for the qualified students required to complete at least a minimum of three hundred (400) hours;
2. Award each student who has successfully completed the student training program a Certificate of Completion duly signed by the HR Manager/Officer.
3. Hold its Officers/ Supervisors and Employees to impart to the students' trainees the supervision and technical skills as practiced in the industry;

This Agreement is made purely as an accommodation by the COMPANY to the UNIVERSITY; that the student trainees are not employees of the COMPANY, and no employer-employee relationship shall exist between the students and the COMPANY. Thus, the COMPANY is not obligated to pay the student trainees wages. However, the student shall be provided on the duty meal and any allowance the COMPANY deems appropriate.
2. The COMPANY / UNIVERSITY shall not be held responsible for any untoward incidents/accidents and or illness that may happen to the students during the entire training.
3. The COMPANY has the final decision in the selection of student trainees based on the qualification standards set by the COMPANY. Further, the COMPANY has the option to decline students with adverse medical findings and for reasons it may deem appropriate.
4. Both parties shall consider an amicable settlement or resolution as the best course of action in conflicts and disagreements.
5. Both parties shall establish and agree to an Implementing Rules and Regulations to efficiently and effectively implement this Memorandum of Agreement (MOA).

NON-EXCLUSIVITY

Either Party has the prerogative to sign a similar MOA with other institutions.

EFFECTIVITY

This Agreement is valid for one (1) year and may be canceled, amended and or extended by mutual consent of both parties.
