Subject: *A resolution authorizing the City Mayor, Hon. Strike B. Revilla, to sign a deed of donation and acceptance on behalf of the City Government of Bacoor with the Municipality of Baras, Rizal regarding the donation of One (1) Unit of Mini Dump Truck by the City Government in favor of the Municipality of Baras.*

The above-mentioned proposed resolution underwent its first reading on December 01, 2025 during the 22nd Regular Session of the Sangguniang 6th Panlungsod. The said proposed ordinance was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

FINDINGS:

A letter from the Office of the City Mayor dated November 26, 2025 requesting the Sangguniang Panlungsod for appropriated legislative action regarding the proposed Tripartite Memorandum of Agreement among the City Government of Bacoor, the Municipality of Baras, and the National Housing Authority (NHA), as well as the Deed of Donation and Acceptance (DODA) covering one (1) unit of Mini Dump Truck to be donated by the City Government of Bacoor in favor of the Municipality of Baras, Rizal.

This MOA forms part of the continuing inter-local government cooperation relative to the implementation and support of the Savannah Homes NHA Relocation Project, particularly in ensuring the efficient delivery of basic services, solid waste management, and environmental sanitation for the benefit of the relocated families.


RECOMMENDATION:




