Subject: A resolution authorizing the creation of a Technical Working Group on the formulation of the Implementing Rules and Regulations of City Ordinance No. 320-2023 otherwise known as the "2023 Barangay Boundaries Settlement ordinance of the City of Bacoor, Cavite.

The above-mentioned proposed resolution underwent its first reading on December 01, 2025 during the 22nd Regular Session of the Sangguniang 6th Panlungsod. The said proposed ordinance was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

FINDINGS:

City Ordinance No. 320-2023 otherwise known as the "2023 Barangay Boundaries Settlement Ordinance of the City of Bacoor was approved by the Sangguniang Panlungsod on October 23, 2023.

Since the said ordinance took effect, the Sangguniang Panlungsod conducted a series of public hearings attended by the Barangay Officials and residents of the 47 barangays of the City of Bacoor, Cavite thresh out the various aspects of the settlement of the political boundaries of the said local government units.

Section 6 of the said ordinance provides that the office of the City Legal Service, with the assistance of the Zoning and Land Development Department, the City Environment and Natural Resources Office, and the City Engineering
