Subject: (PCR 313-2025) A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A DEED OF DONATION ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES – ENVIRONMENTAL MANAGEMENT BUREAU, CALABARZON REGION IV-A. (Date referred December 15, 2025)

The Committee held a committee hearing on January 08, 2026, at 11:18 am. at the Sangguniang Panlungsod, 6th Floor Bacoor Legislative & Disaster Resilience Building, Bacoor Government Center, Bacoor City, Cavite. It was presided over by the Chairperson of the Committee on Environment and Natural Resources, Hon. Levy M. Tela.

FINDINGS:

The placed trash traps and nets in the following locations within the City of Bacoor are the subject of this donation:

- Habay Globe (Dulong Bayan Creek), Brgy. Dulong Bayan;
- Imus River, Brgy. Habay II;
- Imus River, Brgy. Mambog;
- Mestizo River, Brgy. Poblacion; and
- Panapaan Creek, Brgy. P.F. Espiritu I.

The PARTIES previously entered into a Memorandum of Agreement (MOA) title "For the Protection of Installed Trash Trap at Imus River", located in Brgy. Habay II, Bacoor City, Cavite, Province of Cavite, which was duly signed on July 10, 2024 at Fynn Boutique Hotel, Bacoor, Cavite. The said MOA delineates the respective responsibilities of each party concerning the protection, upkeep, and continued maintenance of the installed trash trap.

EMB-Calabarzon hereby freely and voluntarily gives, conveys, and transfers, by way of donation, unto the LGU one (1) unit set of Trash Traps, installed on November 30, 2023, inclusive of a one (1) year service warranty, and in accordance with the following technical specifications:

- Collapsible 3" G.I. pipe (Schedule 40) main frame
- 3.0" G.I. pipe (Schedule 40) support frame
- Steel matting
- Flat bar 1" x 1", $\frac{1}{4}$ inch thick
- Angle bar 2" x 2", $\frac{1}{4}$ inch thick

- Five (5) meters of stone masonry for soil erosion protection
- Concrete post with an average elevation of 1.20 meters from the creek water level and a foundation depth of 1.0 meter from the natural grade line
- Footing measuring 1 meter x 1 meter

EMB-Calabarzon is dedicated to promoting sustainable development by encouraging inclusive stakeholder engagement in the protection, stewardship, and responsible governance of said resources for the benefit of both present and future generations. It is the primary government agency tasked with supervising the conservation, appropriate management, development, and prudent utilization of the nation's environment and natural resources.

EMB-Calabarzon is encouraged to build and reinforce cooperation agreements with public and private stakeholders in support of environmental protection, conservation, and rehabilitation. In accordance with the Supreme Court's Writ of Continuing Mandamus from G.R. Nos. 171947-48, the EMB-Calabarzon is required, in conjunction with the Department of Environment and Natural Resources (DENR-EMB) and the relevant Local Government Units (LGUs), to clean up, preserve, and restore Manila Bay's waters to Class SB level, as defined by Department Administrative Order (DAO) No. 90-34, making them suitable for swimming, skin diving, and other forms of contact recreation.

In order to improve waste collection and disposal within its territorial authority, LGU-Bacoor will use the donated trash traps. To this end, it will take on the following tasks and responsibilities:

- Ensure the secure handling and provision of appropriate storage facilities for collected and segregated solid waste along Imus River, Barangay Habay II, Bacoor City, Province of Cavite, in accordance with the provisions of Republic Act (R.A.) No. 9003, otherwise known as the Ecological Solid Waste Management Act of 2000;
- Designate and deploy at least two (2) qualified and competent personnel to operate, monitor, and maintain the trash traps;
- Undertake the proper and efficient operation, routine maintenance, and timely repair of the trash traps to ensure their continuous functionality;
- Implement segregation-at-source and enforce segregated waste collection practices in the operation of the trash traps;
- Provide appropriate Personal Protective Equipment (PPE) to all personnel assigned to operate and maintain the trash traps, in accordance with occupational safety standards;
- Allocate sufficient funds from the Barangay's annual budget and Internal Revenue Allotment (IRA) to cover operational costs including, but not limited to, repairs, utilities (e.g., fuel, electricity), and other incidental costs necessary to sustain the trash traps' functionality; and
- Institute appropriate security measures to safeguard the trash traps against tampering, vandalism, and adverse environmental conditions.





The committee respectfully recommends that the Sangguniang Panlungsod members **APPROVE** on second reading the Proposed resolution "A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A DEED OF DONATION ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES – ENVIRONMENTAL MANAGEMENT BUREAU, CALABARZON REGION IV-A."





WHEREAS, in compliance with the Writ of Continuing Mandamus issued by the Supreme Court in G.R. Nos. 171947-48, the DONOR, together with the Department of Environment and Natural Resources (DENR-EMB) and the concerned Local Government Units (LGUs), is mandated to undertake the cleanup, rehabilitation, and preservation of Manila Bay, and to restore and maintain its waters to Class SB level, as defined under Department Administrative Order (DAO) No. 90-34, thereby rendering them suitable for swimming, skin diving, and other forms of contact recreation;

WHEREAS, the PARTIES previously entered into a Memorandum of Agreement (MOA) titled "For the Protection of Installed Trash Trap at Imus River," located in Brgy. Habay II, Bacoor City, Province of Cavite, which was duly signed on July 10, 2024 at Fynn Boutique Hotel, Bacoor, Cavite; said MOA delineates the respective responsibilities of each party concerning the protection, upkeep, and continued maintenance of the installed trash trap;

WHEREAS, the DONOR hereby freely and voluntarily gives, conveys, and transfers, by way of donation, unto the DONEE one (1) unit set of Trash Traps installed on November 30, 2023, inclusive of a one (1) year service warranty, and in accordance with the following technical specifications:

1. Collapsible 3" G.I. pipe (Schedule 40) main frame
2. 3.0" G.I. pipe (Schedule 40) support frame
3. Steel matting
4. Flat bar 1" x 1", 1/4 inch thick
5. Angle bar 2" x 2", 1/4 inch thick
6. Five (5) meters of stone masonry for soil erosion protection
7. Concrete post with an average elevation of 1.20 meters from the creek water level and a foundation depth of 1.0 meter from the natural grade line
8. Footing measuring 1 meter x 1 meter

WHEREAS, the DONEE shall utilize the donated trash traps to enhance waste collection and disposal efforts within its territorial jurisdiction, and shall assume the following roles and responsibilities in support of this objective:

1. Ensure the secure handling and provision of appropriate storage facilities for collected and segregated solid waste along Imus River, Barangay Habay II, Bacoor City, Province of Cavite, in accordance with the provisions of Republic Act (R.A.) No. 9003, otherwise known as the "Ecological Solid Waste Management Act of 2000."
2. Designate and deploy at least two (2) qualified and competent personnel to operate, monitor, and maintain the trash traps;
3. Undertake the proper and efficient operation, routine maintenance, and timely repair of the trash traps to ensure their continuous functionality;
4. Implement segregation-at-source and enforce segregated waste collection practices in the operation of the trash traps;

5. Provide appropriate Personal Protective Equipment (PPE) to all personnel assigned to operate and maintain the trash traps, in accordance with occupational safety standards;
6. Allocate sufficient funds from the Barangay's annual budget and Internal Revenue Allotment (IRA) to cover operational including, but not limited to, repairs, utilities (e.g., fuel, electricity), and other incidental costs necessary to sustain the trash traps functionality; and
7. Institute appropriate security measures to safeguard the trash traps against tampering, vandalism, and adverse environmental conditions.

WHEREAS, the DONOR reserves the right to revoke this Deed of Donation and Acceptance and withdraw the donated set of Trash Traps in the event that the DONEE fails, without justifiable cause, to undertake the necessary preparatory activities, installation, commissioning, and utilization of the Trash Traps, or otherwise fails to perform its stipulated roles and responsibilities under this DODA including, but not limited to, the following:

1. Ensuring the provision and deployment of one (1) unit of brand-new Trash Traps to the qualified barangay for the enhancement of local waste management practices, in accordance with R.A. No. 9003, or the "Ecological Solid Waste Management Act of 2000" and R.A. No. 9275, or the Philippine Clean Water Act of 2004; and
2. Establishing and conducting regular monitoring and evaluation activities to ensure compliance with the terms and objectives of this DODA.

WHEREAS, the DONEE hereby formally accepts and receives the donated Trash Trap, and expressly acknowledges the generosity and liberality of the DONOR and that the acceptance shall take effect upon the signing of this DODA;
