

SUBJECT : Special Written Report re-Alleged Violation of R.A. 8353 (Anti-Rape Law), Robbery in Band and Violation of RA 10883 (New Anti-Carnapping Act of 2016)

1. References:

- a. Spot Report dated November 23, 2025, with subject same as above.
- b. 1<sup>st</sup> Progress Report dated November 23, 2025, with subject same as above.
- c. 2<sup>nd</sup> Progress Report dated November 24, 2025, with subject same as above.

2. This pertains to the reported Violation of RA 8353 (Anti-Rape Law), Violation of RA 10883 (New Anti-Carnapping Act of 2016) and Robbery in Band which transpired on November 22, 2025 at around 7:45 AM at Zone 6, Barangay Talaba 3, Bacoor City, Cavite wherein the complainants/victims were as follows:

1. Alias "NENA," female, 18 years old (born on November 14, 2007, in Bacoor City, Cavite), single, Grade 9 student, and live streamer;
2. Alias "TEP", male, 25 years old (born on July 14, 2000, in Bacoor City, Cavite), single, senior high school graduate, and employed as a factory worker;
3. Alias "NICA", female, 22 years old (born on February 16, 2003, in Las Piñas City), single, high school graduate, and unemployed.

All residents of #248, Zone 6, Barangay Talaba 3, Bacoor City, Cavite.

3. The suspects were fourteen (14) personnel of PNP Drug Enforcement Group, Special Operation Unit 4A, Police Regional Office 4A, Camp Vicente Lim, Barangay Mayapa, Calamba City, Laguna.

4. Initial investigation disclosed that while the victim was in front of their residence using her cellphone, a group of more or less eight (8) armed men in civilian attire who introduced themselves as policemen from Canlubang suddenly arrived, grabbed her by the hand, and forcibly entered the house. Once inside, the armed suspects started looking for @ RV who happened to be @ NENA's boyfriend and searched through their belongings where they took her two (2) gold rings worth Php 40,000.00, her iPhone 13 worth Php 40,000.00, her boyfriend's shoes, shirt, and cap worth Php5,000.00, two (2) helmets worth

Php6,000.00, a piggy bank containing more or less Php15,000.00, and cash amounting to Php1,500.00.

The suspects likewise took the Infinix Hot 11s and a Redmi 14C cellphones of live-in partners, @ TEP and @ NICA with an estimated total value of Php23,000.00.

5. Since the armed suspects were not able to find @ RV, she was told that they will arrest her instead wherein she heard the alleged team leader saying "AKO NA ANG BAHALA SA IYO" while the other armed suspects alternately saying, "SIGE SIR IYAN NA LANG ARESTUHIN NATIN" which caused fear on the part of the victim @ NENA.

6. Thereafter, the team leader ordered his companions to go outside, locked the door of the room, undressed himself and told the victim to perform oral acts on him while threatening her that if she will not cooperate with what he wants, they will take her and arrest her. Out of fear, the victim complied and did everything he forced her to do then the team leader kissed her on the lips and her breast then forcibly inserted his penis to victim's genitalia. That after satisfying his lustful desire, the team leader and his companions left taking with them the victim's yellow Yamaha Mio i125 motorcycle where she even heard the team leader uttered the words, "PAGAWAAN NINYO NA LAMANG NG DUPLICATE" pertaining to the keys of the motorcycle.

7. Sensing that the group left their house, @ NENA proceeded to the nearby house of her sister then to her aunt's house where she stayed for a while since the group was still present in the area. After @ NENA and her relatives were certain that the group left their barangay, they proceeded to the barangay hall of Talaba 3 to report the incident. The barangay officials led by Barangay Captain Emmanuel T Trinidad assisted the victim to this station where she, in the presence of the undersigned, the barangay officials and the Women and Children and Protection Desk investigator, narrated what happened, described the suspects involved as well as the vehicle used by the suspect, a red Toyota Innova with plate number SHU 704.

8. Upon receipt of the report, the investigators-on-case and intelligence operatives proceeded to and secured the crime scene to preserve evidence, interviewed possible witnesses and initiated backtracking and retrieval of CCTV footage in the vicinity to aid in the identification of the suspects. The Chief of Police personally assessed the crime scene and instructed the investigators-on-case to request from Cavite Provincial Forensic Unit the assistance of Scene of the Crime Operation (SOCO) Team for the technical aspect of investigation.

9. The SOCO Team from Cavite Provincial Forensic Unit led by PMAJ AUREE RENAN M. RANER arrived and processed the crime scene and was able to recover the following pieces of evidence;

- a) brown medium underwear
- b) white crumpled tissue
- c) two (2) cut pieces of cloth from a foam bed

10. Subsequently and upon instruction of the undersigned, the victim underwent a genital examination at Cavite Provincial Forensic Unit. That on November 22, 2025 at about 7:20 PM, the examination conducted by PMAJ ATTY. PETE C MALINAO, MD, Medico-Legal Officer was completed and a Medico-Legal Report with number R25-287-CAV was issued.

11. That upon receipt and confirming the reported incident, the undersigned Chief of Police immediately created a team composed of investigators from General Investigation Section and Women and Children Protection Desk Section, operatives from Intelligence Section, SWAT Team and mobile patrollers to conduct thorough investigation of the case for its speedy resolution. Relentless concerted efforts were exerted by the members of the team and through CCTV review and backtracking, the getaway vehicle of the suspects was captured in the CCTV cameras located in the barangay and identified as a red Toyota Innova with plate number SHU 704.

12. Through the acquired knowledge from @ NENA that the armed male persons in civilian attire introduced themselves as policemen from Canlubang, the undersigned ordered the operatives to check any coordination from other units who conducted operation within the City of Bacoor on November 22, 2025. A Coordination from PNP Drug Enforcement Group (DEG) Special Operations Unit 4A to conduct anti-illegal drug operation (buy-bust) at Barangay Talaba 6, Bacoor City, Cavite from November 22, 2025, 1:10 AM to November 23, 2025, 1:10 AM was found among the correspondence sent to this station wherein the operating personnel and the vehicles used were listed and attached to the said coordination.

13. That upon scrutiny, the red Toyota Innova with plate number SHU 704 which was captured in the CCTV camera and was positively identified by @ NENA as the suspects' getaway vehicle matched with the red Toyota Innova with same plate number listed in the coordination made by the PNP Drug Enforcement Group (DEG) Special Operations Unit 4A.

14. Having the list of the operating elements from the coordination, this station exerted efforts to find pictures of each of the names listed therein and once obtained, together with other pictures from the rogue gallery of this station were presented to the victims for identification. The victims through the mixed pictures presented were able to identify the operatives from PDEG SOU 4A as the same person who forcibly entered their house then took and carted away their personal belongings while @ NENA positively identified the team leader as the very same person who sexually abused her.

15. With the information at hand regarding the suspects, the undersigned sought the guidance of the Provincial Director, Cavite Police Provincial Office and the Regional Director, Police Regional Office 4A who gave their instruction to continue the hot pursuit against the suspects for their possible apprehension. Wasting no time, at about 11:10 PM of November 22, 2025 personnel of Bacoor Component City Police Station led by PCPT HERMINIGILDO M. SORIANO JR, together with the undersigned Chief of Police and the victims, were dispatched to PDEG SOU4A located in Camp Vicente Lim, Calamba Laguna to conduct hot pursuit operation. Thereat, a joint operation with Regional Intelligence Division, Regional Headquarters Support Unit and Regional Mobile Force Battalion, under the personal supervision of the undersigned, was conducted which resulted in the arrest of the above-mentioned suspects at about 2:00 AM of November 23, 2025.

16. That during the course of the hot pursuit operation, the undersigned was in constant communication with the Regional Director, PRO 4A regarding the development of the operation wherein upon arrival of the operating elements at the PDEG SOU 4A, the Regional Director, through telephone call, instructed the PDEG SOU 4A Team Leader to produce all the operating personnel involved in the operation conducted on the morning of November 22, 2025 which he acceded.

17. That eight out of the fourteen suspects were arrested and they were personally and positively identified by the victims who were then inside the mobile car of this station parked near the PDEG SOU 4A Office. Likewise, @ NENA identified the red Toyota Innova with plate number SHU 704 as well as the yellow Yamaha Mio 125i she owned and allegedly stolen by the suspects, as both vehicles were parked at PDEG SOU 4A parking area.

18. The undersigned was likewise able to ask the team leader after their arrest whether or not they conducted operation on November 22, 2025 in Bacoor City and what was the result of their operation which he admitted that there was an operation and it yielded negative result. He was further asked if a report was submitted or if they filed or they will file a case but he answered in the negative. Thereafter, the Chief of Police informed him regarding the complaints of robbery and rape against them which the team leader replied

that he is taking full responsibility and even returned the iPhone 13 cellphone owned by @ NENA which was stolen by the group.

19. After the arrest was made, the suspects peacefully surrendered their issued firearms, as follows;

- a) One (1) Zigana PX-9 pistol with SN T0620-19BM08483 loaded with 14 rounds of live ammunition;
- b) One (1) Glock 17 Gen 4 pistol with SN PNP52157 loaded with 17 rounds of live ammunition;
- c) One (1) Canik TP9 SF Elite-S pistol with SN T6472-19BG22889 loaded with 10 rounds of live ammunition;
- d) One (1) Zigana PX-9 pistol with SN T0620-19BM09883 loaded with 8 rounds of live ammunition;
- e) One (1) Canik TP9 SF Elite-S pistol with SN T6472-19BG08018 loaded with 15 rounds of live ammunition;
- f) One (1) Canik TP9 SF Elite-S pistol with SN T6472-19BG10889 loaded with 15 rounds of live ammunition;
- g) One (1) Canik TP9 SF Elite-S pistol with SN T6472-19BG11117 loaded with 12 rounds of live ammunition;
- h) One (1) Canik TP9 SF Elite-S pistol with SN T6472-19BG13483 loaded with 12 rounds of live ammunition while the proceeding pieces of evidence were recovered during the search conducted in the presence of the barangay official witnesses and arrested suspects as follows;

- a) One (1) iPhone 13 cellphone owned by the victim allegedly stolen by the suspect/s;
- b) One (1) red Toyota Innova vehicle with plate number SHU 704;
- c) One (1) color yellow Mio i125 motorcycle without attached plate number, owned by the victim allegedly stolen by the suspects;
- d) Two (2) heat-sealed transparent plastic sachets and one (1) knot-tied transparent plastic bag containing white crystalline substance suspected as shabu, weighing more or less 86 grams, with a standard drug price of Php584,800.00;
- e) One (1) color pink wallet;
- f) Boodle money; and
- g) Two (2) pieces of car plate number RGD944

An inventory of the recovered pieces of evidence was conducted in the presence of the arrested suspects and Barangay Kagawad Apolonio O Dimayuga and Jose Omar Miguel, elected officials of Barangay Mayapa, Calamba City, Laguna.

20. On November 23, 2025, at around 4:30 PM, the investigator-on-case submitted the confiscated suspected drug evidence to the Cavite Provincial Forensic Unit (PFU) for laboratory examination. Likewise, all arrested suspects were subjected to a Drug Test Examination as part of the standard post-arrest procedures.

21. That based on the results of the Laboratory Examination completed on November 24, 2025, at around 5:30 AM, the confiscated suspected drug evidence yielded NEGATIVE as reflected in Chemistry Report No. D-2135-25-RFU4A-A. Furthermore, based on the results of the Drug Test Examination completed on November 23, 2025, at around 7:35 PM, all suspects yielded NEGATIVE as indicated in Chemistry Report Nos. DT-2887 to DT-2894-25-RFU4A-A.

22. All arrested suspects are presently under the custody of Bacoor Component City Police Station Custodial Facility.

23. That a case conference with PMAJ DARWIN S VIADUMANG, Provincial Legal Officer, Cavite PPO was held during the preparation of criminal complaints for

Violation of R.A. 8353 (Anti-Rape Law), Robbery in Band, and Violation of R.A. 10883 (The New Anti-Carnapping Act of 2016) against the fourteen (14) suspects.

24. That the above-mentioned cases were filed before the Office of the City Prosecutor-Bacoor City through Inquest Proceedings received on November 23, 2025 and conducted by Honorable Neil Bryan S. Tibayan, Assistant City Prosecutor and docketed under NPS No. IV-27-INQ-25K-0902.

25. The seven (7) other arrested suspects had also undergone buccal swab in compliance with the Verbal Instructions of The Director, DIDM and The Director, Forensic Group as relayed to Bacoor CCPS dated November 29, 2025. Results of which is yet to be received by this office.
