The Committee, after due deliberation and consultation with the representatives of Funeraria Mesina, respectfully submits this report regarding the previously raised request to amend the reference to "Mesina Funeral Home" in City Resolution No. 2025-877, Series of 2025.

During the committee discussion, the Funeraria Mesina representative clarified the concern regarding the business name appearing in the Resolution. It was formally conveyed and placed on record that Funeraria Mesina agrees not to pursue any amendment to City Resolution No. 2025-877. Instead, Funeraria Mesina committed that the correct and duly recognized business name "FUNERARIA MESINA" shall be used in all Statements of Account (SOA) and official documents for all transactions within the City of Bacoor.

For the purpose of clarification, it was confirmed that Mesina Funeral Homes is situated in Las Piñas City, while Funeraria Mesina is the establishment legally operating in Bacoor City, supported by the Sanitary Permit issued by the City Government of Bacoor.

4. Continued use of "Funeraria Mesina" in all SOA and official city transactions ensures accuracy and consistency in records.


## RECOMMENDATION:

The hearing was presided over by Committee on Social Services Chairman, Hon. Horacio Brillantes, Jr. He gave his opening remarks and acknowledged the presence of all the committee members and resource persons as well.

During the deliberation concerning the requested amendment of the business name stated in the said Resolution, the representative of Funeraria Mesina namely Ms. Aiza Tayco and Mr. Mark Edward Tayco clarified the concern on the use of "Mesina Funeral Home" indicated in the Resolution. It was formally stated and placed on record that Funeraria Mesina has agreed not to pursue any amendment to City Resolution No. 2025-877, Series of 2025, and instead, commit that the name "FUNERARIA MESINA" shall be consistently used in their Statements of Account (SOA) and all official transactions within the entire City of Bacoor. It was further clarified that Mesina Funeral Homes is located in Las Piñas City, while Funeraria Mesina is the establishment duly operating and registered in Bacoor City, as supported by their existing local permits such as the Sanitary Permit issued by the City Health Office. With the foregoing agreement, the Committee acknowledged the clarification as sufficient to maintain accuracy in official records while ensuring smooth program implementation. There being no further matters to discuss, the meeting was adjourned and seconded at exactly 10:17 a.m.





Accordingly, this clarification is respectfully submitted to ensure the accuracy of official records and consistency with the legally recognized business name.
