Subject: *PCR 335-2025 – A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY GOVERNMENT OF BACOOR AND THE DEPARTMENT OF INFORMATION AND COMMUNICATIONS TECHNOLOGY. (referred January 05, 2026).*

The aforementioned proposed City Resolution was endorsed by the Office of the City Mayor to the Sangguniang Panlungsod on December 11, 2025. The draft of Memorandum of Understanding was subsequently attached and made an integral part of this report, along with the minutes of the hearing, attendance sheets, and photos taken during the January 14, 2026 hearing.

FINDINGS :

The Department of Information and Technology (DICT), fulfilling its mandate under R.A. No. 10844, develops Information and Communications Technology (ICT), plans, and initiatives that ensure effective knowledge sharing, resource allocation, comprehensive database building, and strengthening agency connectivity among government agencies.

In accordance with this, the DICT, through its training arm, the ICT Literacy and Competency Development Bureau (ILCDB), is tasked to promote ICT-related competencies by providing ICT courses, programs, and policies and conducting comprehensive trainings and other capacity-building activities that aim to strengthen ICT skills and awareness across all sectors of the Philippines.

Considering DICT's role in promoting ICT initiatives, a mutual understanding between the City Government of Bacoor and the mentioned parties embodies the significance of reinforced inter-agency coordination and cooperation, which aims to enhance ICT literacy and competency among the public and achieve effective digital governance within the City.

RECOMMENDATION :

Following careful analysis and deliberation, the Committee on Information and Communications Technology and Committee on Education, Science and Technology recommend to **APPROVE** the proposed city resolution authorizing the City Mayor, Hon. Strike B. Revilla, to sign a Memorandum of Understanding between the City Government of Bacoor and the Department of Information and Communications Technology.
