This committee report pertains to the committee hearing conducted on January 14, 2026 relative to the above-stated subject matter. The hearing was presided over by the Chairperson of the Committee on Housing, Land Utilization and Urban Development, Hon. Horacio M. Brillantes Jr. and was held at the Sangguniang Panlungsod Session Hall situated on the 6th Floor of the BLDR Building, Bacoor Government Center, Barangay Bayanan, Bacoor City, Cavite. The minutes, attendance sheets, and pictures taken during the said hearing are attached hereto and shall be made integral parts of this report.

FINDINGS:

After careful evaluation of the documents and deliberation during the Committee's review, the following findings are hereby presented:

- The grant of beneficial use of the subject City-owned property requires prior legislative authority from the Sangguniang Panlungsod.
- The proposed grant is consistent with existing laws and policies governing the use of local government properties.





- The continued use of the property by the Judiciary serves public interest and supports the efficient administration of justice.
- Necessary documentary and technical requirements are already in the process of completion by the concerned offices.

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Joint Committee hereby recommends the **APPROVAL** of the Proposed City Resolution authorizing the grant of donation and/or beneficial use of the building space of the Old City Hall Building with the approved technical description and size by the Trial Courts of Bacoor City, Cavite.
