The above-mentioned proposed resolution underwent its first reading on January 26, 2026 during the 27<sup>th</sup> Regular Session of the 6<sup>th</sup> Sangguniang Panlungsod. The said proposed resolution was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

### FINDINGS:


