Subject: *PCR 350-2026* – BARANGAY ORDINANCE NO. 5, SERIES OF 2026 ENTITLED: "AN ORDINANCE MANDATING THE ADOPTION, IMPLEMENTATION, MAINTENANCE OF A DIGITAL BARANGAY MANAGEMENT INFORMATION SYSTEM (BMIS), PROVIDING GUIDELINES FOR DATA MANAGEMENT AND ALLOCATING FUNDS THEREOF. (dated January 26, 2026)

Barangay Ordinance No. 5 series of 2026 was endorsed to the Sangguniang Panlungsod by Barangay Talaba 2. The said Barangay Ordinance mandates the adoption, implementation, and maintenance of a digital Barangay Management Information System (BMIS), providing guidelines for data management and allocating funds thereof.

FINDINGS :

Barangay Talaba 2, through the continuous efforts of the Sangguniang Barangay to maintain an updated and reliable record of all its inhabitants, has adopted a modernized administrative process to ensure the faster delivery of services, accurate profiling, and transparent governance. Barangay Talaba 2 formulated an ordinance known as Barangay Talaba 2 BMIS Ordinance of 2026. The aim is to establish a centralized digital database of all residents, streamline the issuance of clearances, certificates, and indigency reports, improve disaster response and health monitoring through real-time data, and ensure 100% compliance with the Data Privacy Act of 2012. BMIS also includes the profiling of residents in different segment groups. Its digital implementation eases the barangay document processing and tracking for legislative and finance purposes.

RECOMMENDATION :

Following careful analysis and deliberation, the Committee on Information and Communications Technology and Committee on Barangay Affairs recommend the **approval** of the Barangay Ordinance No. 5, Series of 2026 entitled: "An Ordinance Mandating the Adoption, Implementation, Maintenance of a digital Barangay Management Information System (BMIS), providing guidelines for data management and allocating funds thereof given that the said barangay ordinance would present a modernized approach on the records system and would provide a better barangay documents services to its constituents.
