The above mentioned subject matter underwent first reading on October 02, 2023 during the 63rd Regular Session of the Sangguning Panlungsod. The said subject matter was referred by the Presiding Officer Hon. Rowena Bautista Mendiola to the Committee on Ethics, Appointments, and Government Reorganization.

The Committee on Ethics, Appointments and Government Reorganization sent out invitations to the resource persons and conducted a committee hearing on October 05, 2023 at the Session Hall of the Sangguniang Panlungsod at 11:00 a.m.

FINDINGS:
