Subject: A resolution approving the official name of the existing lying-in clinic and eye center at Barangay Talaba 1 as 24/7 City of Bacoor Lying-In and Eye Center.

The above-mentioned subject matter underwent first reading on February 19, 2024 during the 79th Regular Session of the Sangguniang Panlungsod. The said subject matter was referred by the Presiding Officer, Bacoor City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Health and Sanitation.

The Committee on Health and Sanitation sent out invitations to the resource persons and conducted a committee hearing on February 29, 2024 at the Sangguniang Panlungsod Session Hall at 9:00 a.m.

#### FINDINGS:

During the City Health Board meeting conducted last February 15, 2024, it was raised that the existing lying-in and eye center in Talaba 1 presently operating has no official name and identity.

The said lying-in and eye center has numerous numbers of patients being served. It was established and being operated by the City Government of Bacoor.

The proposed official name of the said government medical establishment would be 24/7 City of Bacoor Lying-In and Eye Center and is needed for its identification.

#### RECOMMENDATION:

After a thorough review of all the circumstances and statements from the resource persons, the Committee respectfully recommends that the Sangguniang Panlungsod approve the above subject matter.

By the motion of Hon. Reynaldo C. Palabrica duly seconded by all the members of the Sangguniang Panlungsod, the above subject matter was APPROVED during its 81st Regular Session.



- The Presiding Officer, City Councilor Hon. Reynaldo Palabrica read the above-subject matter and the committee hearing was called to order.
- The Presiding Officer then proceeded with the introduction of the members of the Honorable Committee and City Councilors present in the committee hearing.

- The Presiding Officer asked the City Health Services Head, Dra. Ivy Marie Yrastorza to give before the Honorable Committee her comments and suggestions regarding the proposed resolution.

#### OFFICE OF THE SAGGUNIANG PANLUNGSOD

- Dra. Ivy Marie Yrastorza narrated that the said medical establishment opened last 2011 and was initially called Bacoor Lying-In wherein the same official documents of the medical establishments were submitted to the Department of Health.
- Dra. Ivy Marie Yraztorza added that there was no existing city ordinance or city resolution from the previous term of City Mayor Hon. Strike B. Revilla seeking for the official name of the said medical establishment.
- Dra. Ivy Marie Yraztorza mentioned that for this year's accreditation to PHILHEALTH, the city is required to present an ordinance or a resolution stating the name of the lying-in. She further mentioned that since 2015, the name 24/7 City of Bacoor Lying-In and Eye Center was already being used as the official name of the medical establishment.
- The Presiding Officer asked for the comments/suggestions of the members of the Honorable Committee.
- City Councilor Hon. Alde Pagulayan saw no reason not to approve the proposed resolution and proceeded with the motion of approving the same, duly seconded by all the members of the Honorable Committee.
- The Presiding Officer solicitated a motion for the adjournment of the committee hearing.
- City Councilor Hon. Alde Pagulayan moved for the adjournment of the committee hearing duly seconded by all the members of the Honorable Committee present.
- The committee hearing ended at 9:20 a.m.
