Subject: *Letter from the Office Commission on Human Rights Regional Office IV-A regarding the complaint of Ms. Mylene Remojo Y Fermanes of the alleged domestic and economic abuse by her husband which was neglected by Barangay VAWC Desk Officer named Cristina A. Clarito of Barangay Molino 1 on April 30, 2024.*

(PCR 598-2024 – Date Referred: June 10, 2024)

The above-mentioned subject matter underwent its first reading on June 10, 2024 during the 94th Regular Session of the Sangguniang Panlungsod. The said complaint was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Ethics, Appointments, and Government Reorganization.

The Committee on Ethics, Appointments and Government Re-Organization sent out invitations to the resource persons and conducted a hearing on June 13, 2024, 10:00 a.m. at the Session Hall of the Sangguniang Panlungsod.

FINDINGS:

During the committee hearing, it was found out that the above-subject matter emanated by the actions of the VAWC Desk Officer of Barangay Molino 1, Ms. Cristina Clarito. The complainant narrated that she felt neglected and disenfranchised by the remarks made by the VAWC Desk Officer.

The Committee Chairman explained that the Honorable Committee have the power and the authority to reconcile disagreements and suggested that this case to be amicably settled and a compromise agreement will be made. Both parties agreed to the manifestation made by the committee chairman.





The Committee Chairman ordered Ms. Cristina A. Clarito, Barangay Molino 1 VAWC Desk Officer to schedule another hearing between the complainant Ms. Mylene Remojo and her husband Renan Remojo and to make a final agreement between the two.

The Committee Chairman also instructed the Punong Barangay of Molino 1, PB Jeo Dominguez to supervise and monitor the scheduled hearing and to take photos of the proceedings. He further advised the complainant, Ms. Mylene Remojo to file necessary legal action in case the amicable settlement and agreement made is not fulfilled by her husband.

RECOMMENDATION:

After a thorough review of all the circumstances and statements from the resource persons, the Committee respectfully recommends that the Sangguniang Panlungsod dismiss the above subject matter.

By the motion of Hon. Alejandro Gutierrez duly seconded by all the members of the Sangguniang Panlungsod, the above subject matter was **DISMISSED** and was permanently archived in the agenda during its 95th Regular Session.

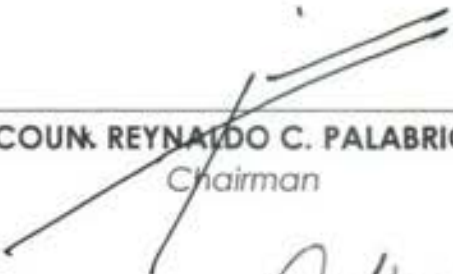

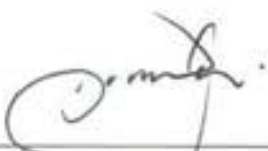

COUN. REYNALDO PALABRICA "In attendance to this committee hearing are the following members of the committee."

COUN. REYNALDO PALABRICA "May I request the resource person present to introduce themselves and their representation, let us start with Kap."

KAP. JEO DOMINGUEZ "Magandang umaga ho Mr. Chair and sa bumubuo ng Sangguniang Panlungsod, ako po si Jeo Dominguez punong barangay po ng Molino 1."

COUN. REYNALDO PALABRICA "Thank you Kap., next."

CRISTINA CLARITO "Good morning po, Cristina Clarito po not Claro ang inirereklamo po ni Mrs. Remojo."

COUN. REYNALDO PALABRICA "Thank you very much, next."

LEONILA F. DASALLA "Good morning po sainyong lahat. Leonila Felicia Dasalla po VAWC."

COUN. REYNALDO PALABRICA "Thank you very much, so secretariat nandito na ba yung complainant, wala pa? On the way, eh matatapos na to. So, desidido siya sa kaniyang complaint. For the record, the resource persons from Molino 1 submitted a folder containing records of complain file before their office by the complainant Mylene Remojo. So, ito po yung record Kap. ng proceedings?"

COUN. REYNALDO PALABRICA "For the meantime wala muna kaming itatanong sa inyo, kasi wala pa yung complainant. Una kasi nating tatanungin ay yung complainant eh kailangan niya ipaliwanag. So, for the record purposes and correction hindi po ito Claro, Clarito po? Secretariat take note on the surname of the VAWC desk officer being complaint Cristina A. Claro dapat Cristina A. Clarito."

COUN. REYNALDO PALABRICA "Pwede po kayo magpakilala dito sa committee, paki banggit po ng pangalan, address at pakay dito."

MYLENE REMOJO "Ako po si Mylene Remojo po, nakatira po sa B2 L29, Bayanan Bacoor, Cavite po."

COUN. REYNALDO PALABRICA "Barangay Bayanan."

MYLENE REMOJO "Opo."





COUN. REYNALDO PALABRICA "So, I will remind you that always make it on time hindi tayo pedeng late dito dahil sunod sunod ang hearing dito. Please be reminded on that."

COUN. REYNALDO PALABRICA "Paki paliwanag nga po, pero bago ka mag paliwanag I will request to rise at manumpa po kayo sa harap ng committee."

COUN. REYNALDO PALABRICA "Nanunumpa na magsasabi ng katotohanan at pawang katotohanan lamang."

MYLENE REMOJO "Opo."

COUN. REYNALDO PALABRICA "Kasihan nawa kayo ng Diyos. Maupo na po kayo. Okay, kayo po ay nagcomplains sa Region IV-A sa human rights?"

MYLENE REMOJO "Opo."

COUN. REYNALDO PALABRICA "Kailan po iyon?"

MYLENE REMOJO "May 30 po ata."

COUN. REYNALDO PALABRICA "Ano po ang reklamang iyong inihain sa human rights Region IV-A office?"

MYLENE REMOJO "Tungkol po doon sa VAWC officer na nilapitan ko sa may barangay Molino 1 po."

COUN. REYNALDO PALABRICA "Taga Bayanan kayo, doon kayo nakatira?"

MYLENE REMOJO "Opo."

COUN. REYNALDO PALABRICA "Tapos ang kinausap niyo po ay taga Barangay Molino 1. Paki paliwanag nga po ang iyong reklamo."

MYLENE REMOJO "Kasi po yung time na pumunta po ako nung April 30 sa Molino 1 about po yun sa VAWC, tungkol po yun sa asawa ko para po sa financial support na kakailanganin namin at lahat po ng support na kinakailangan namin. Ngayon po nung April 30 po, nag ask po ako sa Molino 1 VAWC na pagharapin po kami ng asawa ko, pinasabi ko naman po doon lahat ng pangangailangan namin at kasama rin po doon sa attachment na inemail ko dun sa CHR yung lahat po ng napagusapan namin. Sinabi po nung VAWC yung napagusapan po namin doon is kailangan po maisatupad ng asawa ko, so meron din po dun sa letter ng harapan ng VAWC na magkakaroon po ulit po ng patawag from April 30 po hanggang sa umabot po ng May 30, wala po silang pangalawang patawag o text message. Ilang beses din po akong bumalik doon sa barangay, yun nga lang every time na babalik ako doon eh wala raw po doon yung tao,





yung VAWC doon sa may Molino 1. So bumalik po ako doon noong May 18 before mag May 30, May 29 po ata iyon o May 27, sabi po nila pumunta nalang po ako ng umaga, so nung May 30 nagpunta po ako doon ng bandang tanghali tapos po sinabi nga po yung nangyayare lahat po ng napagusapan po namin noong April 30 na wala nga po siyang tinupad. Ngayon nga po syempre po masama po yung loob ko, tinatanong ko rin po sila kung bakit po kumbaga hindi nila binigyan ng pangalawang patawag o update kasi sabi nga po nila may follow up para po doon sa patawag. Tapos sabi po nila bakit daw po hindi po ako pumunta doon para ipatawag yung asawa ko na hindi nga po na follow up.

MYLENE REMOJO "Ngayon po, nung May 30 sabi ko po kasi nga po medyo malaki na po yung gastusin namin, eh mas maliit po lalo yung binigay niya. Kaya sabi ko po doon eh bakit po ganun na yung asawa ko po para mas naging safe pa sa kanya na nagreklamo ako sa VAWC. Nagalit po sa akin yung VAWC doon at sinabi po sakín na "kung sa tingin mo nagiging bias kami sayo, mas maigi pa na sa iba mo na lang yan ilapit, idinidisregard na namin at hindi na kami tatanggap ng kahit anong reklamo mula sayo dito sa Molino 1. Hindi na namin tatanggapin."

MYLENE REMOJO "So para sakín po yung katuparan na magkaroon po sana ng hustisya yung ginagawa saamin ng asawa ko kasi hindi na rin po siya umuuwi doon, hindi na rin po siya nag susupport o gumagabay sa anak ko. Kahit ako lang mag isa, may part sakín na masakít kasi napabayaán kami. Tapos ganun pa po yung sinabi saamin ng VAWC na dinidisregard na dinidismis po kami."

COUN. REYNALDO PALABRICA "Sino po yung binabanggit po ninyong VAWC?"

MYLENE REMOJO "Si Cristina Claro po."

COUN. REYNALDO PALABRICA "Andito ba siya ngayon?"

MYLENE REMOJO "Opo, siya po yun."

COUN. REYNALDO PALABRICA "Okay. Please make it on record that the complainant identified the VAWC officer being mentioned to be Cristina Claro in fact Cristina Clarito. Sigé po tuloy po."

MYLENE REMOJO "Syempre dun po ako lumapit sa mas malapit saamin para matulungan ako. Tapos sabi po niya sakín na "baka gusto mo kasuhan pa kita eh. Gusto mo idemanda kita kasi pinagtataasan mo kami ng boses." To the point na sabi ko sa sarili ko na sana naiinitindihan niyo rin yung sitwasyon namin, kasi kung tutuusin kita niyo naman po yung sitwasyon ng anak ko and then parang kinecater pa po nila yung inaano nung lalaki, kumbaga okay lang sa kaniya."

MYLENE REMOJO "Ngayon po, yung text po sakín ng asawa ko na "bahala ka na, basta kung ano yung napagusapan natin doon yun lang yung kaya kong ibigay." Kahit inilapit ko po yun sa abogado pwede ko nga raw po iyon ipakita or ipresent yung dinemand ko na usapan namin nung una, na nagrerepresent na meron





kaming napagkasunduan kahit papaano. Dapat nga raw po naupdate po iyon sa may VAWC, sakin po kasi parang lalo po ako nadown nung time na yun kasi hindi ko po alam saan ako lalapit."

COUN. REYNALDO PALABRICA "Okay. So, paki bigyan nga ng water. Any question from the city council members present, question sa ating complainant?"

COUN. REYNALDO PALABRICA "So sa madaling sabi, base sa inyong pahayag nagkaroon kayo ng paghaharap ni VAWC officer?"

MYLENE REMOJO "Opo."

COUN. REYNALDO PALABRICA "Si Cristina Clarito, sa paghaharap ninyo nagkarating kayo sa kasunduan ng inyong asawa?"

MYLENE REMOJO "Hindi pa po, kasi sabi niya po doon sa kasulatan na yun nandun po yun sa xerox. Magkakaroon po ng final na agreement, na kailangan masunod muna yung mga nandun na nakasulat. So ilang beses po ako lumapit doon sa barangay kasi nga po hindi nga po niya tinutupad yung."

COUN. REYNALDO PALABRICA "So may binanggit po kayo kanina na parang napag kasunduan. So, ilang beses ba kayo nagkaharap sa Molino 1."

MYLENE REMOJO "Yung huli po nung May 30."

COUN. REYNALDO PALABRICA "Ilang beses? Ang tanong ko po ilang beses."

MYLENE REMOJO "Dalawa po."

COUN. REYNALDO PALABRICA "Dalawang beses. Una nagkaharap kayo walang napagkasunduan. Tapos pangalawang patawag, doon kayo nagkaroon ng kasunduan?"

MYLENE REMOJO "Hindi, unang paghaharap pa lang po meron na pong napagkasunduan, kung ano yung nirerequest o parang dinedemand ko sa kanya."

COUN. REYNALDO PALABRICA "Pumayag naman?"

MYLENE REMOJO "Yes po, pumirma po siya doon."

COUN. REYNALDO PALABRICA "Sa unang paghaharap pa lang, nagkaroon na kayo ng kasunduan."





MYLENE REMOJO "Opo."

COUN. REYNALDO PALABRICA "Para magkaroon ng amicable settlements base sa iyong reklamo sa barangay."

MYLENE REMOJO "Opo."

COUN. REYNALDO PALABRICA "Matanong ko lang po. Bakit po kayo sa Molino 1 nag complain samantalang taga Barangay Bayanan po kayo."

MYLENE REMOJO "Doon po kasi nakatira yung asawa ko."

COUN. REYNALDO PALABRICA "Ah doon nakatira. Ilang taon na ba kayong hiwalay?"

MYLENE REMOJO "Nasa buwan pa lang po, since last year po October po."

COUN. REYNALDO PALABRICA "Buwan pa lang pero doon na nakatira sa Molino 1?"

MYLENE REMOJO "Doon po siya umuwi sa nanay niya."

COUN. REYNALDO PALABRICA "Kasi tinatanong ko lang yung jurisdiction ng complaint based on rules of filing a complaint, barangay complains ay kung saan nakatira yung respondent eh doon ang complain hearing. So tama naman po yung ginawa niyo, na nagpunta kayo ng Molino 1 at doon kayo nag file ng complaint."

COUN. REYNALDO PALABRICA "Sa unang patawag, kelan nag ho yun. Nung nagkaroon kayo ng kasunduan, anong petsa ho yun?"

MYLENE REMOJO "April 30 po."

COUN. REYNALDO PALABRICA "Yung pangalawang patawag na binabanggit niyo po kanina?"

MYLENE REMOJO "May 30 po."

COUN. REYNALDO PALABRICA "After a month. So, after a month nagkaharap ulit kayo?"





MYLENE REMOJO "Yes po."

COUN. REYNALDO PALABRICA "Sa paghaharap ninyo, ano po ang napagusapan po ninyo doon?"

MYLENE REMOJO "Pinagmamatigasan niya po na kung ano lang po yung ibibigay niya eh ayun lang po yung tatanggapin ko."

COUN. REYNALDO PALABRICA "So ayaw niyang tuparin yung unang kasunduan?"

MYLENE REMOJO "Yes po."

COUN. REYNALDO PALABRICA "Dito sa binigay niyong file, nandirito ba yung kasunduan?"

COUN. REYNALDO PALABRICA "Gumamit ba kayo ng amicable settlement form?"

COUN. REYNALDO PALABRICA "Ang nandito is yung complaint eh yung sumbong, meron kayong kopya ng kasunduan?"

MYLENE REMOJO "Wala pa nga pong kopya ng kasunduan record pa lang po nilagay."

COUN. REYNALDO PALABRICA "Record? Blotter?"

MYLENE REMOJO "Sa record book pa lang po nakalagay yun."

COUN. REYNALDO PALABRICA "Meron kayong kopya dyan? Patingin nga po wala po kami dito eh. Please make it on record that the respondent Cristina Clarito submitted and presented a document containing the amicable settlement between the complainant Mylene Remojo against her husband Renan."

COUN. REYNALDO PALABRICA "Renan Remojo, kasal po kayo?"

MYLENE REMOJO "Yes po, meron po akong marriage contract dito po."

COUN. REYNALDO PALABRICA The committee orders the respondent to submit a clear copy medyo zoom copy ng sinubmit ninyo for perusal of this honorable committee. Before the next hearing na lang."





COUN. REYNALDO PALABRICA "Meron pa po kayong gsutong sabihin ma'am? So ibig sabihin dalawang beses kayo nagkaharap. Unang paghaharap nagkaroon kayo kasunduan, naaalala niyo ito?"

MYLENE REMOJO "Kasi nakalagay po dyan na after April 30 ipapatawag po kami sa susunod na Linggo."

COUN. REYNALDO PALABRICA "Please make it on record that the complainant submitted 3 copies of document. Number 1 is sumbong, second is the settlement, and the second page of the settlement, third is document."

COUN. REYNALDO PALABRICA "Blotter ito, hindi pa ata kasunduan ito. Hindi pa ito settlement eh. Wala bang dokyument na pinirmahan yung Renan. Ah, ito Renan Remojo."

COUN. REYNALDO PALABRICA "Inirerequest din ni Mylene Remojo na sana magbigay ng support para sa education. Number 7 marami pang demand si Mylene Remojo. Muli sila ipapatawag sa mga susunod na Linggo."

COUN. REYNALDO PALABRICA "Okay so nakapirma naman dito si Renan, so ang gusto po ninyo maaksyunan po iyong reklamo po ninyo?"

MYLENE REMOJO "Yes po. Kasi nangungupahan po kami ng bahay, actually yung deposito po namin doon nagamit na po namin kasi kulang po yung pinapadala niya po saamin. Ngayon po kung tutuusin parang pinagbibigyan na lang po kaming mag stay doon sa bahay na inuupahan namin, kasi wala na kami halos pambayad. Kaya po ako lumapit sa CHR kasi dahil nga po doon sa sinasabi niya na nagbibigay siya, yung binibigay niya po kulang talaga. Kasi nung tumira po kami doon sa inuupahan namin, hindi po talaga buo yung deposito namin."

COUN. REYNALDO PALABRICA "Gusto ko lang po ipaunawa sa inyo na ang trabaho kasi ng barangay is to settle the disputes, amicably pagkasunduin kung ano man ang namamagitan. Ngayon pagka di nagkasundo o nagkaroon ng kasunduan at sadyang di tinupad ayun yung settlement was repudiated o di napatupad ng inirereklamo. Kasunod noon ay pwede mo siyang filelan ng kaso sa korte. So, ang pinaka problema dito ay suporta ng asawa, nadagdag lang to kaya mo nirereklamo dahil gusto mo maaksyunan."

MYLENE REMOJO "Opo. Tsaka gusto ko po kasi na yung binitawan niyang salita na hindi na raw po ako makakalapit kahit kailan or di na raw po ako magkakapag file ng kahit anong reklamo sa Molino 1."





COUN. REYNALDO PALABRICA "Kaya ang pakiramdam mo tuloy ay parang kinakampihan ng Molino 1 yung asawa mo?"

MYLENE REMOJO "Parang pinag co-closan po ako ng pinto."

COUN. REYNALDO PALABRICA "Hindi maaari yun, ang gagawin po natin according to rules ng katarungan pambarangay, ang pinaka mainam na gawin ay yung ayusin na lang natin yung problema. Dahil medyo mahirap yung sitwasyon ninyo, lalo na kung hindi sapat yung binibigay ay mamomroblema talaga kayo."

COUN. REYNALDO PALABRICA "Dapat dito kasuhan niyo na sa korte to. So, ganito na lang gawin natin, okay lang ba kung ayusin na lang natin dito."

MYLENE REMOJO "Ako willing naman po ako na. Ayoko nga po umabot sa ganito, kaso nga lang po kasi nung time na nagbitaw sila ng salita saakin feeling ko po eh nawalan po ako ng karapatan."

COUN. REYNALDO PALABRICA "Tutulongan po namin kayo na maibalik ho ang inyong karapatan sa pamamagitan ng kagalang galang na komite na ito. Ang gagawin po natin ay oorderan po natin ang respondent, ayusin na lang ho natin noh, kasi dito naman ho sa Sangguniang Panlungsod there is always an option for amicable settlements yung tinatawag natin na ibang proceedings, legal proceedings. Ngayon kung dalawang kaso ang aasikasuhin mo lalong sasama at sasakit ang ulo mo, tumbukin na natin ang problema mo, pagtulong tulungan na lang natin. Sangguniang Panlungsod tsaka sa barangay, okay lang ho ba sainyo yun?"

MYLENE REMOJO "Yes po. Okay lang po saakin."

COUN. REYNALDO PALABRICA "Ganito po gagawin natin, oorderan natin ang VAWC ng Molino 1 na muli sila pagharapin within this week, pagharapin na agad yan. By the order of this honorable committee, the VAWC officer of Molino 1 is being ordered to a personal confrontation between disputing parties within this week. Next week na lang, Mondays to Fridays."

COUN. REYNALDO PALABRICA "Also the VAWC officer ordered that any amicable settlements between the two disputing parties should be written in the amicable settlement forms of katarungan pambarangay and both parties should be furnished by copies certified true copies of that particular amicable settlements





form. If ever any settlements be reached by two parties repudiated by the respondents yung asawa niyo po. The VAWC are ordered to issue certificate of file action immediately, so that justice will not be delay, okay. Naiintindihan po natin? Next week inoorderan kayo na mag conduct ng committee hearing paghaharap at anuman ang mapagkasunduan maabot nila pareho ay ilagay sa amicable settlement form, papirmahan sa kanilang dalawa at picturan, ireport saamin. Picturan yung proceedings at magsubmit ng copy ng dokumento dito saamin. Tapos pag hindi tinupad yan, Kap. you are being ordered to issue certificate of file action, kasuhan mo na yan, pakulong mo na yan pagka ano. Hindi dapat ganyan ang nangyayare."

MYLENE REMOJO "Ayun nga po yung minemessage niya sakín na nagaantay lang po siya na may mag warrant of arrest. Kumbaga parang nagmamalaki po siya."

COUN. REYNALDO PALABRICA "Edi subukan natin pag may warrant of arrest na kundi nanginig pati ang buto niyan. Anyway, okay na tayo doon ma'am? Ang record natin dito sa committee ay nagkasundo na ang dalawang panig na ipatupad ang proceedings ng katarungan pambarangay been supervised or monitored by this Sangguniang Panlungsod."

COUN. REYNALDO PALABRICA "Okay na po sa inyo yun?"

MYLENE REMOJO "Okay po yun saakin."

COUN. REYNALDO PALABRICA "Hindi ko na kayo pagsasalitain, inoorderan na kayo na yun ang gagawin natin. Okay na po sa inyo yun ma'am?"

MYLENE REMOJO "Okay na po."

COUN. REYNALDO PALABRICA "Any motion for adjournment? It has been moved by Councilor Bok Nolasco that this complaint hearing be adjourned, any second to the motion?"

COUN. ALEJANDRO GUTIERREZ "Pumapangalawa po ako."

COUN. REYNALDO PALABRICA "Seconded, therefore this hearing is now adjourned."

As Gender Umbod of the country under Republic Act 9710 otherwise known as the Magna Carta of Women, and pursuant to the Constitutional mandate under Article XIII, Section 18 of the 1987 Constitution to "Request the assistance of any department, bureau, office or agency in the performance of its functions," the Commission on Human Rights, Regional Office IV-A took cognizance of the case of **"MYLENE REMOJO y FERMANES"**, regarding the alleged domestic and economic abuse by her husband which is a violation on Republic Act 9272 otherwise known as the Anti-Violence Against Women and Their Children Act of 2004. This case was docketed as CHR Case No. 4A-2024-0276.

According to the email-complaint before this Office, the alleged domestic and economic abuse was reported before the **Barangay Molino I** on April 30, 2024. However, according to Ms. Remajo, the complaint was neglected by a **Barangay VAWC Desk Officer named Cristina A. Claro**.

In this regard, we respectfully **REFER** the instant complaint to your good office in your capacity as the Presiding Officer of the Sangguniang Panlungsod for the initiation of administrative sanctions against Ms. Claro as may be warranted under the circumstances.
