### COMMITTEE REPORT

CHS-PCR-614-2024

Subject: *A resolution authorizing the City Mayor, Hon. Strike B. Revilla, to sign a Memorandum of Agreement with the Foundation of Our Lady of Peace Mission, Inc. to render outpatient cataract surgery services to indigent Bacoor residents.*

(PCR-614-2024: Date referred: July 8, 2024)

The above-mentioned proposed resolution underwent its first reading on July 08, 2024 during the 98<sup>th</sup> Regular Session of the Sangguniang Panlungsod. The said proposed resolution was referred by the Acting Presiding Officer, City Councilor Hon. Reynaldo C. Palabrica to the Committee on Health and Sanitation.

The Committee on Health and Sanitation sent out invitations to the resource persons and conducted a committee hearing on July 11, 2024 at the Session Hall of the Sangguniang Panlungsod.

#### FINDINGS:

Endorsement Letter No. 757 series of 2024 dated June 24, 2024 issued by the Office of the City Legal Services relative to the Memorandum of Agreement with Foundation of Our Lady of Peace Mission, Inc (FOLPMI) was endorsed to the office of the Sangguniang Panlungsod for appropriate action.

During the conducted committee hearing, representatives from the FOLPMI was given time to explain before the Honorable Committee their intent to render outpatient cataract surgery services to indigent Bacoor residents through the Vision Project.

The resource persons from the City Government of Bacoor raised their questions, concerns and suggestions regarding the Memorandum of Agreement submitted by FOLPMI to the office of the City Mayor.





The Honorable Committee through its chairman gave their gratitude for the attendance and intention of the FOLPMI to cater cataract surgery services to the indigent Bacoor residents and further said that the Honorable Committee will further discuss and study the submitted Memorandum of Agreement during their committee meeting and will consult with concern departments regarding their suggestions.

#### RECOMMENDATION:

After a thorough review of all the circumstances and statements from the resource persons, the Committee found out that the Memorandum of Agreement submitted by FOLPMI is disadvantageous to the City Government of Bacoor and respectfully recommends that the Sangguniang Panlungsod disapprove the above subject matter.


By the motion of Hon. Reynaldo C. Palabrica duly seconded by all the members of the Sangguniang Panlungsod, the above subject matter was **DISAPPROVED** during its 101<sup>st</sup> Regular Session.

**COUN. REYNALDO C. PALABRICA** "Committee hearing regarding proposed resolution authorizing the City Mayor, Hon. Strike B. Revilla, to sign a Memorandum of Agreement with the Foundation of Our Lady of Peace Mission, Inc. to render

**COUN. REYNALDO C. PALABRICA** "For the record, present in this committee hearing are the honorable members of the city council from district two, honorable councilor Bok Nolasco."

**COUN. ROGELIO NOLASCO** "Mr. Chair, good morning po sa ating lahat."

**COUN. REYNALDO C. PALABRICA** "From district one, honorable councilor Levy Tela."

**COUN. REYNALDO C. PALABRICA** "From district two, honorable councilor Simplicio Dominguez."

**COUN. REYNALDO C. PALABRICA** "From district one, former general councilor Alex Gutierrez."

**COUN. REYNALDO C. PALABRICA** "May I request again the resource persons present, that they, for the record, introduce themselves and their representations."

**ATTY. SALVE VALENCIANO** "Mabuhay po, Bambi Valenciano from the City Legal Services."

**COUN. REYNALDO C. PALABRICA** "Thank you."

**DRA. IVY MARIE C. YRASTORZA** "Good morning po, doctora Ivy Marie Yrastorza from the Office of City Health Offices."

**COUN. REYNALDO C. PALABRICA** "Thank you, doc. Again, the CSWD."

**RICCA O. CLAPIT** "Good morning po, Ms. Ricca Clapit, Social Worker from CSWD Office."

**COUN. REYNALDO C. PALABRICA** "Thank you. Yes sir?"

**COUN. REYNALDO C. PALABRICA** "Thank you. Yes sir. Next po."







**SR. EVA FIDELA MAAMO** "Good morning po, sister Eva Fidela Maamo, I'm the president of the Foundation of Our Lady of Peace Mission, and we have a hospital, Our Lady of Peace Hospital, here in Parañaque."

**COUN. REYNALDO C. PALABRICA** "Thank you, mother. Next po."

**JULIUS ESTRADA** "Good morning po, Julius Estrada, Medical Social Worker of Our Lady of Peace Hospital."

**COUN. REYNALDO C. PALABRICA** "Thank you, sir. Next."

**ROVIE ROSE A. JOSE** "Good morning po, Rovie Rose Jose, from Our Lady of Peace Hospital, assistant of sister Eva."

**COUN. REYNALDO C. PALABRICA** "Thank you."

**COUN. REYNALDO C. PALABRICA** "So the Our Lady of, the foundation of Our Lady of Peace Mission Incorporated will partnering the local government unit of Bacoor in regards to cataract operations of our indigent residence. So, would you please enlighten the committee sir, papaano po ang sistema natin."

**JULIUS ESTRADA** "Ang foundation of Our Lady of Peace Mission mayroon siyang Eye center, so, we cater some private cases and through the foundation of Our Lady of Peace Mission, we also cater indigent patients, at discounted cost. So, we wrote to the office of the mayor, to proposed a project, with beneficiaries which are indigent patients. We proposed to make our facilities available for these patients. We wrote to mayor and told them that, to the office, we can cater residence, indigent patients of Bacoor City, especially those elderly having problems with vision, so, they can enroll to the project, the city government allocate budget to pay the cost, the discounted cost of their surgery. So, parang ganun."

**COUN. REYNALDO C. PALABRICA** "Okay po. We will go directly to the responsibilities of the parties, in the propose MOA submitted to this council. So, the responsibilities of the parties specifically the city, the local government of Bacoor, ito po ang nakalagay. Identify eligible project beneficiaries, so yung mga possible patients; Conduct liat assessments; Provide identified patients with serialized number of referral letter to be presented to FOLPMI for outpatient department assessment; Enroll eligible patients in PhilHealth, if they are not enrolled; Refer eligible beneficiaries in need of cataract surgery to FOLPMI for evaluation and





treatment; Coordinate with the FOLPMI to conduct patient education before the actual surgery; Provide transportation to qualified patients going to FOLPMI Hospital for OPD assessment and conduct of surgery; lastly, coordinate with FOLPMI for overall implementation of the project."

**COUN. REYNALDO C. PALABRICA** "Dito po, so kami ang mag iidentify kung sino. Naturally naman ay ang LGU, kami rin ang magdadala sainyo, magkano po ang babayaran namin saibyo?"

**JULIUS ESTRADA** "Our package for surgery is sixteen thousand pesos, and we discussed it with the Office of the City Social Welfare Development Office, initially we told them we can cater or willing to commit fifty patients for the surgery.

**COUN. REYNALDO C. PALABRICA** "Fifty patients per month?"

**JULIUS ESTRADA** "Fifty for the whole project."

**COUN. REYNALDO C. PALABRICA** "Gaano po katagal itong project? Is this one-time project? Or is this continuous project?"

**JULIUS ESTRADA** "A one-time six months duration. From July to December, targeting about fifty patients."

**COUN. REYNALDO C. PALABRICA** "Fifty patients. May babayaran po ba ang city government?"

**JULIUS ESTRADA** "Yes po, the cost of the surgery."

**COUN. REYNALDO C. PALABRICA** "How much will be the cost sir?"

**JULIUS ESTRADA** "Sixteen thousand per patients."

**COUN. REYNALDO C. PALABRICA** "Sixteen thousand per patients? Doctora, mayroon ba tayong Eye clinic? Nag ooperate ba ang Eye clinic natin?"

**DRA. IVY MARIE YRASTORZA** "Currently, we have two ophthalmologist po, conducting and consulting in our Eye center."

**COUN. REYNALDO C. PALABRICA** "Mayroon kasi kami naging patient taga doon sa barangay ko mismo. Inendorse ko sayo diba? Pinapunta daw doon sa Eye







clinic natin, libre yung cataract operation, tapos libre ang lente, tapos ang binayaran lang sa prep? Ano nga tawag doon?"

**DRA. IVY MARIE YRASTORZA** "Ano po, assessment po, pre-screening po niyan, halimbawa kung may laboratory."

**COUN. REYNALDO C. PALABRICA** "Kung may ganun, ang ginastos lang hanggang sa nag cataract operation siya ay six thousand pesos. So, parang mas mahal ito sir."

**JULIUS ESTRADA** "Considering that this is a private eye center, our doctors are also, are private practitioners. Recovery lang ito ng medicines and supply kailangan,"

**COUN. REYNALDO C. PALABRICA** "If the patients within the six months' time minimum, times sixteen thousand, may pera pa ba tayo?"

**DRA. IVY MRE YRASTORZA** "Doon po ba sa sixteen thousand is less or deducted na yung PhilHealth nila?"

**COUN. REYNALDO C. PALABRICA** "Ang nakalagay naman doon sa proposed MOA, if ever na hindi PhilHealth member, tayo ang may responsibility, ang LGU para ma enroll natin ang patients. So, okay po lang po sainyo ang PhilHealth ang magbabayad ng sixteen thousand? Kinocover nga ba talaga ito? Sixteen thousand? Lahat? Lahat sixteen thousand?"

**DRA. IVY MARIE YRASTORZA** "Nag aadditional payment lang ang patients, halimbawa po yung lente, kailangan po nila is special."

**COUN. REYNALDO C. PALABRICA** "Ano yun, may progressive?"

**DRA. IVY MARIE YRASTORZA** "May mga lente po kasi na mas gusto ng pasyente branded or mas mahal, so nagdadagdag sila talaga yung mga pasyente for the lenses."

**COUN. REYNALDO C. PALABRICA** "Ah okay. Naintindihan na natin."

**COUN. REYNALDO C. PALABRICA** "So kung cover ng PhilHealth okay naman yun sainyo? Kung ang PhilHealth ang magbabayad?"

**JULIUS ESTRADA** "Actually, may PhilHealth may counterpart na po, that's why."





**COUN. REYNALDO C. PALABRICA** "Kaya sixteen thousand lang? So, meaning sir, halimbawa ako, papacataract surgery ako sainyo, tapos ako'y hindi pa PhilHealth member, kailangan kong magpa member kasi para yung counter part ng PhilHealth doon sa sixteen thousand, or ang sixteen thousand labas na doon yung PhilHealth counterpart?"

**JULIUS ESTRADA** "On top of the PhilHealth ba yan?"

**COUN. REYNALDO C. PALABRICA** "On top of the PhilHealth. Malinaw po yun. On top of Philhealth, kung PhilHealth member, sixteen thousand pa rin ang babayaran natin. CSWD, what's your reaction about this?"

**RICCA O. CLAPIT** "Yes po your honor, I concern po muna namin, hindi rin po namin alam yung sa fund po namin, kasi sa AICS rin po siya namin kukuhanin."

**COUN. REYNALDO C. PALABRICA** "Yun nga mismo."

**RICCA O. CLAPIT** "Yes po and siguro we will finalize with ma'am Lillian, kung mag agree po doon sa sixteen thousand, kasi based po doon sa kinompyut, parang nasa forty-eight patient lang po itong sixteen thousand, tama po ba? Doon sa computation, and then yung sa project stipend niyo po, nung kinompyut namin ay magigiging counterpart niyo lang po ay five thousand plus, tama po ba? Dito po sa project stipend po. Then clear lang po namin yung sa lump sum, eighty thousand, ano po yung explanation po ba dito, ma'am sa lump sum."

**COUN. REYNALDO C. PALABRICA** "Mayroon kayong proposal galing sa kanila? Wala kami rito."

**RICCA O. CLAPIT** "Ay wala po ba?"

**COUN. REYNALDO C. PALABRICA** "Wala kami rito, ay sige okay lang na ikaw na magtanong. Okay lang, we will adhere to the questions or inquiries."

**JULIUS ESTRADA** "Ano po ulit? Paki ulit po nung tanong ma'am."

**RICCA O. CLAPIT** "Yun pong sa project staff stipend na proposal, bale nung kinompyut namin siya, sa forty-eight na clients, lalabas po doon five thousand lajng po ang counterpart ng inyong foundation, tama po ba?"







"Yes po, yung project staff yun po yung counterpart po namin, pati yung lump sum na pang office supplies kasi, actually the PF there, counterpart pa rin, we are not charging the professional fees of the doctor."

**RICCA O. CLAPIT** "Ah okay po, doon po sa sixteen thousand, included din po doon yung sa PF?"

**COUN. REYNALDO C. PALABRICA** "On top daw e. Yung sa sixteen thousand."

**JULIUS ESTRADA** "Lahat na po iyon."

**RICCA O. CLAPIT** "Ah okay po."

**JULIUS ESTRADA** "Wala PF doon."

**RICCA O. CLAPIT** "Ah okay po, so package na po yun?"

**JULIUS ESTRADA** "Package na po."

**RICCA O. CLAPIT** "So, we will clarify kay ma'am Lillian, kung if mag aagree doon sa sixteen thousand per patient."

**COUN. REYNALDO C. PALABRICA** "Ito ba yung project brief, the same document na mayroon tayo? Nakakuha na ako e, ito rin ba yun? Ayun ito, parehas. Thank you., parehas ata e."

**COUN. REYNALDO C. PALABRICA** "It is also proposed by the foundation, your representation, that the LGU shall allocate funds of the total cost of the project, is it correct?"

**JULIUS ESTRADA** "Yes sir."

**COUN. REYNALDO C. PALABRICA** "Also the LGU shall be responsible for finding at least two hundred of the target cases by conducting information, dissemination, in all the barangays."

**JULIUS ESTRADA** "That's the overall from inclusive screening, so from the screen patients of two hundred, we will get fifty that will be operated."

**COUN. REYNALDO C. PALABRICA** "Ah okay. Naintindihan po namin iyon."





**COUN. REYNALDO C. PALABRICA** "The LGU shall make a master list of the two hundred cases found identified by the foundation. A copy of the list of identified cases of patients, yun nalang ang irerefer. The LGU shall should be responsible for instructing identified patients on how, kami ang bahala, LGU din. Paano pupunta doon at babalik kailan. The LGU shall provide the serialized number referral letter presented, dito na yun sa procedure ng hospital, ng clinic ninyo. The LGU shall provide transportation for patients going to the foundation or to the hospital for assessment. So yun yung mga, in totality, how much it will cost of this project? Assuming we have fifty qualified patients."

**JULIUS ESTRADA** "The total project cost for the fifty, for all the inclusive screening is eight hundred eighty-one thousand pesos."

**COUN. REYNALDO C. PALABRICA** "Fifty patients?"

**JULIUS ESTRADA** "Pati ba yung isscreen?"

**COUN. REYNALDO C. PALABRICA** "Pati yung screen, pero ang iquaqualify lang natin only fifty. Out of eight hundred thousand, eight hundred thousand pesos divided by fifty, parang lalabas forty? sixteen thousand? Ah yun na yun."

**COUN. REYNALDO C. PALABRICA** "Any other questions from the members of the council? May tanong kayo general? Councilor Dominguez? Finance committee chairman? Pera ang kailangan dito. Yes doc, any questions?"

**DRA. IVY MARIE YRASTORZA** "Bakit niyo po kailangan na kami ang maghahanap, kumbaga parang mangyayari ay hahakot po ang gagawin natin? Instead na halimbawa, if may nangagailangan ng cataract operation and then refer nalang po sila doon sa facility?"

**COUN. REYNALDO C. PALABRICA** "Ipapasagot natin, pero sa pagkakaintindi ko kanina, six months ito, so in six months' time, may two hundred tayong maipadadala, fifty lang ang mag quaqualify and we will pay eight hundred thousand."

**DRA. IVY MARIE YRASTORZA** "Since may transportation, so it is implied na paramihan ang ipapadala natin, sayang naman yung gagastusin natin sa gas kung paisa-isa yung pagpapadala natin."







**COUN. REYNALDO C. PALABRICA** "lipunin muna natin yung mga possible beneficiaries natin, tama po ba?"

**JULIUS ESTRADA** "Opo. ang ano po kasi, may time frame tayo, parang may beginning at end. So may stage tayo na we gather the patients, for initial, if you want, we assigned per barangay or cases kaysa lalapit sa health worker or DSWD, kung may problema siya sa ano, ililista."

**COUN. REYNALDO C. PALABRICA** "So scheduled nalang ang pagdala. Parang mass screening and mass operation ganun. In six month's time yun. Medyo may pagkakaiba yung current practice namin, kasi pag may dumating sa city health office or CSWD, will automatically referred to the health clinic of the city. Then ipaprocess na doon and will be scheduled na yung cataract operation after medical screening."

**JULIUS ESTRADA** "This is just my suggestion sir, what will be the pleasure of the city, we can modify."

**COUN. REYNALDO C. PALABRICA** "Okay so, any other questions? May tanong pa? sir halos naitanong na namin sainyo ang lahat, salamat po sa pag punta dito, sa pag offer ng serbisyo sa local government ng Bacoor, we really appreciate your proposal and your intention to help our indigent residence, maraming maraming salamat po. Pag-aaralan po ng committee as mentioned earlier, during our first hearing that this proposal will be discussed again by the committee during our committee hearing. We will consult the concerned departments kung anong mga inputs pa na puwede ibigay sa amin, and the committee will be submitted a committee report to the city council, for the recommendation and the city council ultimately decide to this matter. But again, maraming marami salamat po. We really appreciate your intention to help our indigent residence. Maraming salamat. And may I ask the motion for the adjournment."

**COUN. ALEJANDRO GUTIERREZ** "Mr. Chair, since there is no other matter and special concern to be discussed, I moved for the adjournment of this morning hearing."

**COUN. REYNALDO C. PALABRICA** "It has been moved by honorable General Alex Gutierrez, that this hearing be adjourn, any second to the motion, any objections? hearing none, therefore, this committee hearing is now adjourned."






The **CITY GOVERNMENT OF BACOR**, a local government unit created and existing under the laws of the Republic of the Philippines, with principal office address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Province of Cavite, represented herein by its City Mayor, **HON. STRIKE B. REVILLA**, pursuant to his authority conferred and embodied in City Resolution No. \_\_\_, and hereinafter referred to as the "**CITY**"

and

The **FOUNDATION OF OUR LADY PEACE MISSION, INC.**, a non-stock non-profit organization duly organized and existing under the laws of the Republic of the Philippines, with principal business address at Coastal Road, San Dionisio, Paranaque, Metro Manila, represented herein by its Founder/Chairperson Emeritus, **SR. EVA C. MAAMO, MD**, hereinafter referred to as "**FOLPMI**"

"**PARTY**" shall mean either the **CITY** or **FOLPMI**, if applicable, while the term "**PARTIES**" shall mean **CITY** and **FOLPMI**, collectively.

#### WITNESSETH:

WHEREAS, under the Local Government Code, the City Mayor is mandated to ensure the delivery of basic services, including health services;

WHEREAS, the **CITY** is dedicated to improving the health and welfare of its inhabitants, with a focus on addressing growing concerns on vision-related issues such as cataracts, especially among the elderly;

WHEREAS, the Foundation of our Lady of Peace Mission, Inc. – Our Lady of Peace Hospital is a private charity hospital that caters to neighboring cities of Las Pinas, Paranaque, Bacoor City, and other nearby municipalities and cities in Cavite;

WHEREAS, numerous indigent residents of Bacoor City suffering from cataracts have sought financial assistance from the **CITY** for the treatment of their vision-related problems;

WHEREAS, the **FOLPMI** has been providing high-quality medical services, including cataract surgery, to individuals in need;

WHEREAS, the **CITY** recognizes the necessity of partnering with a service provider to offer cataract surgery services to indigent Bacoor residents in need, thereby helping them become more productive and/or require less or no assistance at all once their vision has improved;

WHEREAS, the **CITY** and the **FOLPMI** have expressed their commitment to assist indigent Bacoor residents suffering from cataracts by providing free eye surgery through the "Vision Project"

WHEREAS, Department of Social Welfare and Development Memorandum Circular No. 16-2022 provides guidelines for the implementation of Assistance to Individuals in Crisis Situation (AICS), which includes medical assistance in the form of cash or guarantee letters provided to qualified beneficiaries or through service providers;

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties agree as follows:

**1. PROJECT DESCRIPTION**

Through this Vision Project, the FOLPMI shall render outpatient cataract surgery services to indigent Bacoor residents who are in need of such services. These services include diagnostic laboratory tests as necessary

**2. RESPONSIBILITIES OF THE PARTIES**

**A. The CITY shall:**

- Identify eligible project beneficiaries in coordination with barangays and make a master list of possible cataract cases in the City of Bacoor.
- Conduct client assessments to verify their financial incapacity to finance the eye surgery, thus necessitating project assistance
- Provide the identified patients with serialized numbered referral letters to be presented to the FOLPMI for an outpatient department (OPD) assessment.
- Enroll eligible patients in PhilHealth if they are not yet enrolled
- Refer eligible beneficiaries in need of cataract surgery to the FOLPMI for evaluation and treatment.
- Coordinate with the FOLPMI to conduct patient education before the actual surgery
- Provide transportation to qualified patients going to the FOLPMI hospital for OPD assessment and conduct of surgery
- Closely coordinate with FOLPMI for the overall implementation of the project.

**B. The FOLPMI shall:**

- Receive patients upon presenting the referral letter from the CITY and validate their names from the master list provided by the CITY.
- Direct patient to the OPD for documentation and subsequent assessment.
- Assess the eligibility of referred patient depending on their eye condition and overall health, and conduct physical examination to determine their readiness for surgical operation.
- Inform the qualified patients of further instructions or of succeeding scheduled operations.
- Provide high-quality outpatient cataract surgery services to patients referred by the CITY.
- Administer appropriate treatment, including pre-operative evaluations and post-operative care.
- Conduct detailed follow-up evaluations of the patient after surgery, documenting their medical history and progress.
- Maintain close communication and coordination with the CITY for progress reporting and overall implementation of the project.

- 3. CONFIDENTIALITY.** The Parties agree to maintain the confidentiality of any personal information between the CITY and the FOLPMI shared during the training

sessions and implementation of this Agreement. Processing of patient's data must be in accordance with the guidelines set forth under the Data Privacy Act (R.A. 10173).

4. **ENTIRE AGREEMENT.** This Agreement constitutes the entire agreement between the parties concerning the subject matter hereof.
5. **AMENDMENTS AND MODIFICATIONS.** This Agreement may not be amended, modified, or supplemented in any manner, whether by course of conduct or otherwise, except by an instrument in writing specifically designated as an amendment hereto, signed on behalf of each party.
6. **TERMINATION.** Either party may pre-terminate this Agreement upon 30 days' written notice to the other party for violation of any provision of this Agreement or upon mutual consent of the Parties.
7. **EFFECTIVITY.** This Agreement shall take effect upon signing by the Parties shall remain in effect until 31 December 2024. This Agreement shall be subject to renewal after its expiry, unless either party gives notice of its intention not to renew, at least 30 days prior to expiration.
