This report resolves the letter of complaint filed by Ms. Jonalyn G. Plazuela against Punong Barangay Alfredo Arevalo of Barangay San Nicolas 3 dated June 20, 2024. The said complaint was referred to the Committee on Ethics, Appointments and Government Re-Organization by the Sangguniang Panlungsod Acting Presiding Officer, City Councilor Hon. Reynaldo C. Palabrica, on July 08, 2024.

The Committee on Ethics, Appointments and Government Reorganization sent out invitations to the resource persons and conducted a committee hearing on July 11, 2024 at the Session Hall of the Sangguniang Panlungsod.

FINDINGS:

During the committee hearing, the Presiding Officer, Hon. Reynaldo C. Palabrica gave the complainant the time to explain before the Honorable Committee, the nature of her complaint against the respondent, Punong Barangay Alfredo Arevalo of Barangay San Nicolas 3.

The complainant, Ms. Plazuela manifested her withdrawal of the complaint and further explained that she and the respondent PB Arevalo have already settled their dispute. The Honorable Committee took note of her manifestation and further dismissed the case.

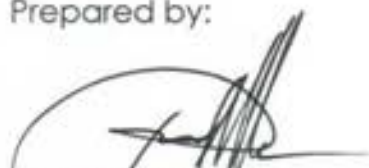
JONALYN PLAZUELA "Opo."

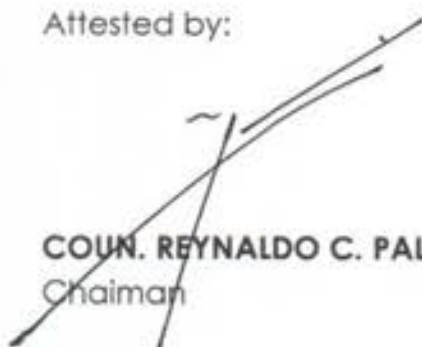
