Subject: A resolution authorizing the City Mayor, City Treasurer, City Assessor, and directing the Office of the City Legal Office and all the lawyers assigned thereto or engaged therewith to file and prosecute the appropriate legal actions against persons and entities, including real estate developers for failure to pay the appropriate real property taxes, and to file a collection suit with preliminary attachment for the same purpose.

(PCR 627-2024: Date referred: July 22, 2024)

The above-mentioned proposed resolution underwent its first reading on July 22, 2024 during the 100th Regular Session of the Sangguniang Panlungsod. The said proposed resolution was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

The Committee on Rules and Privileges, Laws and Ordinances sent out invitations to the resource persons and conducted a hearing on August 09, 2024, 10:30 a.m. at the Session Hall of the Sangguniang Panlungsod.

FINDINGS:

Pursuant to Section 5 of the 2013 Revenue Code of the City of Bacoor provides that a real property tax shall be imposed upon all real properties, including but not limited to lands, machineries, and other improvements located in the City of Bacoor.

It has been reported by the City Treasurer that there is a significant increase in the number of persons, entities, including real estate developers, who are owners of delinquent real properties. The City Treasurer has already sent several notices of delinquency to owners of delinquent properties.

The City Government has undertaken a multi-faceted approach as provided for by national laws, local ordinances, rules and regulations. Nevertheless, there are still many unpaid real property taxes due to the City.

COUN. REYNALDO PALABRICA "Thank you, magandang umaga."

COUN. REYNALDO PALABRICA "For the record, may I request the resource persons present to introduce themselves and their representation, we start with assessor."

ENGR. ALLAN C. QUINATADAN "Good morning, everyone, engineer Allan, from the City Assessor Department."

COUN. REYNALDO PALABRICA "Thank you very much."

ATTY. NATHANIEL DE LEON "Good morning your honor, Attorney Nathaniel De Leon from the Office of City Legal Services your honor."

COUN. REYNALDO PALABRICA "Thank you very much."

ATTY. BENEDICT V. VICTA "Good morning your honor, I'm Attorney Benedict Victa, respectfully appearing for City Admin Office."

COUN. REYNALDO PALABRICA "So, ang pag-uusapan natin dito ay tungkol din sa authority ng mag file tayo ng kaso, aalamin lang namin kung sino ba ang fifilean natin ng kaso? Sinong puwedeng sumagot?"

ATTY. NATHANIEL DE LEON "I believe your honor, there is a list coming from the Office of the City Treasurer your honor for those who have unpaid real property taxes, your honor."

COUN. REYNALDO PALABRICA "So general ito?"

ATTY. NATHANIEL DE LEON "Yes your honor, in general rin po sana yung request ng authority."

COUN. REYNALDO PALABRICA "So parang blanket authority ang hinihingi niyo?"

ATTY. NATHANIEL DE LEON "Yes, your honor. Kung kasi po hihingan pa namin ng isa-isa, madadamay pa yung."

COUN. REYNALDO PALABRICA "Marami ba ito engineer? Ang kakasuhan natin?"

ENGR. ALLAN C. QUINATADAN "Actually ito yung, mayroon nanaman tayong auction diba, nag aano ito sa common areas, usually po ito sa subdivision, yung mga kalsada, mga open spaces nila, dahil construction kasi hangga't hindi nila dinonate sa City Government, ay taxable po yun. Sa ngayon po kasi hindi sila nagbabayad, may isa silang inoauction parang hindi naman sila akma para doon dahil talaga namang destined na idonate sa atin. So parang nakikita ko dito sa atin, kakasuhan nalang natin sila para doon sa mga taxes na yun, then iaatach yung mga property nila na naka pangalan pa sa kanila as pambayad, parang ganun po."

COUN. REYNALDO PALABRICA "Ang mangyari kasi parang deliberately, hindi talaga binabayaran ng developer yung mga taxes ng kalsada, tapos hinihintay lang nila ma auction or ma forfeit ng, or hinihintay nila yung prescribe period para ma furnover sa gobyerno. So, kung kakasuhan ba natin sila, ano sa tingin mo ano ang implication nun?"

ENGR. ALLAN C. QUINATADAN "Actually ang ano, yung na deliberate dati, may mga involved na budget kasi na magfifile ng kaso ganun, sa collection ng ano, pero ang ano ko kasi talaga, parang lumabas kasi na optional on their part to donate, then deliberately, hind inga po nila binabayarran dahil alam po nila talaga na yun kasi ay hindi talaga sa kanila. Kahit nakapangalan sa kanila, mayroon po kasing naka annotate sa likod, na compliance for PD1215. So, yung compliance na yun ay characteristic nung mga property na yan ay kahit idonate dito sa city, ay hindi po pag mamay-ari ng city, dahil sa pag annotate. So ang beneficial user is yung mga HOA. So, hindi nila binabayaran deliberately nga, so

COUN. REYNALDO PALABRICA "Kasi hindi na nila mapapakinabangan na."

ENGR. ALLAN C. QUINATADAN "Hahabulin natin sila, kung may property pa sila na natitira sa kanila sa subdivision na yan, iaattach natin, para yun ang ipangbayad nila sa RPT."

COUN. REYNALDO PALABRICA "So, this is a form of strategy para makolekta tayo or ma forfeit sat mapasa atin yung existing property na hindi pa nabebebenta. So, itong pag fifile ng kaso, gaano na ba in terms of mga kalsada na pinaguusaspan, how many billions yan na collectible natin dito? Tingin ko laki na nito, walang nababayad niyan."

ENGR. ALLAN C. QUINATADAN "Actually, mayroon lang rin po sa batas na declared for the first time, ten years ang back taxes nun."

COUN. REYNALDO PALABRICA "Ten years."

ENGR. ALLAN C. QUINATADAN "Ngayon kung na declare na po natin kasi, mayroon ding disputed din na kaunti, five years. Iyan ang puwede natin singilin."

COUN. REYNALDO PALABRICA "Singilin."

ENGR. ALLAN C. QUINATADAN "Singilin sa kanila. Hindi naman, may mga iba ata silang, sinisingil talaga yun lahat. So medyo malaki, parang in case na ano rin, provision diyan, in case of fraud, ten years lang din."

COUN. REYNALDO PALABRICA "Kasi hindi nila kasalanan na hindi sila nagbayad kung hindi tayo naninigil. Yun ay may principle na ganun diba, attorney? Lapses ng gobyerno yung hindi paninigil kaya may period na hanggand doon nalang ang maximum na pasisingil ng isang gobyerno, may it be provincial or city. ATTY. BENEDICT V. VICTA "With regards to that issue na hangga't hindi po sila nagbabayad, hannga't hindi sila sinisingil, after coordinating with City Treasury Office, she told me that hindi sila naninigil dahil wala na po sila sa property. So, in effect the for leve cannot be transfer or we have difficulty collecting that, because wala po sila."

COUN. REYNALDO PALABRICA "Strategy din nila yun. Maglalgay sila ng business office during construction then after towards galis na sila, wala na tayong padadalhan ng sulat. Cannot be located na sila. Maganda yun, na buksan yan, kasi irerequire na natin yan, na residential address ng may-ari ang kukunin natin, upon the application ng development permit in the city, para walang kawala in the future. Ano sa tingin mo? Puwede no? puwede."

ATTY. BENEDICT V. VICTA "Yes your honor."

COUN. REYNALDO PALABRICA "Kasi maluwag sila, pag development permit, so kung anong naka declare na address yun lang pagkatapos na yung project, sibat na sila, wala na tayong hahabulin. Parang doon sa DOST developer, hindi na rin ma locate, kahit anong gawing investigation wala na. But anyway, ano sa tingin niyo may economic impact or upon doon sa mga developers? Kung magag fifile tayo ng kaso, ano sa tingin ninyo? May mga land areas na for development, so anong tingin niyong magiging impact nito sa mga developers?"

ENGR. ALLAN C. ENGR. ALLAN C. QUINATADAN "May exemption siya, kasi City Government na base lang doon sa donation na ginawa, na yung donation kasi kung anohin natin may kulang kaunti kasi wala ng certificate of completion ang karamihan nag donate."

COUN. REYNALDO PALABRICA "Hindi, ang nangyari kasi diyan, yung mga projects na nailalatag ng city government, kaya tayo na rin ang nag apura na I donate ng mga developers o Home Owners Association, yung mga road blocks na yan. Tulad noong binuo natin yung solidarity road, tayo na nga namwersa, kaya hindi na natin tinignan ang requirement na yun. Yun ang isa sa mga factors kung bakit sa tingin natin nagkaroon ng lapses. Pero pinapakinggan po namin yung suggestion niyo, para upon issuance ng development permit include natin yun, para walang gray area. COUN. REYNALDO PALABRICA "Kasi itong hinihingi nila blanket authority ito e."

COUN. ADRIELITO GAWARAN "Labas nila kung sinu-sino, at least alam natin, pagaralan natin, yung mga hindi nagbabayad."

COUN. REYNALDO PALABRICA "So, pag-uusapan ng committee ito, nirerequest nila is blanket authority, to those violators ng ordinances natin, automatic may authority sa atin na kasuhan sila. Sila na yung mag initiate, kasi may blanket authority ka. Yung manifestation ni Councilor Gawaran, kailangan malaman muna ng City Council kung sino ang kakasuhan, nako nga naman kung ang kakasuhan ay yung kapatid o pinsan mo."

COUN. REYNALDO PALABRICA "What is your opinion about this? Kahit sino sa inyong dalawa."

ATTY. NATHANIEL DE LEON "Your honor, we submitted po in today's session po of the Sangguniang Panlungsod po on that matter your honor. It's just that po yung kung sakali po na isa-isahin po natin yung pag require ng authority po from the honorable Sangguniang Panlungsod, baka po kasi may hinhabol po tayong period to file the cases, ang period po kasi natin, kung walang fraud, five years ang collection, hanggang doon lang sa five years na period na yun. Kung may evidences ng fraud tayo, ten year period, mas malaki. Pero mayroon po kasing mga hinahabol po tayo na, kumbaga pag naumpisahan natin ito, sunod-sunod na po kasi ito. Pero kung maghihintay po tayo every time ng kada isang case, isang SP reso, baka magkaroon ng mabawasan yung period na makokolekta natin. Yun lang po, for your consideration niyo lang po, your honor."

COUN. REYNALDO PALABRICA "Sige-sige."

COUN. ADRIELITO GAWARAN "Okay. Total may time frame, mayroon kayong gustong ganun, can you name one or two big fish, na hind nagbabayad, para mapadalhan natin, kahit one or two big fish na hindi nagbabayad sa ating properties."

ATTY. NATHANIEL DE LEON "Yes, your honor. Your honor, if we can ask the Office of the City Treasurer to name the persons who have unpaid real property taxes, if there is."

ATTY. NATHANIEL DE LEON "Opo your honor."

COUN. REYNALDO PALABRICA "Tsaka yung blanket authority is risky on the part of the Sangguniang Panlungsod yan."

ATTY. NATHANIEL DE LEON "We understand, your honor."

COUN. REYNALDO PALABRICA "Ang puwedeng remedyuhan natin, ang gagawin, bibigay namin yung blanket authority, why not? But before the filing of the case, the City Council should be informed, kung sino yung kakasuhan."

ATTY. NATHANIEL DE LEON "If I may suggest your honor, if we can do it by batches, para po ano."

COUN. REYNALDO PALABRICA "Puwede. Kaya nga, by batches or by individual names submitted dito, okay lang yun. But before the actual filing of the case in the court, inform muna ang Sangguniang Panlungsod."

ATTY. NATHANIEL DE LEON "Yes, your honor, we will, your honor."

COUN. REYNALDO PALABRICA "Okay lang na ba sayo yun idol, yun? Sir Gawaran, okay sayo yun?"

COUN. ADRIELITO GAWARAN "Kung wala naman problema sa technicalities and legalities bigyan natin sila ng notices, na Ito baka nakakalimot na ganto."

COUN. REYNALDO PALABRICA "Kasama yun sa due process, may mga demand letter yan, notices yan before filing of the case. Ang pinag-uusapan idol yung concern kanina na kailangan alam ng Sanggunian kung sino ang kakasuhan. Kaya nagpapa ano, kagaya nga ng sabi mo, name two big fishes. Sinong puwede mong filean ng kaso. Ngayon, ang suggestion ko lang, base doon sa concern nila, na ibigay na yung resolution na ito, bago mag file ng kaso, ng actual filing sa korte, ay inform ang Sangguniang Panlungsod kung sino yung fifilan ng kaso. Okay ba sayo yun?"

ATTY. NATHANIEL DE LEON "Yes, your honor. We will submit your honor."

COUN. REYNALDO PALABRICA "Yun, agree na tayo? Ang sabi dito blanket authority nga ito talaga.
