Subject: A resolution approving the CDRRMC Resolution No. 08 Series of 2024 entitled "A resolution requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Sitio Wawa, Barangay Zapote 3 which sustained massive property damages when a fire broke out in the early morning of 07 August 2024.

(Date referred: August 13, 2024)

The above-mentioned proposed resolution underwent its first reading on August 13, 2024 during the 103<sup>rd</sup> Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Presiding Officer, City Vice-Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

#### FINDINGS:

A fire broke out in a residential unit at Sitio Wawa Longos in Barangay Zapote 3 in the early morning of 07 August 2024, that rapidly spread to adjacent residential units which were mostly made from light materials thereby affecting around 600 families whose houses were destroyed.

The affected families were relocated and stayed at various covered courts which served as the evacuation centers.

There was a need to extend immediate assistance to the fire victims like hot meals, clothings and dry good and financial assistance for their temporary shelters.



Morales, Ground Commander, it was then raised to Second Alarm at 0121H by F/SInsp. Precious V. Petalio, Ground Commander. It was declared Fire Under Control at 0250H and Fire Out at 0355H by F/SInsp. Precious V. Petalio, Ground Commander. The immediate

response from our local BFP and Fire Volunteers, ensured the containment of the incident. There were standby EMS personnel on scene to ensure the safety of the responders and the community. Initial information showed that was more or less six hundred (600) residential units affected occupied by more or less six hundred (600) families. There was one (1) casualty involved in the incident
