#### FINDINGS:

In compliance with Memorandum Circular No. 2022-105 dated August 25, 2022 issued by the Department of the Interior and Local Government Unit (DILG) entitled: "The revised Policy Guidelines on Motor Vehicles Purchase/Acquisition, Use and Rental by the Local Government Units", the Office of the City Vice Mayor requested the purchase of one (1) 16-seater van and three (3) motorcycles to be used by the said office.

The Office of the City Accountant and Internal Audit Service and the Office of the City Treasurer certified that there are enough funds for the purchase of the latter.

The purchase of the said vehicle units shall enhance the ability of the city government to deliver basic services to the people of Bacoor.
