Subject: *A resolution authorizing the City Mayor, Hon. Strike B. (PCR-654-2024: Date referred: August 13, 2024)

The above-mentioned proposed resolution underwent its first reading on August 13, 2024 during the 103rd Regular Session of the Sangguniang Panlungsod. The said proposed resolution was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances,

The Committee on Rules and Privileges, Laws and Ordinances sent out invitations to the resource persons and conducted a committee hearing on August 22, 2024, 10 a.m. at the Session Hall of the Sangguniang Panlungsod.

FINDINGS:

A letter dated August 13, 2024 from the Office of the City Mayor was received by the Sangguniang Panlungsod, requesting for appropriate action for the proposal of the Department of Information and Communications Technology (DICT) Region-IV A for the establishment of Digital Transformation Center in the City of Bacoor.

The proposal aims to train Filipinos with high-caliber information and communication technologies skills and resources. The said center shall be used as an office, co-working space and training facility of the DICT in and for the benefit of the people of Bacoor.

9. Mr. Lodgene Asuncion, E-Governance Department Officer said that the Memorandum of Agreement will be sent to the Sangguniang Panlungsod for further review once it is received by their office.
10. The Presiding Officer asked the representatives of DICT the benefits the city will gain once the Memorandum of Agreement is approved.
11. Mr. Tan explains to the Honorable Committee that the proposal aims to train Bacooreños with high-caliber information and communication technologies skills





- and resources. The center will also be used as an office, co-working space and training facility of the DICT for the benefit of the people of Bacoor.
12. The Presiding Officer asked the members of the Honorable Committee for further clarifications, opinions and suggestions.
 13. There, being no matters to be discussed, City Councilor Hon. Alejandro Gutierrez moved for the adjournment of the hearing, duly seconded by all the members of the Honorable Committee present.
