Subject: LETTER FROM MS. MARITES P. OTALIA, PRESIDENT OF MERALCO BACOOR VILLAGE HOMEOWNERS' ASSOCIATION, INC. REQUESTING ASSISTANCE ON OFFICIALLY DECLARING MARIA SALUD VILLAGE PHASE 1 AND 2 AS AN "ABANDONED SUBDIVISION". (PCR 658-2024 dated 19 August 2024)

The above-stated matter was discussed during the 105th Regular Session held on 27 August 2024. It was initially referred to the Committee on Housing, Land Utilization, and Urban Development, chaired by Hon. Alde Joselito F. Pagulayan during the 104th Regular Session on 19 August 2024.

FINDINGS:

On 14 August 2024, the Office of the City Mayor endorsed to the Sangguniang Panlungsod a letter dated 06 August 2024 from Ms. Marites P. Otalia, President of the Meralco Bacoor Village Homeowners' Association, Inc. (MEBAVIHAI).

The letter requested assistance in declaring Maria Salud Village Phase I and 2 as an "abandoned subdivision" pursuant to issues raised by the homeowners.

However, in accordance with Section 34.1(e) of Republic Act (R.A.) No. 11201, also known as the "DHSUD Act of 2018," the authority to declare a subdivision as abandoned lies solely with the Department of Human Settlements and Urban Development (DHSUD).

RECOMMENDATION:

After due deliberation, the Committee recommends the **ARCHIVING** of the matter, citing the lack of jurisdiction by the local government to make such a declaration.

Additionally, the Committee recommends that the matter be referred to the Office of the City Legal Services (OCLS) and other concerned City Government Departments to provide appropriate assistance and guidance to Ms. Otalia (MEBAVIHAI).


