Subject: *A RESOLUTION CONCURRING IN THE ESTABLISHMENT OF END-OF-TRIP CYCLING FACILITIES IN SCHOOLS IN THE CITY OF BACOR, CAVITE TROUGH THE ACTIVE TRANSPORT PROJECT OF THE DEPARTMENT OF TRANSPORTATION. (PCR 660-2024 dated 19 August 2024)*

The above-stated proposed resolution was discussed during the 104th Regular Session on 19 August 2024. The Committee on Education, Science, and Technology, chaired by Hon. Alde Joselito F. Pagulayan respectfully reports the following:

FINDINGS:

On 10 July 2024, the Department of Transportation (DOTr) formally requested the Sangguniang Panlungsod of Bacoor City to adopt a resolution concurring in the establishment of End-of-Trip Cycling Facilities (EOTCF) in selected schools within the City as part of DOTr's Active Transport Project.

The request was made in coordination with the Department of Education (DepEd) Region IV-A, which identified fourteen (14) schools under the City Schools Division of Bacoor (CSDO Bacoor) as valid sites for the installation of the EOTCFs.

RECOMMENDATION:

Upon due evaluation, the Committee recommends the **APPROVAL** of the proposed resolution, as stated in the subject title. This is expected to promote sustainable mobility, support healthier lifestyles, and provide safer and more accessible transport options for students and the general public in Bacoor City.
