Subject: *A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH THE CAVITE STATE UNIVERSITY (CavSU) REGARDING THE CLINICAL AFFILIATION OF CavSU MIDWIFERY AND NURSING STUDENTS TO BE ASSIGNED TO BARANGAY HEALTH CENTERS AND TO THE CITY OF BACOR BIRTHING HOME. (PCR 669-2024 dated 09 September 2024)*

Acting on the above-stated proposed resolution, the matter was discussed during the 107<sup>th</sup> Regular Session held on 09 September 2024. The Committee Chair on Education, Science, and Technology, Hon. Alde Joselito F. Pagulayan reports the following.

**FINDINGS:**

On 21 August 2024, the Office of the City Mayor formally requested the Sangguniang Panlungsod to pass the proposed resolution. The request was in response to a letter dated 15 August 2024 from the Department of Midwifery, College of Nursing of Cavite State University (CavSU), which expressed interest in facilitating the clinical exposure of its midwifery and nursing students.

The proposed collaboration involves assigning CavSU students to various Barangay Health Centers and to the City of Bacoor Birthing Home to provide them with practical hands-on experience essential to their academic training and professional development.

The terms of affiliation and training shall be governed by Provincial Resolution No. 157, Series of 2008, which aims to preserve and promote good relations between all parties involved.

**RECOMMENDATION:**

Upon due evaluation, the Committee recommends the **APPROVAL** of the proposed resolution, emphasizing the importance of providing clinical experience to CavSU midwifery and nursing students. Such exposure is crucial in enhancing their learning and preparing them for professional practice. Additionally, their involvement will contribute significantly to the delivery of healthcare services in City of Bacoor.

The Presiding Officer, Hon. Rowena Bautista-Mendiola presided over the 132<sup>nd</sup> Regular Session of the 5<sup>th</sup> Sangguniang Panlungsod on 17 March 2025.

Hon. Alde Joselito F. Pagulayan moved for the suspension of the Internal Rules to expedite the approval of the proposed measure. The motion was duly approved by the City Council through a show of hands.
