

Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A DEED OF DONATION ACCEPTANCE ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE BACOOR SEAFRONT DEVELOPMENT CORPORATION INVOLVING THE DONATION OF A PARCEL OF LAND LOCATED AT BARANGAY MOLINO II, BACOOR CITY, CAVITE. (PCR 671-2024 dated 09 September 2024)

The proposed resolution was referred to the committee during the 107th Regular Sessian on 09 September 2024. This resolution will authorize the City Mayor to sign a Deed of Donation Acceptance (DODA) with Bacoor Seafront Development Corporation (BSDC). Hon, Alde Joselito F. Pagulayan, Chairperson of the Committee on Housing Land Utilization Development, reports the following:

BSDC is a domestic corporation under the laws of the Republic of the Philippines, with its principal office located at 1051 Northbay Blvd., Navotas City, and is represented in this matter by its authorized representative, Mr. Floyd P. Tiu Laurel.

The City Government of Bacoor, a local government unit (LGU) of the Republic of the Philippines, has its seat of government at Bacoor Government Center, Bacoor Boulevard, Bayanan, City of Bacoor, Cavite. The city is represented herein by its Local Chief Executive, Hon. Strike B. Revilla.

BSDC is a special-purpose corporation created by Frabelle Fishing Corporation and other entities for the 90-hectare Bacoor Reclamation and Development Project and the 230-hectare Bacoor Reclamation and Development Project.

BSDC is the owner of a Thirteen Thousand Two Hundred Forty-Four (13,244)-squaremeter parcel of land covered by Transfer Certificate of Title (TCT) No. 057-2022017588 located in Barangay Molino II of Bacoor City, Cavite.

BSDC has offered to donate the property to the City Government of Bacoor for exclusive use in the development of 1, socialized housing units 2, school buildings, and 3.

support facilities for the relocation of Bacoor Informal Settlers affected by the reclamation projects.

This donation complies with the Mandamus issued by the Supreme Court of the Philippines in its decision dated 18 December 2008 in the case of Metropolitan Manila Development Authority (MMDA), et al. V. Concerned Residents of Manila Bay, et al. [G.R. Nos 171947-481.

Additionally, City Ordinance No. CO 198-2022 Series of 2022 "AN ORDINANCE AUTHORIZING THE CITY ASSESSOR AND CITY TREASURER TO EXEMPT FROM REAL PROPERTY TAX AND OTHER TAXES AND FEES A PORTION OF THE PROPERTY OF BACOOR SEAFRONT DEVELOPMENT CORPORATION DEDICATED FOR GEVERNMENT USE FOR PHASE 2 AND 3 OF CIUDAD KAUNLARAN IN-CITY SOCIALIZED HOUSING PROJECT", provides tax exemptions for BSDC on land portions dedicated for government use.

#### FINDINGS:

During the committee hearing on 20 September 2024, the following observations were noted:

- The committee reviewed tax exemption concerns under City Ordinance (CO) No. 198-2022. While BSDC is granted tax exemptions, the Office of the City Finance Department needs to verify and rectify any outstanding taxes reflected in their records.
- · BSDC holds the title to the donated property, but legal verification is pending review by the Office of the City Legal Services.
- · The donation supports the city's relocation and urban development initiatives by facilitating the provision of essential infrastructure, including housing, schools, and commercial spaces.

#### RECOMMENDATION:

Upon thorough evaluation, the committee recommends the APPROVAL of the Deed of Donation Acceptance with Bacoor Seafront Development Corp. The donation aligns with the city's urban development priorities and will be exclusively utilized for the relocation and housing needs of Bacoor's Informal Settlers.

Hon. Pagulayan recognized the presence of the committee members, along with representatives from various offices and resource persons.

Atty. Ian Baliwag was recognized, he presented the draft doda, stating that BSDC is the registered owner of a 13,244 sqm parcel of land under Transfer Certificate of Title No. 057-2022017588. According to him, the donation aims to fulfill the donor's obligation to support the Local Government Unit (LGU's) relocation program for informal Settler Families (ISFs).

The Housing Department Representatives were recognized, they confirmed that they were aware of the donation and clarified that the land would be used for Phase 3 of the project, which includes:

- Mixed-use development e.g. health Center, commercial areas, school, and housing units,
- 2. Planned Unit Development, and
- 3. Master plan preparation.

Hon. Pagulayan requested verification of the land titles and legal compliance. He instructed to the representatives of BSDC to submit the title numbers to Atty, Sumira of the City Legal Office for review.

The committee also addressed the issue of tax exemptions, referencing City Ordinance (CO) No. 198-2022, which grants tax exemptions to BSDC. However, it was noted that the Treasury Department's records still reflect unpaid taxes, prompting the need for record rectification.

Atty. Ian Baliwag requested that the Deed of Donation (DOD) include a statement affirming the donor's full compliance with their obligation to the City Government, Hon. Pagulayan clarified that while the committee supports the resolution, the final decision regarding compliance lies with the executive department.

The committee agreed to approve the resolution, subject to the following conditions:

- Verification of land titles by the City Legal Office.
- Finalization of the master plan for the donated land.
- Resolution of tax exemption issues in coordination with the Assessor's Office and Treasury Department.

With no further questions or objections, the hearing was adjourned by Hon. Gawaran

#### DEED OF DONATION AND ACCEPTANCE

#### KNOW ALL MEN BY THESE PRESENTS:

This Deed of Donation and Acceptance ("Deed") is made and executed by:

BACOOR SEAFRONT DEVELOPMENT CORPORATION, a domestic corporation under the laws of the Republic of the Philippines, with principal office address at 1051 Northbay Blvd., Navotas City, herein represented herein by its authorized representative, MR. FLOYD P. TIU LAUREL, hereinafter referred to as the "DONOR";

city Government of the Republic of the Philippines created in accordance with the law with the seat of government at Bacoor Government Center Bacoor Boulevard, Bayanan, City of Bacoor, Cavite, represented herein by its local shiet executive, HON. STRIKE B. REVILLA, duly authorized by its Sangguniang Panlungsod under City Resolution No., hereinafter referred to as the "DONEE".

The DONOR and the DONEE shall hereinafter collectively be referred to as the "Parties" and Individually as a "Party".

#### -ANTECEDENTS:

WHEREAS the DONOR is a special purpose vehicle created by Frabelle Fishing Corporation, among others for the 90-hectare Bacoor Reclamation and Development Project and 230-hectare Bacoor Reclamation and Development Project (the "Projects");

WHEREAS The DONOR is the absolute and registered owner of a parcel of land covered by Transfer Certificate of Title ("TCT") No. 057-2022017588 with an area of approximately Thirteen Thousand Two Hundred Forty-Four (13,244) square meters, more or less, located in Barangay Molino II of Bacoor City, Province of Cavite ("DONATED PROPERTY"). A copy of the TCT No. 057-2022017588 is attached hereto as Annex "A";

WHEREAS, the DONOR has offered to donate the Property to the DONEE for it to be exclusively used for the development of socialized housing units, school buildings, and support facilities for Baccor informal settlers affected by the Projects in compliance with the Mandamus issued by the Supreme Court of the Philippines on its Decision dated 18 December 2008 in the case of Metropolitan Manila Development Authority, et al. V. Concerned Residents of Manila Bay, et al. [G.R. Nos 171947-48];

WHEREAS, the DONEE, in cognizant of liberality and beneficence of the DONOR and in full appreciation thereof, has accepted the donation of the Donated Property from the DONOR;

WHEREAS, the Sangguniang Panlungsod of Bacoor, Cavite approved the terms and conditions contained herein and authorized the Honorable Mayor Strike B. Revilla to accept and execute this Deed;

NOW THEREFORE, for and in consideration of the foregoing premises, and as an act of generosity and pure liberty, the DONOR hereby voluntarily and freely gives, transfers, and conveys by way of Donation unto the DONEE all the rights, title and interest which the DONOR has over the DONATED PROPERTY, subject to the following conditions:

- The DONATED PROPERTY shall consist of THIRTEEN THOUSAND TWO HUNDRED FORTY-FOUR (13,244) SQUARE METERS ONLY, which shall be physically separated by adequate structure, fence, or devices on the account of the DONEE.
- 2. The DONATED PROPERTY shall for all eternity be used ONLY and EXCLUSIVELY for the purpose of developing socialized housing units, school buildings, and support facilities for Baccor informal settlers affected by the Projects in compliance with the Mandamus issued by the Supreme Court of the Philippines on its Decision dated 18 December 2008 of Metropolitan Manile Development Authority, et al. vs Concerned Residents of Manile Bay, et al. [G.R. Nes. 171947-48].
- The DONEE shall not sell, dispose, mortgage, encumber, transfer, assign, tolerate the use by a third party, or use as collateral for any economic venture the DONATED PROPERTY or any portion thereof.
- In consideration of the donation, the DONEE will allocate funds and build access roads and bridges on the DONATED PROPERTY at no cost to the DONOR
- The DONEE shall provide all public facilities and amenities, as needed, such but not limited to police stations, barangay outposts, school buildings, health centers, public markets, and the like.
- This Deed, at the sole option of the DONOR, may be canceled or revoked by the DONOR for the following causes:
  - (a) Failure by the DONEE to use the DONATED PROPERTY as the development site for socialized housing projects and support facilities;
  - (b) Breach of the conditions set forth in this Deed; and
  - (c) Any other act, deed, or circumstance that occurs or is committed which under the law entities the DONOR to cancel or revoke the donation herein made.
- The conditions set forth in this Deed shall be annotated to TCT No. 057-2022017588 upon execution of this Deed.

 The DONOR affirms that the donation is not made with the intent to deceive its creditors and that it has reserved for itself and its legal obligations sufficient funds and properties.
