



Subject: RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA TO SIGN A PETITION FOR THE ISSUANCE OF CERTIFICATION OF EXEMPTION AND AUTHORIZATION FOR THE RELEASE OF PUBLIC FUND FOR THE VARIOUS PROGRAMS, PROJECTS AND ACTIVITIES OF THE CITY GOVERNMENT OF BACOOR DURING THE ELECTION PERIOD FOR THE 2025 NATIONAL AND LOCAL GOVERNMENT ELECTIONS. – PCR 700-2024 dated October 21, 2024

Referred to this Committee on the 113th Regular Session is the above-subject matter for appropriate action and recommendation.

The Commission on Election (COMELEC) in its Resolution No. 11060 promulgated on September 13, 2024 adopted certain provisions of the Omnibus Election Code pertaining to the prohibition against the release of public fund in relation to the upcoming election on May 12, 2025.

For reference and guidance, the provisions on exceptions and the requirement in the filing of request for exemption promulgated by the Commission on Election, Manila, are hereunder quoted, as follows:

"RESOLUTION NO. 11060

RULES AND REGULATIONS ON THE PROHIBITION AGAINST THE RELEASE, DISBURSEMENT, OR EXPENDITURE OF PUBLIC FUNDS FOR SOCIAL SERVICES AND HOUSING-RELATED PROJECTS, AND ISSUANCE OF TREASURY WARRANTS AND SIMILAR DEVICES UNDER SECTIONS 261 (V) AND (W) OF THE OMNIBUS ELECTION CODE IN CONNECTION WITH THE MAY 12, 2025 NATIONAL AND LOCAL ELECTIONS, AND BARMM PARLIAMENTARY ELECTIONS.

RULE III EXCEPTION

XXX

SECTION 6. Release, Disbursement or Expenditure of Funds during Calamities or Disasters. The release, disbursement, expenditure of public funds for relief or other goods to be
distributed to the affected individuals and families in case of calamities or disasters does not
require exemption from the COMELEC.

However, the concerned agency/office/local government unit (LGU) shall immediately submit to the Law Department a report containing the following information:

 a) Type of assistance provided, date and location of the distribution, and the amount of public funds released, disbursed, or expended; and

- b) Certified True Copy of the Executive Order or the Local Sanggunian Resolution declaring a state of calamity in the disaster-stricken area.
- **SECTION 7. MOOE; Excepted.** MOOE are considered normal and routine expenses incurred through day-to-day operations, and are not covered by the prohibition against the release, disbursement, expenditure of public funds.
- **SECTION 8. Salaries of Government Personnel; Excepted.** Payments for salaries of personnel in the government, including benefits mandated by law, are excepted from the prohibition against the release, disbursement, expenditure of public funds, and issuance of treasury warrants and similar devices.
- SECTION 9. Use of Public Funds for Projects not Covered by the Prohibition under Section 261(v) of the OEC. The release, disbursement, expenditure of public funds for projects/programs/activities (PPAs) which are not social service and welfare projects and housing-related projects is allowed subject to the following conditions:
- a) The PPAs sought to be implemented during the period of forty-five (45) days before the conduct of 2025 NLE and BARMM Parliamentary Elections were established prior the said period and duly reported to the Commission on Audit (COA) pursuant to Item 2.1 of its Circular No. 2013-004 dated 30 January 2013;
- b) The public awareness and information dissemination activities pertaining these PPAs must conform to the guidelines provided under the said COA Circular;
- c) In no instance shall the implementation of PPAs be used as an opportunity by any candidate, his or her spouse, family member within the second civil degree of affinity or consanguinity to further their candidacy through their personal appearance in such events, posting, exhibition or distribution of any form of election propaganda, or any material containing their names, logos, initials, mottos, slogan, images and other forms of representation attributable to them;
- d) Support for or endorsement of candidates shall not be made as a condition for the entitlement of the benefits from the PPAs; and
- e) Candidates, their spouses, and members of their family within the second civil degree of affinity or consanguinity are strictly prohibited from participating, directly or indirectly, in the distribution of cash, goods or merchandise for scholarships, assistance for burial, health care, calamity and ither similar programs. A violation of this condition shall subject the candidates or their representatives to liability under Section 261(o) of the OEC.
- **SECTION 10. Excepted Expenditures; No Need to Request for Exemption/Exception** For the excepted expenditures, the concerned agency/office/LGU <u>need not request for the issuance</u> of Certificate of Exception.

SECTION 11. Request for Exemption; Contents. - In order to exempt social welfare and services projects and housing related projects from the prohibition on the release, disbursement or expenditure of public fund, a request for exemption shall be filed providing the following information:

- a) Name of the social welfare and services projects or housing-related projects, as the case may be;
- b) Requesting agency, office, or LGU;
- C) Name, position, and authority of the person filing the request.

For requesting local chief executives, their authorities to request for exemption from their Sanggunian shall be attached to the request.

XXX

- d) Purpose and period of implementation;
- e) Amount to be released, disbursed, or expended; and
- f) Active email address(es) and contact number(s).

For projects of national agencies/department/GOCC/LGUs which will be implemented by its field offices/local units/component LGUs, the requesting entity must provide an additional list identifying the implementing unit(s) and the particular project(s) to be implemented.

SECTION 12. Use of Prescribed Forms. - Requesting parties shall use the prescribed forms provided in this Resolution which is available at the Law Department and also downloadable at www.comelec.gov.ph.

SECTION 13. Supporting Documents; Submission and Duty to Safekeep. - Requesting parties shall submit supporting documents **when required** by the Law Department or COMELEC. x x x

SECTION 14. Request for Exemption; Manner of Filing. - Requests for exemption in **originally signed hard copy** shall be submitted to the Law Department. <u>Any request submitted through email shall not be acted upon.</u>

The date of receipt by the Law Department shall be considered as the date of filing.

SECTION 15. Request for Exemption; Deadline. - The deadline for filing requests for exemption shall be on February 11, 2025.



ELECTIONS. - PCR-700-2024 Dated October 21, 2024.

Honorable Rowena Bautista Mendiola, Presiding Officer called the 113^{TH} Regular Session to order.

Atty. Khalid Atega, Jr., Secretary of the Sangguniang Panlungsod, proceeded with the roll call, the approval of the Journal and Minutes of the 112th Regular Session, and the reading of the referrals to committees of proposed Ordinances, Resolutions, Messages, Communications, Petitions and Memorials.

On motion by Honorable Rogelio M. Nolasco which was unanimously seconded by the majority of the Honorable Members of Sangguniang Panlungsod, the internal rules were suspended.

Upon reading and referral of Agenda Item No. F.1.5 – PCR-700-2024 – "A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A PETITION FOR THE ISSUANCE OF CERTIFICATION OF EXEMPTION AND AUTHORIZATION FOR THE RELEASE OF PUBLIC FUNDS FOR THE VARIOUS PROGRAMS, PROJECTS AND ACTIVITIES OF THE CITY GOVERNMENT OF BACOOR DURING THE ELECTION PERIOD FOR THE 2025 NATIONAL AND LOCAL GOVERNMENT ELECTIONS." Pursuant to Section 16 Republic Act No. 7160 otherwise known as the Local Government Code, (e)very local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.

The Commission on Elections (COMELEC) issued Resolution No. 10999 pertaining to the National and Local Elections (NLE) and BARMM Parliamentary Elections to be held on 12 May 2025 and calendar of activities and periods of certain prohibited acts approved and promulgated on 24 May 2024.

The City Government of Bacoor is petitioning the COMELEC to acknowledge its mandate of delivering basic services under the Republic Act 7160 (otherwise known as the "Local Government Code of 1991") during the Election Ban Period from 28 March 2025 to 11 May 2025 as the mentioned electoral prohibition might delay the disbursement of funds for the completion of various programs, projects and activities of the city government.

PETITION FOR THE ISSUANCE OF A CERTIFICATE OF EXEMPTION AND AUTHORIZATION TO RELEASE, DISBURSE, AND EXPEND PUBLIC FUNDS

COMES NOW, the Petitioner, the City Government of Bacoor, represented by its Local Chief Executive – HON. STRIKE B. REVILLA, through the undersigned counsel and unto the Honorable Commission on Elections, most humbly and respectfully submits the foregoing Petition pursuant to the Omnibus Election Code and hereby states that:

PREFATORY STATEMENT

"Election ban is not designed to paralyze the operations of the government, but to insulate government procurement from political partisan activities, usually, in the form of new projects, which are designed to influence the public during elections."

> Government Procurement Policy Board Technical Support Office Circular No. 01-2019, 09 March 2018

THE PETITIONER

- The Petitioner is a local government unit in the Province of Cavite, created by Republic Act No. 10160 or the Charter of the City of Bacoor, with an official address at New Bacoor City Hall, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Province of Cavite;
- 3. The Petitioner may be served with copies of the Honorable Commission's notices, orders, resolutions, and other processes through its counsel – the Office of the City Legal Service with official office address at Third Floor, New Bacoor City Hall, Bacoor Government Center, Barangay Bayanan, Bacoor City, Province of Cavite.
 - 3.1. The official electronic mail address of the Office of the City Legal Service is closebacoor.gov.ph.

STATEMENT OF THE PETITION

4. It is a declared policy of the State to serve and protect the people, maintain peace and order, protect life, liberty, and property, and promote the general welfare of the people. No less than the 1987 Constitution enshrined these declarations under Sections 4 and 5 of Article II:

"Section 4. The prime duty of the Government is to serve and protect the people. The Government may call upon the people to defend the State and, in the fulfillment thereof, all citizens may be required, under conditions provided by law, to render personal, military, or civil service.

Section 5. The maintenance of peace and order, the protection of life, liberty, and property, and promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy."

- On 24 May 2024, the Honorable Commission on Elections issued COMELEC Resolution No. 10999, which provided that between 28 March 2025 and 11 May 2025, the following are prohibited:
 - 5.1. The appointment or hiring of new employees, creation of new positions, filing of new positions in a government office, agency, or instrumentality, whether national or local, including government-owned or controlled corporations, except upon prior authority of the Commission (Sec. 261 (g) (1), Omnibus Elections Code);
 - 5.2. The promotion or giving of salary increases, remuneration of privileges to any government official or employee, including those in government-owned or controlled corporations (Section 261 (g) (2), Omnibus Elections Code);
 - Release, disbursement, or s of public funds, except those enumerated in (Section 261 (v), Omnibus Elections Code);
 - 5.4. Construction of public works, delivery of materials for public works except for projects or works exempted in Section 261 (v) of the OEC, and issuance of treasury warrants or similar devices. (Section 261 (w), Omnibus Election Code);
- In Mandanas v. Executive Secretary (G.R. No. 199802,3 July 2018) perJ. Bersamin, EN BANC, the Supreme Court has emphasized that fiscal autonomy includes the power to allocate resources with their own priorities. To wit:

"One of the key features of the 1987 Constitution is its push towards decentralization of government and local autonomy. Local autonomy has two facets: the administrative and the fiscal. Fiscal autonomy means that local governments have the power to create their own sources of revenue in addition to their equitable share in the national taxes released by the National Government, as well as the power to allocate their resources in accordance with their own priorities. Such autonomy is as indispensable to the viability of the policy of decentralization as the other." (Emphasis and underscoring supplied)

 Under Section 16 of the Local Government Code, a local government is empowered to ensure the promotion of the general welfare of its constituents. Thus:

> "Section 16. General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things. the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants." (Emphasis and underscoring supplied)

- 8. Under Section 8 of Republic Act No. 10160 or the Bacoor City Charter has empowered the City Government through its City Mayor as local chief executive to exercise those powers expressly granted to him by law and those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for the efficient and effective governance of the City and those essential to the promotion of general welfare;
- 9. The concept of the promotion of general welfare has developed over the years. The Supreme Court, in the case of Roble Arrastre Inc v. Villaflor (G.R. No. 128109, 22 August 2006) per J. Chico-Nazario, First Division, has discussed the same as follows:

"The general welfare clause is the delegation in statutory form of the police power of the State to LGUs. Through this, LGUs may prescribe regulations to protect the lives, health, and property of their constituents and maintain peace and order within their respective territorial jurisdictions. Accordingly, we have upheld enactments providing, for instance, the regulation of gambling, the occupation of rig drivers, the installation and operation of pinhall machines, the maintenance and operation of cockpits, the exhumation and transfer of corpses from public burial grounds, and the operation of hotels, motels, and lodging

houses as valid exercises by local legislatures of the police power under the general welfare clause."

- 10. The following requested projects and disbursements of public funds below that may cover the period as prohibited by the Honorable Commission are essential to the promotion of the general welfare of the people of Bacoor City. Should the implementation and execution of these projects be hampered or delayed, there is an equivalent danger and harm that may afflict those intended beneficiaries;
- Hence, this Petition for the Issuance of the Certificate of Exemption;

The Petition for Exemption is allowed under the Omnibus Election Code for Social Welfare Related Projects.

12. Under Section 261(v)(2) of the Omnibus Elections Code, any other office with similar performing functions with the Ministry of Social Services (now Department of Social Welfare and Development) may, after due notice and hearing, be exempted. To wit:

"The Ministry of Social Services and Development and any other office in other ministries of the government performing functions similar to said ministry, except for salaries of personnel, and for such other routine and normal expenses, and for such other expenses as the Commission may authorize after due notice and hearing. Should a calamity or disaster occur, all releases normally or usually coursed through the said ministries and offices of other ministries shall be turned over to, and administered and disbursed by, the Philippine National Red Cross, subject to the supervision of the Commission on Audit or its representatives, and no candidate or his or her spouse or member of his family within the second civil degree of affinity or consanguinity shall participate, directly or indirectly, in the distribution of any relief or other goods to the victims of the calamity or disaster; and'

13. Furthermore, Section 261 (v)(3) likewise exempts projects related to the functions of the Ministry of Human Settlements (now Department of Human Settlements and Urban Development) or any other office with similar performing functions. To wit: "The Ministry of Human Settlements and any other office in any other ministry of the government performing functions similar to said ministry, except for salaries of personnel and for such other necessary administrative or other expenses as the Commission may authorize after due notice and hearing." (Emphasis and underscoring supplied)

14. It is most humbly submitted that the functions of the Department of Social Welfare and Development and that of the Department of Human Settlements and Urban Development are similar to that of the statutory power of Local Government Units under the Local Government Code and that which is provided for by Republic Act No. 10160 to promote the general welfare of the people and its expanded and evolved concept as duly decided by no less than the Supreme Court;

Exemption of Public Works

15. Meanwhile, the release, disbursement, or expenditure of public funds may be exempted by the Honorable Commission as provided for by the Omnibus Election Code under Section 261 (v) (1) based on the following:

> "a. Maintenance of existing and/or completed public works project: Provided That not more than the average number of laborers or employees already employed therein during the sixmonth period immediately prior to the beginning of the forty-five day period before election day shall be permitted to work during such time: Provided, further, That no additional laborers shall be employed for maintenance work within the said period of forty-five days;

> b. Work undertaken by contract through public bidding beld, or by negotiated contract awarded, before the forty-five day period before the election: Provided That work for the purpose of this section undertaken under the so-called "takay" or "paquiao" system shall not be considered as work by contract;

> c. Payment for the usual cost of preparation for working drawings, specifications, bills of materials, estimates, and other procedures preparatory to actual construction, including the purchase of materials and equipment, and all incidental expenses for wages of watchmen and other laborers employed for

such work in the central office and field storehouses before the beginning of such period: Provided, That the number of such laborers shall not be increased over the number hired when the project or projects were commenced; and

d. Emergency work necessitated by the occurrence of a public calamity, but such work shall be limited to the restoration of the damaged facility.

No payment shall be made within five days before the date of election to laborers who have rendered services in projects or works except those falling under subparagraphs (a), (b), (c), and (d) of this paragraph.

This prohibition shall not apply to ongoing public works projects commenced before the campaign period or similar projects under foreign agreements. For purposes of this provision, it shall be the duty of the government officials or agencies concerned to report to the Commission the list of all such projects being undertaken by them."

SOCIAL WELFARE-RELATED PROGRAMS, PROJECTS, AND ACTIVITIES OF THE CITY GOVERNMENT OF BACOOR

16. The social welfare-related programs, projects, and activities of the City Government of Bacoor that have been determined by the same for the promotion of the general welfare of its constituents and are submitted to the Honorable Commission for the issuance of the necessary exemption amounts to ONE BILLION ONE HUNDRED SEVENTY-EIGHT MILLION NINE HUNDRED FIFTY-FIVE THOUSAND SIX HUNDRED SEVENTY PESOS (PHP 1,178,955,670.00). The complete list is attached to this Petition as Annex "A". Some of the plans, programs, and activities amounting to PHP 1,178,955,670.00 will be conducted as early as January 2025. However, the City Government of Bacoor seeks an exemption since the implementation period may be extended and fall within the election ban period. Further, the disbursement may also be within the election ban period. As for other projects, the actual preparation and implementation will fall within the election ban period, hence the request for the exemption.

PUBLIC WORKS AND CONSTRUCTION-RELATED PROGRAMS, PROJECTS, AND ACTIVITIES OF THE CITY GOVERNMENT OF BACOOR Government of Bacoor and are submitted to the Honorable Commission for the issuance of the necessary exemption amounts to SEVEN HUNDRED SIXTY-FOUR MILLION NINE HUNDRED EIGHTY-THREE THOUSAND THREE HUNDRED SIXTY PESOS AND FORTY-TWO CENTAVOS (Php 764, 983,360.42). The complete list is attached to this Petition as Annex "B". Some of the construction projects amounting to Php 764, 983,360.42 will be initiated as early as January 2025. However, the City Government of Bacoor seeks an exemption since the construction period may be extended and fall within the election ban period. Further, the disbursement may also be within the election ban period. As for other construction projects, the actual preparation and implementation will fall within the election ban period, hence the request for the exemption.

CONCLUSION

- 18. The abovementioned list covers both infrastructure and non-infrastructure projects of the City Government of Bacoor. These are integral parts of the City Government's promotion of the general welfare of the people, which includes not only basic services but also those projects that directly benefit the lives of the Bacooreno populace;
- 19. The project spans the services provided for by social work, environmental and natural resources protection, public safety and traffic management, public health housing and urban development, food security and agriculture, population and gender development, senior citizens affairs, civil registry, youth and sports development, livelihood, land development, economic and business development, promotion of culture, and the over-all continued work and service by the City Government of Bacoor including but not limited to general services, e-governance, and planning services;
- 20. Indubitably to abruptly halt the implementation of the abovementioned projects for the period of two months will unnecessarily result in the suspension of these much-needed services;
- 21. To the recipient and intended beneficiaries such as informal settler families, the sick and the differently-abled, and those displaced by calamities, the students, the elderly the two-month prohibition on public spending means the world because it will likewise delay the financial assistance to their families which could directly translate to loss;
- 22. Moreover, for the establishment, construction, and repair in various locations of the city, the deferment of these projects for the period of two months would necessarily mean a delay. Such delay would worsen the traffic conditions in the City and the flooding it is experiencing during heavy rainfall;

23. The City Government of Bacoor remains committed to the public in ensuring that services and projects for their general welfare will be undertaken with the kind authority of this Honorable Commission.

PRAYER

WHEREFORE, premises considered, the City Government of Bacoor most humbly and most respectfully prays for the Honorable Commission on Elections to favorably consider this Petition and, accordingly, issue a Certificate of Exemption for all releases, disbursements, and expenditures by the City Government of Bacoor, and its departments, offices, and units, for its above-listed mandated, statutory, and specialized programs, projects, and activities, including routine and normal expenses from the prohibition under Section 261 (v) of the Omnibus Election Code.

Other reliefs, just and equitable under the circumstances, are likewise prayed for.
