Subject: REQUEST FOR A CITY RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER INTO A SIGN MEMORANDUM OF AGREEMENT WITH VARIOUS PRIVATE EDUCATIONAL INSTITUTIONS WITHIN THE CITY OF BACOOR REGARDING THE S.T.R.I.K.E. SA KARUNUNGAN SCHOLARSHIP PROJECT. (PCR 702-2024 dated 21 October 2024)

Acting on the above-stated proposed resolution, the matter was discussed during the 113th Regular Session held on 21 October 2024. The Committee Chair on Education. Science, and Technology, Hon. Alde Joselito F. Pagulayan, reports the following:

Section 33 of Republic Act No. 7160 (the "Local Government Code of 1991") provides that the Local Chief Executive of a local government unit, such as the City of Bacoor, possesses the authority to enter into contracts and agreements, subject to prior authorization from the Sangguniana Panlungsod.

FINDINGS:

The Committee finds that the City Government of Bacoor and the private educational institutions concerned recognize the importance of establishing partnerships in promoting accessible and quality education. The S.T.R.I.K.E. sa Karunungan Scholarship Project seeks to extend financial assistance and academic opportunities to deserving Bacooreños students who meet the eligibility requirements. Through this partnership, the City Government will be able to formalize its cooperation with local schools to institutionalize the implementation of the scholarship program.

RECOMMENDATION:

Upon due evaluation, the Committee recommends the APPROVAL of the proposed resolution, as stated in the subject. This will authorize the City Mayor to enter into and sign Memoranda of Agreement with partner private educational institutions, thereby facilitating the implementation and expansion of the S.T.R.I.K.E. sa Karunungan Scholarship Project in the City of Bacoor.
