Subject: A resolution adopting Sangguniang Panlalawigan Resolution 3411-2024 declaring the existence of a state of calamity over the entire Province of Cavite due to the onslaught of Typhoon Kristine and authorizing the 47 Barangays of the City of Bacoor, Cavite to utilize the quick response funds of their respective barangay disaster.

(Date referred: Nov. 11, 2024)

The above-mentioned proposed ordinance underwent its first reading on November 11, 2024 during the 116th Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Actina Presiding Officer, City Councilor and President Pro-Tempore Hon. Reynaldo C. Palabrica to the Committee on Rules and Privileges, Laws and Ordinances.

FINDINGS:

Provincial Resolution No. 3411-2024 was approved on October 24, 2024 due to the wide spread adverse impact of Typhoon Kristine on the whole Province of Different barangays experience knee-high floods brought by the onslaught of the said weather disturbance which affected a great number of families within the province.

The declaration of state of calamity enables the local government as well as the barangays to access emergency funds swiftly and implement relief operations to aid the displaced constituents residing in the 47 barangays in the City of Bacoor.

Adopting the Provincial Resolution No. 3411-2024, to deliver the needs for food, emergency supplies, and other projects, the 30% Quick Response Fund of the Barangay Disaster Risk Reduction and Management Fund may be utilized to effectively respond to the needs of the affected families.

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Athena Bryana D. Tolentino, Provincial Governor,

WHEREAS, Section 16 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides in part that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of general welfare;

WHEREAS, Section 468 (a) (1) of the same Act likewise provides in part that the Sangguniang Panlalawigan, as the legislative body of the province, shall approve ordinances and pass resolutions necessary for an efficient and effective provincial government

WHEREAS, due to Severe Tropical Storm "Kristine", the Province of Cavite was declared by the Philippine Atmospheric. Geophysical and Astronomical Services Administration under Tropical Cyclone Wind Signal No. 2 and classes in all levels and work in government offices in Luzon are suspended by Malacañang since 23 October 2024;

WHEREAS, the said storm has brought continuous intense rains and strong winds causing severe flooding and widespread damage in the Province of Cavite,

WHEREAS, Section 21 of the Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, provides that the Quick Response Fund shall be allocated for relief and recovery programs in order that the situation and living conditions of people in communities or areas stricken by disasters, calamities, epidemics or complex emergencies, may be normalized as quickly as possible:

WHEREAS, due to the disastrous aftermath caused by Severe Tropical Storm "Kristine", it is deemed appropriate that the Province of Cavite be placed under a state of calamity and necessary funds shall be utilized to provide effective response in addressing the same;

NOW, THEREFORE, on motion of Hon. Belamide and Hon. Bautista, duly seconded by Hon. Sison and unanimously approved by the Sangguniang Panlalawigan Members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED, that the Province of Cavite be declared under a state of calamity due to Severe Tropical Storm "Kristine";




