Subject: RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN A DEED OF DONATION AND ACCEPTANCE WITH THE DEPARTMENT OF INFORMATION AND COMMUNICATIONS TECHNOLOGY (DICT) ON BEHALF OF THE CITY GOVERNMENT OF BACOOR. (PCR 719-2024 dated 25 November 2024)

Acting on the above-stated proposed resolution, the matter was discussed during the 118th Regular Session held on 25 November 2024. The Committee Chair on Education, Science, and Technology, Hon. Alde Joselito F. Pagulayan reports the following.

FINDINGS:

The Office of the City Mayor formally requested the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor, on behalf of the City Government of Baccor to sign a Deed of Donation with the Department of Information and Communications Technology (DICT) relative to the donation of laptops to the city government.

The DICT rebranded the Digital Learners Project (DLP) into the Courses for Literacy in Internet and Computer Knowledge Project (Project CLICK) and enhanced the implementation strategy by prioritizing the delivery of digital literacy and cyber hygiene trainings to its institutional partners.

the City Government of Bacoor has been recognized as one of the DICT's institutional partners, and the DICT has committed to provide to participants of the trainings and courses conducted under Project CLICK.

RECOMMENDATION:

Upon due deliberation, the Committee recommends the **APPOVAL** of the proposed resolution, as stated in the subject. This measure will facilitate the execution of the Deed of Donation and Acceptance, thereby it supports the digital education initiatives and enhancing the City Government's capacity to deliver digital literacy training.
