Hon. Pagulayan reiterated that while the city cannot refuse donations, all donations must comply with the Department of Human Settlements and Urban Development (DHSUD) requirements. He emphasized that developers remain responsible for Real Property Tax (RPT), maintenance of roads, and upkeep of common areas until the donation is formally accepted.

Engr. Quinatadcan identified certain lots lacking tax declarations, which need to be addressed before finalization. He further instructed the developers to facilitate the turnover of subdivision management to Homeowners Associations (HOAs).

Additional concerns were discussed, including missing documents, such as board resolutions, tax declarations, and updated RPT payments. It was agreed that an updated list of properties and their tax status would be submitted to the City Treasurer's Office for verification.

After addressing all concerns and required documentary updates, Hon. Gawaran adjourned the hearing.




